Foreword

Amid a barrage of shocks during the past four years, the global economy has proved to be surprisingly resilient. Major economies are emerging mostly unscathed after the fastest rise in interest rates in 40 years—without the usual scars of steep unemployment rates or financial crashes. Global inflation is being tamed without tipping the world into a recession. It is rare for countries to bring inflation rates down without triggering a downturn, but this time a "soft landing" seems increasingly possible.

Yet beyond the next two years, the outlook is dark. The end of 2024 will mark the halfway point of what was expected to be a transformative decade for development—when extreme poverty was to be extinguished, when major communicable diseases were to be eradicated, and when greenhouse-gas emissions were to be cut nearly in half. What looms instead is a wretched milestone: the weakest global growth performance of any half-decade since the 1990s, with people in one out of every four developing economies poorer than they were before the pandemic.

The forecasts in *Global Economic Prospects* imply that most economies—advanced as well as developing—are set to grow more slowly in 2024 and 2025 than they did in the decade before COVID-19. Global growth is expected to slow for a third year in a row—to 2.4 percent—before ticking up to 2.7 percent in 2025. Those rates, however, would still be far below the 3.1 percent average of the 2010s. Per-capita investment growth in 2023 and 2024 is expected to average just 3.7 percent—barely half the average of the previous two decades. Without corrective action, global growth will remain well below potential for the remainder of the 2020s.

But while the forecasts in this report are dismal, its policy analysis provides hope.

The report includes the first systematic assessment of what it takes to generate the most desirable kind of investment boom—one that comes with an increase in per-capita income growth, a step-up in productivity, and a reduction in poverty. Since the 1950s, countries across the world have managed to generate nearly 200 windfallproducing investment booms—episodes in which per-capita investment growth accelerated to 4 percent or more and stayed there for more than six years. The secret sauce for sparking such episodes was a comprehensive policy package: consolidation of government finances, expansion of trade and financial flows, stronger fiscal and financial institutions, and a better investment climate for private enterprise.

If each developing economy that engineered such an investment boom in the 2000s and 2010s were to repeat the feat in the 2020s, prospects for developing economies would move a third of the way closer to their full economic potential. If all developing economies also repeated their best 10year performance to improve health, education, and labor force participation, they would close most of the remaining gap. That is, the potential growth in developing economies in the 2020s would be similar to what it was during the 2010s.

An additional avenue is open to the two-thirds of developing economies that rely on commodity exports. They can do better simply by applying the Hippocratic principle to fiscal policy: first, do no harm. These economies are prone to debilitating boom-and-bust cycles because commodity prices can rise or fall suddenly. Their fiscal policies tend to make matters worse. Fiscal procyclicality is 30 percent stronger in commodityexporting developing economies than it is in other developing economies. Fiscal spending among commodity exporters also tends to be 40 percent more volatile than in other developing economies.

The result is a chronic drag on their growth prospects. The drag can be reduced by putting in place a fiscal framework to discipline government spending, adopting flexible exchange-rate systems, and avoiding restrictions on international movements of capital, among other things. If instituted as a package, these policy measures could help commodity exporters in developing economies increase per capita GDP growth by 1 percentage point every four or five years.

The 2020s have so far been a period of broken promises. Governments across the world have fallen short of the "unprecedented" goals they promised to meet by 2030: "to end poverty and hunger everywhere; to combat inequalities within and among countries;...and to ensure the lasting protection of the planet and its natural resources." But 2030 is still more than a half-decade away. That is long enough for emerging markets and developing economies to regain some of the lost ground—if their governments act now.

Executive Summary

Global growth is set to slow further this year, amid the lagged and ongoing effects of tight monetary policy, restrictive financial conditions, and feeble global trade and investment. Downside risks to the outlook include an escalation of the recent conflict in the Middle East and associated commodity market disruptions, financial stress amid elevated debt and high borrowing costs, persistent inflation, weaker-than-expected activity in China, trade fragmentation, and climate-related disasters. Against this backdrop, policy makers around the world face enormous challenges. Even though investment in emerging market and developing economies (EMDEs) is likely to remain subdued, lessons learned from episodes of investment growth acceleration over the past seven decades highlight the importance of macroeconomic and structural policy actions and their interaction with well-functioning institutions in boosting investment and thus long-term growth prospects. Commodity-exporting EMDEs face a unique set of challenges amid fiscal policy procyclicality and volatility. This underscores the need for a properly designed fiscal framework that, combined with a strong institutional environment, can help build buffers during commodity price booms that can be drawn upon during subsequent slumps in prices. At the global level, cooperation needs to be strengthened to provide debt relief, facilitate trade integration, tackle climate change, and alleviate food insecurity.

Global outlook. Global growth is expected to slow to 2.4 percent in 2024-the third consecutive year of deceleration-reflecting the lagged and ongoing effects of tight monetary policies to rein in decades-high inflation, restrictive credit conditions, and anemic global trade and investment. Near-term prospects are diverging, with subdued growth in major economies alongside improving conditions in emerging market and developing economies (EMDEs) with solid fundamentals. Meanwhile, the outlook for EMDEs with pronounced vulnerabilities remains precarious amid elevated debt and financing costs. Downside risks to the outlook predominate. The recent conflict in the Middle East, coming on top of the Russian Federation's invasion of Ukraine, has heightened geopolitical risks. Conflict escalation could lead to surging energy prices, with broader implications for global activity and inflation. Other risks include financial stress related to elevated real interest rates, persistent inflation, weaker-than-expected growth in China, further trade fragmentation, and climate change-related disasters.

Against this backdrop, policy makers face enormous challenges and difficult trade-offs. International cooperation needs to be strengthened to provide debt relief, especially for the poorest countries; tackle climate change and foster the energy transition; facilitate trade flows; and alleviate food insecurity. EMDE central banks need to ensure that inflation expectations remain well anchored and that financial systems are resilient. Elevated public debt and borrowing costs limit fiscal space and pose significant challenges to EMDEs-particularly those with weak credit ratings-seeking to improve fiscal sustainability while meeting investment needs. Commodity exporters face the additional challenge of coping with commodity price fluctuations, underscoring the need for strong policy frameworks. To boost longer-term growth, structural reforms are needed to accelerate investment, improve productivity growth, and close gender gaps in labor markets.

Regional prospects. Although some improvements in growth are expected in most EMDE regions, the overall outlook remains subdued. Growth this year is projected to soften in East Asia and Pacific—mainly on account of slower growth in China—Europe and Central Asia, and South Asia. Only a slight improvement in growth, from a weak base in 2023, is expected for Latin America and the Caribbean. More marked pickups in growth are projected for the Middle East and North Africa, supported by increased oil production, and Sub-Saharan Africa, reflecting recovery from recent weakness. In 2025, growth is projected to strengthen in most regions as the global recovery firms.

The Magic of Investment Accelerations. Investment powers economic growth, helps drive down poverty, and will be indispensable for tackling climate change and achieving other key development goals in emerging market and developing economies (EMDEs). Without further policy action, investment growth in these economies is likely to remain tepid for the remainder of this decade. But it can be boosted. This chapter offers the first comprehensive analysis of investment accelerations-periods in which there is a sustained increase in investment growth to a relatively rapid rate-in EMDEs. During these episodes over the past seven decades, investment growth typically jumped to more than 10 percent per year, which is more than three times the growth rate in other (non-acceleration) years. Countries that had investment accelerations often reaped an economic windfall: output growth increased by about 2 percentage points and productivity growth increased by 1.3 percentage points per year. Other benefits also materialized in the majority of such episodes: inflation fell, fiscal and external balances improved, and the national poverty rate declined. Most accelerations followed, or were accompanied by, policy shifts intended to improve macroeconomic stability, structural reforms, or both. These policy actions

were particularly conducive to sparking investment accelerations when combined with wellfunctioning institutions. A benign external environment also played a crucial role in catalyzing investment accelerations in many cases.

Fiscal Policy in Commodity Exporters: An Enduring Challenge. Fiscal policy has been about 30 percent more procyclical and about 40 percent more volatile in commodity-exporting emerging market and developing economies (EMDEs) than in other EMDEs. Both procyclicality and volatility of fiscal policy-which share some underlying drivers-hurt economic growth because they amplify business cycles. Structural policies, including exchange rate flexibility and the easing of restrictions on international financial transactions, can help reduce both fiscal procyclicality and fiscal volatility. By adopting average advanced-economy policies regarding exchange rate regimes, restrictions on crossborder financial flows, and the use of fiscal rules, commodity-exporting EMDEs can increase their GDP per capita growth by about 1 percentage point every four to five years through the reduction in fiscal policy volatility. Such policies should be supported by sustainable, welldesigned, and stability-oriented fiscal institutions that can help build buffers during commodity price booms to prepare for any subsequent slump in prices. A strong commitment to fiscal discipline is critical for these institutions to be effective in achieving their objectives.

GLOBAL OUTLOOK

Global growth is expected to slow to 2.4 percent in 2024—the third consecutive year of deceleration—reflecting the lagged and ongoing effects of tight monetary policies to rein in decades-high inflation, restrictive credit conditions, and anemic global trade and investment. Near-term prospects are diverging, with subdued growth in major economies alongside improving conditions in emerging market and developing economies (EMDEs) with solid fundamentals. Meanwhile, the outlook for EMDEs with pronounced vulnerabilities remains precarious amid elevated debt and financing costs. Downside risks to the outlook predominate. The recent conflict in the Middle East, coming on top of the Russian Federation's invasion of Ukraine, has heightened geopolitical risks. Conflict escalation could lead to surging energy prices, with broader implications for global activity and inflation. Other risks include financial stress related to elevated real interest rates, persistent inflation, weaker-than-expected growth in China, further trade fragmentation, and climate change-related disasters. Against this backdrop, policy makers face enormous challenges and difficult trade-offs. International cooperation needs to be strengthened to provide debt relief, especially for the poorest countries; tackle climate change and foster the energy transition; facilitate trade flows; and alleviate food insecurity. EMDE central banks need to ensure that inflation expectations remain well anchored and that financial systems are resilient. Elevated public debt and borrowing costs limit fiscal space and pose significant challenges to EMDEsparticularly those with weak credit ratings—seeking to improve fiscal sustainability while meeting investment needs. Commodity exporters face the additional challenge of coping with commodity price fluctuations, underscoring the need for strong policy frameworks. To boost longer-term growth, structural reforms are needed to accelerate investment, improve productivity growth, and close gender gaps in labor markets.

Summary

Global economic activity continues to soften, amid the effects of tight monetary policies, restrictive financial conditions, and weak global trade growth. After a sharp slowdown in 2022 and another decline last year, global output growth is set to edge down in 2024, marking the third consecutive year of deceleration. The recent conflict in the Middle East has heightened geopolitical risks and raised uncertainty in commodity markets, with potential adverse implications for global growth. This comes while the world economy is continuing to cope with the lingering effects of the overlapping shocks of the past four years-the COVID-19 pandemic, the Russian Federation's invasion of Ukraine, and the rise in inflation and subsequent sharp tightening of global monetary conditions.

Near-term prospects are diverging (figure 1.1.A). Growth in advanced economies as a whole and in China is projected to slow in 2024 to well below its 2010-19 average pace. Meanwhile, aggregate growth is set to improve in EMDEs with strong

credit ratings, remaining close to pre-pandemic average rates. Although overall growth is also expected to firm somewhat from its 2023 low in EMDEs with weak credit ratings, the outlook for many such countries remains precarious, given elevated debt and financing costs, and idiosyncratic headwinds such as conflict.

Global headline and core inflation have continued to decline from 2022 peaks. Nonetheless, inflation remains above target in most advanced economies and about half of inflation-targeting EMDEs. Global inflation is projected to remain above its 2015-19 average beyond 2024 (figure 1.1.B). Monetary tightening in advanced economies is concluding, but real policy interest rates are expected to remain elevated for some time, as inflation returns to target only gradually. This will keep the stance of advanced-economy monetary policies restrictive in the near-term, following the largest and fastest increase in U.S. real policy rates since the early 1980s (figure 1.1.C).

Long-term yields on advanced-economy government bonds were volatile in 2023, reflecting shifting expectations about the path of future interest rates and sizable movements in term premia. Although yields have retreated from their late-October peaks, they still imply increased fiscal vulnerabilities, given that median global

government debt has risen by 20 percentage points of GDP since 2007, when U.S. yields were last at their current levels. The drag on growth from monetary tightening is expected to peak in 2024 in most major economies, assuming an orderly evolution of broader financial conditions. Thus far, headwinds to growth from elevated interest rates have been offset, to some degree, by households and firms spending out of savings buffers, resilient risk appetite, and extended maturities on stocks of low-cost debt, as well as by expansionary fiscal policy in some cases, most notably the United States.


Global trade growth in 2023 was the slowest outside global recessions in the past 50 years, with goods trade contracting amid anemic global industrial production. Services trade has continued to recover from the effects of the pandemic, but at a slower pace than previously expected. Global trade growth is projected to pick up to 2.3 percent in 2024, partly reflecting a recovery of demand for goods and, more broadly, in advanced-economy trade (figure 1.1.D).

The recent conflict in the Middle East has so far had only a muted impact on commodity prices. In 2023 as a whole, most commodity prices weakened to varying degrees; however, they remain above pre-pandemic levels. Despite recent volatility triggered mainly by the conflict, and assuming hostilities do not escalate, average oil prices in 2024 are projected to edge down as global growth weakens and oil production increases. Metal prices are set to decline again as the slower growth in China further weighs on metal demand. Food prices are expected to soften further this year amid ample supplies for major crops but remain elevated.


Against this backdrop, global growth is estimated to have weakened last year to 2.6 percent (table 1.1). Although this is 0.5 percentage point higher than last June's forecast, it is mainly due to betterthan-expected growth in the United States. Global growth is forecast to slow again, to 2.4 percent in 2024. This deceleration reflects softening labor markets, reduced savings buffers, waning pent-up demand for services, the lagged effects of monetary tightening, and fiscal consolidation.





Over 2020-24, the forecast entails the weakest start to a decade for global growth since the 1990s—another period characterized by geopolitical strains and a global recession (figure 1.1.E; Kose, Sugawara, and Terrones 2020). Global growth is projected to pick up to 2.7 percent in 2025, as inflation continues to slow, interest rates decline, and trade growth firms.

Advanced-economy growth is set to bottom out at 1.2 percent in 2024 as growth in the United States slows, while euro area growth, which was feeble last year, picks up slightly as lower inflation boosts real wages. In 2025, growth in advanced economies is forecast to pick up to 1.6 percent as the euro area continues to recover and U.S. growth edges up toward its long-term trend rate amid declining inflation and more supportive monetary policy.

Growth in EMDEs is forecast to average 3.9 percent a year over 2024-25. China's growth is expected to slow notably this year, as tepid consumer sentiment and a continued downturn in the property sector weigh on demand and activity. Excluding China, EMDE growth is set to firm from 3.2 percent in 2023 to 3.5 percent this year and 3.8 percent in 2025. This pickup reflects a rebound in trade and improving domestic demand in several large economies, as inflation continues to recede. Nonetheless, elevated borrowing costs will continue to squeeze fiscal space in EMDEs: U.S. dollar-denominated bond yields are well above the growth rates of nominal GDP in many countries, especially those with weaker creditworthiness (figure 1.1.F). Although growth in lowincome countries (LICs) is forecast to firm, this will follow a feeble recovery from 2020, with violence and political instability in some countries curtailing activity last year.

In all, the EMDE recovery from the 2020 pandemic recession remains modest. This reflects the negative effects of headwinds such as tight global financial conditions, a weak recovery in global trade, sharp domestic monetary tightening to tame inflation, the marked slowdown in China, and increased conflict. It also reflects the longerterm downtrend in EMDE potential growth, including in China, due to decelerating investment and productivity growth, slowing labor force growth amid population aging, and the diminishing growth benefits of improvements in education and health (Kose and Ohnsorge 2023).

Aggregate EMDE output is projected to continue following a lower path than was expected before the pandemic. As such, progress closing the gap in per capita income with advanced economies will remain limited, with EMDEs excluding China and India making no relative gains between 2019 and 2025 (figure 1.2.A). Many vulnerable EMDEs are falling further behind—this year, per capita income is forecast to be below its 2019 level in over one third of LICs and more than half of countries marred by fragility and conflict (figure 1.2.B).

Risks to the outlook remain tilted to the downside, although they have become somewhat more balanced since June, following continued declines in inflation and the stabilization of advanced-economy banking systems after stresses early last year. The recent conflict in the Middle East, coming on top of Russia's invasion of Ukraine, has sharply heightened geopolitical risks (figure 1.2.C). Intensification of these conflicts, or increasing geopolitical tensions elsewhere, could have adverse global repercussions through commodity and financial markets, trade, and confidence. Recent attacks on commercial vessels transiting the Red Sea have already started to disrupt key shipping routes, eroding slack in supply networks and increasing the likelihood of inflationary bottlenecks. In a setting of escalating conflicts, energy supplies could also be substantially disrupted, leading to a spike in energy prices. This would have significant spillovers to other commodity prices and heighten geopolitical and economic uncertainty, which in turn could dampen investment and lead to a further weakening of growth.

Moreover, a range of possible developments including unexpectedly stubborn inflation in advanced economies requiring higher interest rates than assumed, or rising term premia in bond yields—could precipitate a souring of risk appetite in global financial markets and a sharp tightening of financial conditions, with adverse effects on EMDEs. Weaker-than-projected growth in China could cause a sharper deceleration in global economic activity than expected. The slowdown in global potential growth could be exacerbated by further increases in trade restrictions and escalating fragmentation of trade and investment networks. Furthermore, the adverse effects of climate change could worsen beyond current expectations, with changing weather patterns contributing to more frequent and severe natural disasters, as well as worsening the incidence of extreme poverty (figure 1.2.D).

On the upside, resilient economic activity and declining inflation in the United States could be sustained, even in the face of substantial headwinds, if aided by further labor supply improvements. There is therefore a possibility that U.S. growth continues to be stronger than projected as price pressures recede and monetary policy is eased, which would bolster global activity.


If any of the aforementioned downside risks were to materialize, they could lead to weaker growth than projected in the baseline. Alternative downside scenarios-including higher oil prices due to an escalation of geopolitical tensions, financial stress in EMDEs that leads to surging sovereign spreads, and weaker growth in China resulting in adverse global spillovers via commodity and other channels-show that in each case global growth in 2024 would be reduced by 0.2 percentage point below the baseline (figure 1.2.E). In contrast, an upside scenario with higher-thanexpected U.S. growth due to continuing strong supply conditions could boost global growth by 0.2 percentage point this year.

The weak global growth outlook and the various downside risks highlight the challenges facing policy makers around the world. At the global level, coordinated improvements in debt relief, especially for the poorest countries, will be necessary to free up resources for growthenhancing investments in human and physical capital. Otherwise, mounting debt-service costs and slow progress in debt restructuring could exacerbate the difficulties facing many EMDEs. Already, about half of LICs and many middle-






B. Share of EMDEs with lower GDP per capita in 2024 than in 2019

Enhanced international cooperation is also required to tackle the existential threat of climate change, including by accelerating the clean energy transition, helping countries improve energy security and affordability, and incentivizing the investments needed to pursue a path toward resilient, low-carbon growth. In addition, the global community needs to guard against the fragmentation of trade and investment networks, including by prioritizing a rules-based international trading system and expanding trade agreements. Furthermore, global cooperation is critical to address the pressing issues of mounting food insecurity and conflict.

Policy makers at the national level also face formidable challenges, which will require careful calibration of competing priorities. With inflation projected to continue moderating, policy interest rates are set to ease across many EMDEs over 2024 and 2025. However, monetary policy easing in EMDEs could be constrained by narrowing interest rate differentials relative to advanced economies, which could heighten the risk of capital outflows and currency depreciations. Renewed surges in advanced economy yieldsdriven, for instance, by upside inflation surprises or rising term premia-could also trigger disruptions in EMDE financial markets. Careful attention to risks is therefore required to ensure that monetary policy supports sustainable growth while helping to durably bring down inflation, and to maintain financial stability, particularly in EMDEs with large fiscal and current account deficits.

Fiscal policy space in EMDEs remains narrow amid weak revenues and rising debt-servicing costs. The crises of recent years—particularly the pandemic and the steep rise in living costs resulting partly from the invasion of Ukraine have seen governments running up public debt and reprioritizing spending away from investment toward shorter-term support for households and firms. Elevated debt, combined with tight financial conditions and tepid growth, is putting further pressure on longer-term fiscal sustainability, while increasing vulnerability to external financial shocks. For EMDEs with weak credit ratings, these pressures have already crystallized such that international capital markets have effectively been closed to them for two years (figure 1.2.F). In the face of exigent borrowing costs, governments in EMDEs, including LICs, need to scale up revenue mobilization and spending efficiency and bolster debt management. Measures to strengthen government institutions more broadly can support these efforts.

Commodity-exporting EMDEs face particular fiscal challenges from fluctuations in commodity prices (chapter 4). A sustainable, well designed, stability-oriented fiscal framework, combined with strong institutions, can help governments build buffers during commodity price booms that can be drawn upon during subsequent slumps.

Reversing the ongoing weakening of potential growth and its underlying drivers, including investment and productivity growth, will require decisive structural reforms, including measures to promote trade and financial liberalization, develop human capital and infrastructure, close gender gaps, increase labor force participation, and promote innovation. Such reforms-together with policies that ensure macroeconomic stability, including the adoption of inflation targeting where not already credibly in place-can form comprehensive packages of beneficial policies. Implementing these policy packages, with judicious sequencing, can help to spark sustained investment accelerations, which have a strong track record of delivering transformative growth (chapter 3). The presence of well-functioning institutions also raises the chances of igniting an investment acceleration and securing improved long-term growth performance.

Global context

The global context remains challenging. Global trade growth has been exceptionally weak as a result of subdued global demand, the continued post-pandemic rotation of consumption from goods toward services, and more restrictive trade policies. Notwithstanding recent volatility, prices of most commodities have fallen back from their 2022 peaks but remain above pre-pandemic levels. This moderation has contributed to a decline in

global headline inflation. Core inflation, however, has been more persistent, especially in some advanced economies where labor markets remain tight. This suggests that policy interest rates in advanced economies will decline only gradually, contributing to higher longer-term market rates than those that prevailed before the pandemic. EMDE financial conditions remain restrictive, with less creditworthy sovereigns facing greater financial strains, as reflected in sharp currency depreciations and capital outflows.

Global trade

Global trade in goods and services was virtually flat in 2023, growing by an estimated 0.2 percent-the slowest expansion outside global recessions in the past 50 years. Goods trade contracted last year, reflecting declines in key advanced economies and deceleration in EMDEs, and mirroring the sharp slowdown in the growth of global industrial production. This marked the first sustained contraction in goods trade outside a global recession in the past 20 years (figure 1.3.A). Reflecting stagnant goods trade and fading pandemic-era disruptions, global supply chain pressures have returned to pre-pandemic averages after receding to record lows in mid-2023. Services trade slowed in the second half of 2023, following an initial rebound from the pandemic (figure 1.3.B).

After lagging the pace of global growth in 2023, global trade is projected to pick up to 2.3 percent in 2024, mirroring projected growth in global output (figure 1.3.C). This reflects a partial normalization of trade patterns following exceptional weakness last year (WTO 2023). Goods trade is envisaged to start expanding again, while the contribution of services to total trade growth is expected to decrease, aligning more closely with the trade composition patterns observed before the pandemic. However, in the near term, the responsiveness of global trade to global output is expected to remain lower than the pandemic, reflecting before subdued investment growth. This is because investment tends to be more trade-intensive than other types of expenditures. Global tourist arrivals are expected to return to pre-pandemic levels in 2024,

A. Growth of global goods trade and industrial production




B. Global PMI new export orders

although the recovery is set to lag in some countries where reopening was delayed.

The global trade growth forecast for 2024 has been revised down by 0.5 percentage point since June, reflecting weaker-than-expected growth in China and in global investment. As a result, the recovery of trade now projected for 2021-24 is the weakest following a global recession in the past half century (figure 1.3.D).

Geopolitical uncertainty, especially in light of ongoing armed conflicts, and the possibility of a







more protracted slowdown in China pose downside risks to the trade outlook. Another downside risk arises from the possibility of further measures to restrict international trade. The recent increase in the use of restrictive trade policies, as well as subsidies and industrial policies aimed at localizing production, has accelerated the reshoring of activities by U.S. and European Union (EU) multinationals, although some of this reflects a desire by firms to diversify sourcing to reduce exposure to adverse shocks (Aiyar, Presbitero, and Ruta 2023; Freund et al. 2023). Continuation of this trend could result in more fragmented supply chains and slower trade growth than projected in the baseline.

Commodity markets

The average prices of most commodities, in U.S. dollar terms, fell in 2023 amid moderating demand (figure 1.4.A). However, they remain more than 40 percent above pre-pandemic levels. Crude oil prices were volatile last year, including in the wake of the conflict in the Middle East; they averaged \$83/bbl, down from \$100/bbl in 2022. Production cuts by OPEC+, which were deepened and extended in November 2023, have mostly been offset by robust output elsewhere, including in the Islamic Republic of Iran and the United States. Currently, OPEC+ spare capacity stands at just over 5 mb/d (figure 1.4.B). Oil prices are expected to edge down to \$81/bbl in 2024 as global activity slows and China's economy continues to decelerate. An escalation of the conflict in the Middle East is a major upside risk to oil prices. Indeed, since the 1970s, a series of significant geopolitical events, often marked by military conflict, have exerted a pronounced impact on oil supplies (figure 1.4.C). Further extensions of production cuts by OPEC+ (to beyond an expected phase-out of cuts in the first quarter of 2024) and stronger-than-expected demand could also result in higher prices.

Natural gas and coal prices declined considerably in 2023 as countries in Europe reduced energy demand and maintained gas inventories above 90 percent of their storage capacity. Natural gas prices are expected to fall further in 2024 and 2025 as production increases, and as liquefied natural gas exports rise. Key upside risks to gas prices include

supply disruptions from the Middle East linked to the conflict and a colder-than-usual winter in Europe.

Metal prices fell by 10 percent in 2023 on account of sluggish demand from major economies notably China, which accounts for 60 percent of global metal consumption, in the midst of protracted weakness in the country's property sector (figure 1.4.D). Metal prices are expected to fall further in 2024, before picking up in 2025 as China's property sector stabilizes and demand for metals used in the green transition (such as copper and nickel) increases. A greater-than-expected downturn in China's real estate sector is a key downside risk to prices.

Food prices-the biggest component of the agriculture price index—fell by 9 percent in 2023, reflecting ample supplies of major crops, particularly grains (figure 1.4.E). Rice was the exception-its price rose 27 percent in the year amid restrictions on exports of non-basmati rice from India, the world's top rice exporter. Food prices are expected to decline nearly 1 percent in 2024 and 4 percent in 2025. Key upside risks to food prices include increases in energy costs, adverse weather events (possibly as a result of an intensification of the ongoing El Niño), further trade restrictions, and geopolitical uncertainty in the Black Sea region. Longer-term risks include the effects of climate change and the expansion of biofuel mandates.

Food insecurity remains a key challenge amid high, albeit declining, consumer food price inflation (figure 1.4.F). The number of people who are severely food insecure globally is estimated to have risen from 624 million in 2017 to 900 million in 2022 (FAO et al. 2023). The recent surge in rice prices is likely to exacerbate food insecurity as rice is a staple food for over half the world's population, providing more than 20 percent of the calories consumed worldwide.

Global inflation

Global headline consumer price inflation declined substantially in 2023 (figure 1.5.A). Moderating energy and food price inflation, along with slowing consumer demand for goods and the










A. U.S. real interest rate cycles

Sep-23 Oct-23 Nov-23 Dec-23 recovery of global supply chains, exerted significant downward pressure on goods inflation. Nonetheless, inflation remains above targets in most advanced economies and in about half of inflation-targeting EMDEs (figure 1.5.B). In the major advanced economies, the rotation of demand from goods to services continued. Declining goods inflation amid easing import prices was partly offset, however, by persistent services inflation tied to tight domestic labor markets (figure 1.5.C). As a result, core inflation, which surged less than headline inflation in 2021-22, has also declined less since its 2022 peak (figure 1.5.D).

The decline in core inflation has proceeded under markedly different growth conditions across countries. In the United States, disinflation has occurred alongside resilient activity and low unemployment, thanks partly to increasing labor supply, improving supply chains, and falling oil prices. The decline in the euro area inflation was accompanied by weak growth, reflecting the negative supply shocks from earlier sharp energy price increases. In most EMDEs, headline and core inflation receded last year as growth weakened. Nevertheless, in countries facing financial stress, inflation remained very high, in association with currency depreciations.

In 2024-25, global inflation is expected to decline further, underpinned by the projected weakness in global demand growth and slightly lower commodity prices. Subdued demand reflects the effects of tight monetary and credit conditions and softening labor markets. Thus, global headline inflation, on a year-on-year basis, is forecast to recede to 3.7 percent in 2024 and 3.4 percent in 2025—still above the pre-pandemic (2015-19) average but closer to central bank inflation targets (figure 1.5.E). Surveys of inflation expectations similarly suggest a steady decline in inflation, but to levels in 2024 that are still higher than prepandemic averages (figure 1.5.F). In particular, Consensus forecasts indicate lower inflation this year than last in 85 percent of EMDEs.

Global financial developments

Monetary tightening in advanced economies is concluding, with subsequent easing of policy interest rates likely to proceed at a measured pace. This, alongside softening inflation, could keep real policy rates elevated for an extended period, following the largest and fastest increase in real U.S. policy rates since the early 1980s (figure 1.6.A). In the United States, tight monetary policy reflects better-than-expected growth outturns. In the euro area, persistent core inflation has played a larger role. Reflecting both the outlook for policy rates and volatile term premia, government bond vields in advanced economies in October reached their highest levels since the late 2000s. Although yields have pulled back since then, they remain at levels that will put upward pressure on the cost of capital for governments and firms as debts are rolled over (figure 1.6.B).

High financing costs have been reflected in credit market developments. Advanced-economy banks have been reporting restrictive lending standards, and bank credit growth has slowed sharply. In addition, corporate bankruptcies and credit card delinquencies have picked up. Although private sector debt-service ratios remain generally manageable, reflecting the stock of debt issued at low fixed rates, they have been trending up, most notably in China (figure 1.6.C). Risk appetite in advanced-economy financial markets has nonetheless been resilient, which has somewhat mitigated the tightening effect of higher interest rates on broad financial conditions. Indeed, equity volatility was subdued in the second half of 2023, while corporate credit spreads were generally below 2000-19 median levels.

Across EMDEs, a rising number of central banks have started cutting policy rates, with further reductions expected in the coming months, especially in Europe and Latin America (figure 1.6.D). Most EMDEs have so far exhibited few signs of financial stress, despite higher interest rates. This is likely due to a mix of factors, including better-than-expected growth, limited current account vulnerabilities, and declining inflation following proactive monetary tightening, all of which have helped contain currency depreciation. Unlike other large EMDEs, China has undergone a period of notable financial strain. Subdued growth prospects and upheaval in the property sector have contributed to debt defaults by property developers, net sales of debt and

equity securities by foreign investors, and a decline in the exchange value of the renminbi.

Economies with weak credit ratings—roughly one in four EMDEs—continue to face prohibitively high financing costs. Lacking access to marketbased financing, these countries ceased international bond issuance two years ago (figure 1.6.E). In addition, and in contrast to other EMDEs, their currencies depreciated substantially last year—some by as much as 30 percent, a threshold often associated with currency crises (figure 1.6.F).

Major economies: Recent developments and outlook


Advanced economies

Aggregate growth in advanced economies was resilient for most of last year, slowing less than previously expected. However, this largely reflected developments in the United States, where consumer spending, in particular, remained robust and fiscal policy was expansionary. Growth in advanced economies is forecast to slow in 2024for the third year in a row-to 1.2 percent, as domestic demand decelerates (table 1.1). Private consumption growth is set to soften as the boost from one-off factors, such as the stock of excess savings accumulated during the pandemic, gradually fades. Investment growth should also remain subdued as sustained high real interest rates and restrictive credit conditions dampen business investment. Most of the projected slowdown in advanced-economy growth in 2024 is due to a deceleration in the United States; it is only partly offset by an expected pickup in euro area growth as the lingering effects of earlier price shocks dissipate.

In the **United States**, growth was resilient last year, picking up to an estimated 2.5 percent, despite rising borrowing rates and tightening credit conditions. Consumer spending remained solid, supported by accumulated savings, tight labor markets, and a boost to disposable incomes from one-off tax adjustments (figure 1.7.A). Activity was also supported by an expansionary impulse from fiscal policy. Growth appears to have softened in the fourth quarter, with weakness

> set to intensify as the lagged and ongoing effects of tight monetary policy increasingly weigh on household spending, and as temporary factors supporting consumption dissipate. With the household saving rate having fallen far below the pre-pandemic average last year, excess savings accumulated during the pandemic have likely been substantially drawn down (Barbiero and Patki 2023). In addition, the real value of these savings and the growth in real household net worth have been eroded by sharp runups in consumer prices and interest rates.

> Tightness in the U.S. labor market has been gradually easing. Job openings have declined,

employment growth has steadily slowed, and wage growth has subsided, despite the unemployment rate remaining near historic lows (figure 1.7.B). Some key drivers of widespread labor shortages, including pent-up demand for labor-intensive services, have been fading. At the same time, labor supply has been rising, with increased prime-age labor force participation partly offsetting the impact of early retirements during the pandemic (Montes, Smith, and Dajon 2022).

In 2024, U.S. growth is expected to slow to 1.6 percent, with high real interest rates restraining activity. Fiscal policy is expected to turn more restrictive, even as elevated interest rates and weakening growth weigh on the federal budget balance (Swagel 2023). A further weakening in consumption growth is projected, amid diminished savings, still-elevated borrowing rates, and easing labor market tightness. Business fixed investment is also set to decelerate further as firms remain cautious, given economic and political uncertainties, and increasingly refinance corporate debt at higher interest rates. Growth is expected to edge up to 1.7 percent in 2025, closer to its trend rate, as the impact of easing monetary policy feeds through the economy.

In the **euro area**, growth slowed sharply in 2023, to an estimated 0.4 percent, as high energy prices—largely related to Russia's invasion of Ukraine—weighed on household spending and firms' activity, particularly in manufacturing. Estimated growth in 2023 is in line with last June's projections, with unexpected resilience in the first half of the year offset by weaker-thanexpected activity in the second half. The downturn in late 2023 reflected broadening weakness in the economy, which extended to the services sector. This was partially attributed to the ongoing decline in exports amid deteriorating export price competitiveness and tepid external demand.

Growth in 2024 is forecast to firm to a stillanemic 0.7 percent. Easing price pressures should boost real wages and lift disposable incomes, but the lagged effects of past monetary tightening are expected to keep a lid on domestic demand, especially business investment, partly by reducing credit growth (figure 1.7.C). The forecast for growth in 2024 has been downgraded since June by 0.6 percentage point, largely owing to weakerthan-expected momentum at the start of the year and more adverse credit supply conditions than previously assumed.

Growth is projected to pick up to 1.6 percent in 2025, supported by a recovery in investment growth, especially as the European Union's NextGenerationEU (NGEU) funds lift public investment and help offset modest consolidation of national fiscal balances. Increased absorption of NGEU funds is predicated on reform milestones being met under Recovery and Resilience plans (European Commission 2023). NGEU-related investments and reforms are expected to accelerate the green and digital transitions and address long-standing structural issues, thereby supporting long-term growth (World Bank 2022a).

In Japan, growth bounced back to an estimated 1.8 percent in 2023, driven by post-pandemic pent-up demand and a rebound in auto exports and inbound tourism. Despite above-target inflation for over a year, the Bank of Japan continued to maintain accommodative monetary policy, but it gradually relaxed its policy of yieldcurve control and allowed longer-term rates to rise. In the forecast horizon, weak growth in major trading partners will weigh on exports, offsetting the support to domestic demand from an expected rebound in real wages amid tight labor markets and slowing inflation. On balance, as the postpandemic rebound tapers off, growth is forecast to slow to 0.9 percent in 2024 and 0.8 percent in 2025, close to its trend rate.

China

Growth in China picked up to an estimated 5.2 percent in 2023, 0.4 percentage point below the June forecast. The boost to consumption early in the year from the lifting of pandemic-related restrictions turned out to be unexpectedly short-lived. The downturn in the property sector intensified as property prices and sales fell, and as developers experienced renewed financial pressures. Real estate investment contracted, while the growth of infrastructure investment was slower than pre-pandemic average rates, resulting in lackluster overall fixed investment growth (figure

1.7.D). Private consumption firmed somewhat toward the end of the year, but consumer confidence remained weak, while feeble external demand weighed on exports. The authorities implemented several stimulus measures, including lowering interest rates and deposit requirements for property purchases, while government debt issuance was expanded to support spending.

In 2024, growth is forecast to slow to 4.5 percent-the slowest expansion in over three decades outside the pandemic-affected years of 2020 and 2022, and marginally lower than envisaged in June. Subdued sentiment is expected to weigh on consumption, while persistent strains in the property sector will hold back investment. Soft construction starts in late 2023 signal further weakness in property activity as developers grapple with stressed balance sheets and lackluster demand. While central government support should help boost infrastructure spending, local governments have limited fiscal space for policy maneuvering. Trade growth is also set to remain weak in 2024, with subdued global demand weighing on exports and slower domestic demand growth holding back imports, including of metals.

Growth is expected to edge down further in 2025, to 4.3 percent, amid the continuing slowdown of potential growth. Mounting debt constraining investment, demographic headwinds, and narrowing opportunities for productivity catch-up are all expected to drag on potential growth.

Emerging market and developing economies

Growth in EMDEs is projected to remain steady at about 3.9 percent a year in the forecast horizon, but with underlying variation across regions (box 1.1). Decelerating activity in China is expected to be offset by firming aggregate growth elsewhere, with improving domestic demand in many countries and a pickup in international trade. Overall, however, the recovery by EMDEs from the pandemic-induced recession of 2020 is expected to remain lackluster, with EMDE growth notably slower than in the recovery from the 2008-09 global financial crisis. Growth is projected to remain weak in EMDEs with low

BOX 1.1 Regional perspectives: Outlook and risks

Although some improvements in growth are expected in most emerging market and developing economy (EMDE) regions, the overall outlook remains subdued. Growth this year is projected to soften in East Asia and Pacific—mainly on account of slower growth in China—Europe and Central Asia, and South Asia. Only a slight improvement in growth, from a weak base in 2023, is expected for Latin America and the Caribbean. More marked pickups in growth are projected for the Middle East and North Africa, supported by increased oil production, and Sub-Saharan Africa, reflecting recovery from recent weakness. In 2025, growth is projected to strengthen in most regions as the global recovery firms. Risks to the outlook remain tilted to the downside. An escalation of the conflict in the Middle East could disrupt global oil supplies and cause a surge in prices for energy and food, pushing up inflation in all regions. Other downside risks include further geopolitical and trade tensions, the possibilities of weaker growth in China and weaker external demand, tighter-than-expected financial conditions, and climate-change-related natural disasters.

Introduction

Growth prospects for EMDE regions vary in the face of an array of global and domestic currents. Although some improvements in growth are expected in most regions, the overall outlook remains subdued. Projected growth is insufficient to reverse output losses inflicted by the overlapping shocks of the past four years, and implies dim prospects for poverty reduction and catching up to advanced-economy per capita income levels.

A modest improvement in global trade this year is expected to lend some support to activity in EMDE regions, yet overall growth is projected to remain feeble, partly reflecting the slowdown in China. While headline inflation is generally anticipated to continue moderating across regions, it remains elevated in some, limiting the scope for monetary policy easing. Moreover, global financial conditions are envisaged to remain tight, amid elevated real interest rates in the major advanced economies. While risks have become more balanced since June, they remain tilted to the downside. In particular, an escalation of the conflict in the Middle East could disrupt global energy markets, with adverse knock-on effects for some commodity prices, inflation, and food insecurity, and ultimately growth.

In this context, this box considers two questions:

- What are the cross-regional differences in the outlook for growth?
- What are the key risks to the outlook for EMDE regions?

Outlook

The overall outlook for EMDE regions remains subdued. Assuming the conflict in the Middle East does not escalate, growth in 2024 is projected to decline in East Asia and Pacific (EAP), Europe and Central Asia (ECA), and South Asia (SAR) and somewhat strengthen to varying degrees in other EMDE regions (figure B1.1.1.A). In EAP, the expected slowing mainly reflects declining growth in China in the face of persistent property sector weakness and structural headwinds. In Latin America and the Caribbean (LAC), growth is projected to edge up only slightly, while growth is expected to pick up more markedly from below-trend growth in 2023 in the Middle East and North Africa (MNA)-supported by recoveries in oil-exporting economies-and Sub-Saharan Africa (SSA). In 2025, growth is projected to strengthen in most regions coinciding with an expected step-up in global growth. SAR is projected to remain the fastest-growing EMDE region over the forecast horizon, led by strong growth in India underpinned by resilient domestic demand.

Despite some strengthening, growth in 2024-25 is anticipated to be slower than in the decade preceding the pandemic in some EMDE regions. Projected growth will also be insufficient to reverse the output losses inflicted by the overlapping negative shocks of the pandemic, the Russian Federation's invasion of Ukraine, the sharp tightening of monetary policy, and the conflict in the Middle East, with output set to remain below pre-pandemic trends in 2025 in all regions (figure B1.1.1.B). Particularly in EAP, but also ECA and LAC, output losses relative to pre-pandemic projections are expected to increase in the forecast period. This reflects various headwinds that have weakened growth prospects, including China's slowdown, the impact of Russia's invasion of Ukraine,



and—particularly in the case of LAC—early and substantial monetary policy tightening in response to rising inflation.

The pace of catch-up to advanced-economy GDP per capita levels is also expected to be slower than in the decade before the pandemic in all EMDE regions except LAC and MNA, where only modest catch-up is expected after a decade of falling behind (figure B1.1.1.C). Worse still, GDP per capita in SSA, which is projected to have the slowest growth among all regions, is set to increasingly lag advanced-economy levels. This decline is occurring in the context of weak institutional quality and flare-ups of conflict and violence, further underscoring the development challenges facing the poorest areas of the world.

After a marked slowdown in global trade last year, an expected modest pickup in 2024 should support output growth in most regions. Many export-oriented economies, including in ECA and LAC, stand to benefit, but in EAP slower growth in China will weigh on regional trade. Tailwinds from the recovery in global


tourism are envisaged to fade through 2024, but to a lesser extent in EAP owing to China's delayed reopening and ongoing recovery in outbound tourism. To varying degrees, over 2024 and 2025 investment is also anticipated to pick up in most regions, supported by lower inflation and easing monetary policy. In energy exporters, particularly in MNA, growth will be supported by elevated energy prices and a ramp-up in oil production. However, continued weakness in metal prices—in part reflecting weaker growth in China, which accounts for most of the global metals demand is expected to soften growth in metal-exporting countries, especially in LAC and SSA (Baffes and Nagle 2022).


Following a significant decline through 2023, headline consumer price inflation is projected to continue easing across EMDE regions in 2024. However, in ECA, MNA, SAR, and SSA, headline inflation is yet to return to central bank targets in many economies. Moreover, with most commodity prices projected to remain above pre-pandemic levels, households and businesses particularly in commodity importers—continue to







C. China's share of goods exports




D. Debt

endure elevated prices. Local food supply shockspartly due to El Niño conditions-are also contributing to expected persistently high food prices and worsening food insecurity. These challenges are most acute where the food share of household spending is greatest and food supply has been impacted by repeated shocks from conflict and adverse weather, notably in MNA and SSA. The initial rise in oil prices following the conflict in the Middle East-and the risks associated with an escalation, discussed below-also underscores the significant uncertainty facing commodity markets.

In tandem with easing inflationary pressures, the tightening of monetary policy appears to have generally ended across EMDE regions. In some cases, policy interest rates have recently been reduced, most notably

in regions where underlying inflationary pressures appear most benign and where central banks began tightening the earliest in response to commodity price shocks through 2022 and 2023. This is particularly evident in LAC and some economies in ECA. While interest rates are expected to decrease further in all EMDE regions this year, the extent of easing may be limited in many instances, partly reflecting continued tight monetary policy in major advanced economies. Given lags in monetary policy transmission, headwinds from the substantial tightening in all EMDE regions through 2022 and much of 2023 will endure in the near term before fading through 2024-25. Moreover, the slowest growth is projected in EMDEs with weaker sovereign credit ratings that have experienced the strongest drags on activity from tight global financial conditions, including in MNA, SAR, and SSA. Fiscal policy is anticipated to exert a broadly neutral influence on activity in the forecast period, though in some regions, including ECA, SAR, and SSA, consolidation is expected to gather momentum, exerting a drag on activity.

Risks

Risks to the baseline growth projections for EMDE regions remain tilted to the downside, with risks from heightened geopolitical tensions-especially those related to the recent conflict in the Middle East-being particularly salient. As underscored by historical precedent, an escalation in the Middle East conflict could disrupt global energy supplies and cause energy prices to spike (chapter 1; World Bank 2023a). All regions are exposed to the risk of higher energy prices but particularly EAP and SAR, both net petroleum importers (figure B1.1.2.A). By increasing production costs, higher energy prices resulting from the conflict would have adverse knock-on effects for prices of other commodities, including metals and food, pushing up inflation and worsening food security. Higher inflation could force central banks to pause planned easing or even to tighten further, weighing on growth. Moreover, MNA, and other regions directly affected by conflict, including ECA, are exposed to the risk of further losses of human life and destruction of capital, including infrastructure. This could offset any benefit to energyexporting regions from higher oil prices and significantly weaken productive capacity (Dieppe, Kilic Celik, and Okou 2020).

Heightened geopolitical tensions and trade fragmentation could spur uncertainty and scuttle the projected recoveries in trade and investment growth. In the face of increased trade policy restrictions, firms in EMDEs are contending with mounting trade frictions and higher costs. The near-shoring and friend-shoring of activities in some advanced economies, including in response to domestic content requirements, has strained global supply chains and shifted the global trade and investment landscape (Alfaro and Chor 2023). Regions most reliant on global value chains, especially those with a significant manufacturing sector reliant on intermediate goods trade, including EAP and ECA, are most at risk (figure B1.1.2.B).

All EMDE regions face the risk of weaker-thanexpected external demand, including from a sharper slowdown in China. Given China's growing share of global output and trade, it has become a key export market for all EMDE regions, particularly for EAP excluding China and SSA (figure B1.1.2.C). Exportoriented EMDEs with strong direct links to China, notably in EAP, are particularly vulnerable. Exporters of commodities that depend on Chinese demand, notably metals, including those in LAC and SSA, are also vulnerable to the risks associated with a sharper slowdown in China.

Recent bouts of financial stress across EMDEs have generally been confined to a small number of countries with relatively weak credit ratings in MNA, SAR, and SSA. However, there continue to be notable risks of even tighter financial conditions—including associated with currency depreciations—confronting all regions. Overall indebtedness has risen in all regions over the past decade, particularly in EAP and LAC, with mounting public and private debt (figure B1.1.2.D). This magnifies exposure to the risk of higher interest rates than currently anticipated. Moreover, with fiscal deficits estimated to have widened in many EMDEs in 2023—to levels above pre-pandemic averages in most EMDE regions—there is renewed upward pressure on public debt (figure B1.1.2.E).

Climate-change-related extreme weather events, which have become more frequent in all EMDE regions in recent decades, pose a downside risk to growth and poverty alleviation (figure B1.1.2.F; Jafino et al 2020). An elevated risk of El Niño conditions continuing into

2024 increases the likelihood of a surge in global temperatures, and of disruptive weather patterns that could damage agricultural output, particularly in EAP, LAC, and SSA (FAO 2023a). Moreover, more frequent storms and floods could damage critical infrastructure, including for transport and energy supplies, with adverse consequences for broader economic activity. Such events can also directly disrupt mining activity, posing a particular threat to ECA, LAC, and SSA. Other types of natural disasters could inflict major costs, as underscored by the devastating earthquakes in MNA and SAR last year.

Finally, growth in the United States was surprisingly resilient in 2023, and the continuation of stronger-

sovereign credit ratings, as they continue to suffer from the tightness of global financial conditions. Growth is forecast to pick up in LICs, but by less than previously expected.

Recent developments


FIGURE 1.8 Recent developments in emerging market and developing economies

EMDE growth is estimated to have picked up to 4 percent in 2023—but, excluding China, to have decelerated to 3.2 percent. In many EMDEs, subdued demand for goods in advanced economies weighed on exports, while elevated interest rates dampened domestic demand. Recent business surveys indicate weak expansion in manufacturing and waning growth in services (figure 1.8.A). Reflecting these trends, EMDE growth is estimated to have slowed markedly in the second half of the year (figure 1.8.B).

Shifts in the composition of global demand have led to divergent trade outcomes across countries. Weak global goods trade has weighed on EMDEs with large goods-exporting sectors. Thus, last year, export volumes barely grew in EMDEs in the top quartile for goods exports relative to GDP (figure 1.8.C). Exports held up better among services exporters, which benefited from resilient, albeit slowing, growth of global services activity, including tourism.

Commodity exporters have faced headwinds from subdued growth of global industrial production.

than-expected U.S. activity presents an upside risk to the outlook for all EMDE regions. Stronger growth in the United States could be accompanied by declining inflation and easing financial conditions due to further improvements in labor supply or productivity. Exportoriented economies with solid direct trade links to the United States, particularly in EAP and LAC, would benefit most. Other regions would also gain, including through positive spillovers to EMDE commodity exporters from stronger global demand. In such a scenario, improved global sentiment and more favorable conditions—including increased financial global investor risk appetite-could ease financial pressure and borrowing costs in all EMDE regions, thereby supporting demand.

> Growth in oil exporters slowed to just 2.1 percent in 2023, amid OPEC+ production cuts. Growth in metals exporters—a group particularly exposed to the slowdown in China—was only 0.7 percent. In all, growth in commodity exporters is estimated to have weakened by about 0.7 percentage point, to 2.5 percent, in 2023.

> Commodity importers, excluding China, grew at a more robust pace of 4.2 percent in 2023. This was largely due to continued resilience in India, which is benefiting from increasing public investment and solid services sector growth (World Bank 2023b). Excluding India and China, output in these economies expanded by 3.1 percent. In some commodity importers, severe food and energy price shocks have eroded real wage growth since end-2021, dampening consumption growth.

> Growth in LICs in 2023 was particularly disappointing, slowing to 3.5 percent—1.7 percentage points below the June forecast (figure 1.8.D). This downgrade is largely attributed to the economic consequences of renewed civil conflict in Sudan and the coup in Niger. More broadly, the ongoing conflict in the Sahel region has continued to weigh on growth.

EMDE outlook

Growth in EMDEs is expected to average 3.9 percent per year in 2024-25, broadly in line with

estimates of EMDEs' potential growth in the 2020s. Excluding China, EMDE growth is projected to firm from 3.2 percent last year to 3.5 percent in 2024 and 3.8 percent in 2025 (table 1.1). This pickup reflects steady improvements in projected trade growth and expectations for solid domestic demand growth in several large economies, as inflation continues to recede and interest rates decline. The firming outlook for external demand represents a partial normalization of the relationship between global GDP and EMDE goods exports, following an unusually services-intensive expansion last year. Growth is forecast to increase in two-thirds of EMDEs this year.




FIGURE 1.9 Outlook in emerging market and developing economies

Despite these improvements, the recovery from the global recession of 2020 over the forecast horizon will remain modest. Overall EMDE growth is projected to be weaker than in the 2010s, partly as a result of the slowing of China's potential growth (figure 1.9.A). Excluding China, EMDE output is set to continue following a lower path than before 2020 (figure 1.9.B). This projected recovery is also substantially weaker than that following the global financial crisis, reflecting the effects of Russia's invasion of Ukraine and the rise in interest rates, as well as longer-term scarring from the pandemic and declining growth in working-age populations (figure 1.9.C).

In commodity exporters, growth is expected to strengthen to 2.9 percent in 2024 and to edge up further to 3.1 percent in 2025 (figure 1.9.D). Much of this projected improvement is due to stronger activity in energy exporters, where energy production is expected to rebound somewhat following large cuts in 2023. Although the forecast assumes modest energy price declines this year and next, projected prices should be sufficient to support investment and fiscal revenues in these economies, which should boost broader economic confidence and non-energy-sector activity.


Growth in metal exporters is forecast to recover somewhat, averaging 2.6 percent over 2024-25, even though growth in both years has been downgraded from June. The slowdown in China's real estate sector, and the structural overcapacity that it reflects, is likely to have enduring




B. Semi-annual growth in EMDEs



dampening effects on metals demand. The associated weakness in the export growth and terms of trade of metal exporters is also expected to constrain domestic demand growth, especially in the sizable number of metal exporters (many in Sub-Saharan Africa) facing prohibitive international borrowing costs.

In agricultural exporters, growth is projected to remain stable at 2.6 percent in 2024, before rising to 3.2 percent in 2025. The moderate acceleration next year partly reflects agricultural prices that are high enough to encourage expanded produc-


A. EMDE actual and potential growth



C. Expansions after 2009 and 2020 in EMDEs excluding China




E. EMDE fiscal impulse and primary deficit





In commodity importers excluding China, growth is forecast to remain at 4.2 percent in 2024, and then increase to 4.5 percent in 2025. Many larger EMDEs in this group have substantial exportoriented manufacturing sectors, which are expected to recover somewhat as goods trade expands after last year's trough. In addition, several economies in Sub-Saharan Africa and East Asia and the Pacific are envisaged to see further recoveries in tourism, which has yet to return to pre-pandemic activity levels. Meanwhile, robust growth in India is mostly due to strong domestic demand: fixed investment is forecast to continue expanding rapidly amid rising public infrastructure spending and strong private-sector credit growth, backed by solid corporate sector balance sheets (World Bank 2023b).

With inflation projected to continue retreating, and policy rates already declining in many EMDEs, monetary policies are expected to be more supportive of EMDE growth in 2024-25 than 2023. Lower domestic interest rates and improving real incomes should start to support consumption and business investment in 2024. A broader easing in global financing conditions is expected to take hold in 2025, as advancedeconomy policy rates are further reduced. This, in turn, should translate into a more benign external environment for many EMDEs, as dollardenominated borrowing costs moderate and firming growth in the United States and euro area supports trade.

Fiscal policies in EMDEs are positioned to dampen growth somewhat this year and next, as governments gradually consolidate budgets following the pandemic-era debt buildup, partly in response to pressures from rising interest rates and debt-service costs (figure 1.9.E). Consolidation is expected to be accomplished mainly through reductions in primary expenditures.

The impact of tight global financial conditions on activity has been most acute in the roughly onefourth of EMDEs with weak credit ratings (Caa-C). Several have experienced debt or currency crises, necessitating current account adjustments through sharp currency depreciations and import compression. The acute phase of these crises appears to be passing in some countries, helped by the introduction of policy programs supported by multilateral organizations. Overall, growth in EMDEs with weak credit ratings is projected to stabilize somewhat over the next two years, albeit at low rates (figure 1.9.F). Even so, output is set to remain well below pre-crisis paths. In many cases, growth is likely to be too weak to durably resolve the challenge of unsustainable fiscal positions or to repair the deterioration in living standards in recent years.

LICs outlook

Growth in LICs is projected to pick up from an estimated 3.5 percent rate in 2023 to 5.5 percent this year and 5.6 percent in 2025—about 0.5 percentage point below last June's forecasts in both years (box 1.2). Growth is expected to be relatively strong among some of the largest LICs, including Ethiopia and Uganda, but weaker in fragile LICs. The projected recovery in 2024 is underpinned by a pickup in LIC metal exporters and the stabilization of some economies marred by conflict last year. In particular, Sudan's outlook has improved notably, with household and business spending expected to continue recovering from the sharp conflict-related contraction in 2023.

Many LICs will continue to face daunting challenges, with projected growth insufficient to allow significant progress in reducing poverty. The resources available to LIC governments to support their populations continue to be squeezed by rising debt-service costs. In addition, slow progress in debt restructuring aggravates the situation for many highly indebted LICs, with access to new external financing remaining highly constrained. A surge in political instability poses additional challenges, including to food security, particularly in the Sahel region.

Per capita income growth

EMDE GDP per capita is projected to grow by 2.9 percent in 2024 and 3 percent in 2025, well below its 2010-19 average annual rate of 3.7 percent. Given subdued projected per capita

growth in advanced economies, averaging 1.2 percent a year in 2024-25, the outlook is for per capita income catch-up by EMDEs at a pace broadly similar to the 2010s. However, excluding China, EMDE per capita growth is forecast to be significantly lower, at 2.2 percent this year and 2.5 percent next year.

Although the projected pace of catch-up is an improvement compared to recent years, it will follow an extended period during which per capita incomes in many EMDEs made little progress toward those in advanced economies. Indeed, excluding China and India, EMDEs in aggregate are projected to make no relative gains on advanced economies between 2019 and 2025 (figure 1.10.A). Some of the most vulnerable EMDEs are falling further behind, with per capita income forecast to remain below its 2019 level this year in over a third of LICs and more than half of economies facing fragile and conflict-affected situations (FCS; figure 1.10.B).

High prices for essential goods remain a major challenge to living standards and, particularly in LICs and FCS economies, to human capital development. Moderate declines in commodity prices since their 2022 peaks have not been fully reflected in consumer prices for food and fuel, and wage rises have generally failed to compensate for earlier runups in these costs (figures 1.10.C and 1.10.D). Thus, although inflation has started to moderate, real incomes remain under pressure. Moreover, the large shocks of the past few years, including the pandemic and the invasion of Ukraine, have tended to hit low-income households disproportionately and exacerbate poverty. This reflects such factors as the unequal labor market impacts of the pandemic and lowincome households' high share of spending on food (Adarov et al. 2022; Hoogeveen and Lopez-Acevedo 2021).

Global outlook and risks

Summary of global outlook

Global growth is projected to edge down from an estimated 2.6 percent in 2023 to 2.4 percent in 2024, marking the third consecutive year of deceleration (table 1.1; figure 1.11.A). Relative to

After slowing to an estimated 3.5 percent in 2023, economic growth in low-income countries (LICs) is projected to recover to about 5.5 percent in both 2024 and 2025—a downward revision from previous projections mainly driven by a deterioration in the outlook for metal-exporting LICs. Additionally, the growth in income per capita in 2024-25 is projected to be lower, at half the rate of gross domestic product (GDP) growth. The number of people struggling with extreme poverty and food insecurity in these countries remains high. Recent flare-ups of political instability and violent conflict have also amplified the challenges faced by some LICs. In many cases, inflation remains elevated, public debt burdens have risen, and activity has been disrupted by extreme weather events. Against this backdrop, risks to the outlook remain tilted to the downside, including those from intensifying insecurity and violent conflict, weaker global growth, higher-than-projected inflation, increased debt distress, and more frequent or intense extreme weather events. An escalation of the conflict in the Middle East could lead to an increase in food price inflation and food insecurity in LICs, especially those highly dependent on food and energy imports.

Introduction

Although growth in LICs is expected to improve in 2024 from a weak performance in 2023, the number of people struggling with extreme poverty and food insecurity in these countries will remain high. Sluggish growth last year mainly reflected increased political instability and violent conflict in some fragile LICs, especially Sudan, and weaker outturns in some metal-exporting LICs facing lower global metal prices. Peacebuilding in Ethiopia is gradually yielding dividends, and growth prospects for Niger, South Sudan, and Sudan are improving somewhat.

Nonetheless, many LICs continue to struggle with persistent vulnerabilities and fragility, as the lingering effects of elevated inflation, despite recent declines, still weigh on food affordability for vulnerable populations. Many LICs also continue to face difficult policy tradeoffs. Not only has policy space to support the poor been depleted in many of these countries, but high financing needs endanger debt sustainability. Elevated levels of violence and extreme weather events have continued to displace people, disrupt food supplies, and exacerbate poverty.

Multiple downside risks cloud LICs prospects, including a further rise in local or global political instability and violent conflict—especially the conflict in the Middle East, which could exacerbate food insecurity in LICs. Also, the risk of a sharper-than-expected global economic slowdown, especially one emanating from China, or more adverse weather events, could weigh on economic activity. Furthermore, more persistent global inflation could lead to additional monetary tightening, in turn adding pressure on highly indebted countries.

Against this backdrop, this box addresses the following questions.

- What have been the main recent economic developments in LICs?
- What is the baseline outlook for LICs?
- What are the risks to the outlook?

Recent developments


Growth in LICs slowed from 4.8 percent in 2022 to an estimated 3.5 percent in 2023. The decline was pronounced in Niger, primarily because of the July coup and the subsequent international sanctions. Sudan also faced significant deterioration, with a resumption of conflict damaging the country's industrial base. In about half of the LICs, estimates for growth for 2023 have been downgraded compared with June projections. Pervasive violence and political instability exacerbated the challenging economic and humanitarian situations in many LICs last year-especially in the Sahel region-including Burkina Faso, Mali, Niger, Somalia, South Sudan, and Sudan (figure B.1.2.1.A). While peacebuilding efforts remained fragile in Ethiopia and the Democratic Republic of Congo, growth in these countries, though slowing in 2023, remained above the LIC average.

Output in agricultural commodity exporters grew by 2.9 percent in 2023—below their long-term average but still markedly faster than in their metal-exporting counterparts, where output expanded only marginally as a result of lower global metal prices as well as violent conflict in some of these countries. In Ethiopia, the

largest agricultural exporter in Sub-Saharan Africa, poultry and fruit production registered sharp increases. In Uganda, increased agricultural production also boosted overall growth. In the Democratic Republic of Congo, the world's largest cobalt producer and a major copper exporter, lower global metal prices and slower growth in domestic metal production contributed to a moderation in activity. Growth in Mozambique picked up as production of liquefied natural gas, coal, and aluminum increased.

While annual consumer price inflation in the median LIC declined in 2023, the progress in achieving disinflation was uneven, with inflation continuing to rise in some countries and remaining in double digits in Ethiopia, The Gambia, Rwanda, and Sierra Leone (figure B.1.2.1.B). In many cases, food price inflation was persistently high (Burundi, Malawi, Sierra Leone, Sudan). High food and energy prices pushed the number of people in LICs facing food security stress or worse circumstances above 400 million in 2022, with some further increase in 2023 (figure B.1.2.1.C). In both the Democratic Republic of Congo and Sudan, more than 20 million people faced high acute food insecurity in August 2023 (FSIN and GNAFC 2023). In some countries, weakening currencies exacerbated inflationary problems (Burundi, Ethiopia, Sudan).

Outlook

Growth in LICs is projected to increase to 5.5 percent this year and 5.6 percent in 2025, up from 3.5 percent in 2023 (figure B.1.2.2.A). The forecasts assume that the conflict in the Middle East does not escalate, that security challenges in a number of LICs improve, that no debt crises emerge, and that inflation pressures continue to decline.

Despite the expected pickup in aggregate LICs growth in 2024, the forecast has been downgraded by 0.5 percentage point, driven by deterioration in the outlook for metal-exporting LICs. Moreover, projections for growth in 2024 in nearly half of the LICs fragile and non-fragile alike—have been revised down. Reflecting weaker commodity prices, 2024 growth forecasts have been downgraded for two-thirds of metalexporting LICs, with downward revisions for the Central African Republic, Democratic Republic of Congo, Mozambique, and Sudan being among the largest.

Growth in fragile LICs is forecast to increase from 3 percent in 2023 to 5.4 percent in 2024 and 5.5 percent in 2025. Growth projections for Sudan have been revised down, as violent conflict has damaged the country's industrial base and education and health


FIGURE B1.2.2 LICs: Outlook and risks



facilities, while remaining unchanged for Burkina Faso and South Sudan. Much of the projected strengthening of growth among fragile LICs is accounted for by the two largest economies in the group-Ethiopia and the Democratic Republic of Congo. Assuming that the Ethiopia-Tigray peace agreement of November 2022 holds, continuing recovery in Ethiopia is expected, driven by growth in investment and a recovery in government consumption. In the Democratic Republic of Congo, growth in mining and metal production is expected to be adversely affected by lower prices, but to remain the main driver of growth, albeit with support from expanding services activity.

Growth in non-fragile LICs is forecast to strengthen to 5.8 percent in 2024 and 6.1 percent in 2025. In Uganda, growth is expected to pick up as monetary policy eases amid waning inflation, and as investment supports tourism, export diversification, and agroindustrialization. Firming growth in Rwanda is expected to benefit from increasing tourism revenues and a pickup in construction associated with the new airport, as well as the country's resilient policy framework (World Bank 2023c).

Per capita income growth in LICs is expected to accelerate from an anemic 0.7 percent in 2023 to 2.7 percent in 2024 and 2.8 percent in 2025. However, in fragile LICs, excluding Ethiopia and the Democratic Republic of Congo-the two most populous LICs-per capita income growth will lag significantly behind the LICs' average. As a result, the average per capita income in this subgroup is expected to remain markedly below pre-pandemic levels through 2025 (figure B.1.2.2.B).

Progress in poverty reduction in many LICs is expected to remain slow, with populations still struggling to cope with high costs of living. After current account deficits widened in 2022, primarily driven by surging import bills caused by higher commodity prices, these deficits did not narrow much in 2023 and are not expected to shrink significantly in the forecast horizon. Although government spending, which increased in 2022 to mitigate the cost-of-living increases, came down in 2023, fiscal deficits are expected to remain elevated over the forecast horizon. Debt-service costs and levels of public debt remain high for many LICs, increasing the likelihood of government defaults in the absence of agreements on debt relief (figure B.1.2.2.C).

Risks

Risks to the baseline forecast remain tilted to the downside, particularly for countries grappling with fragility, and those susceptible to conflicts and adverse weather events. An escalation of the conflict in the Middle East could exacerbate food insecurity across LICs as many of them are highly dependent on food and energy imports. A conflict-induced sustained oil price spike would not only raise food prices by increasing production and transportation costs but could also disrupt supply chains, potentially necessitating stronger efforts by the international community to bolster food supplies to LICs with high rates of malnutrition (World Bank 2023a).

Slower-than-expected growth in China could result in lower commodity prices, negatively impacting metal exporters in particular. If inflation retreats more slowly than currently anticipated, central banks might have to maintain elevated interest rates for longer, heightening the risk of debt crises in some LICs. Gross financing

needs of some LICs have increased substantially since the onset of the pandemic, implying higher risks of debt distress.

Many LICs suffer from fragility stemming from persistent poverty, as well as festering violence and conflict, especially in East Africa and the Sahel (Burkina Faso, Democratic Republic of Congo, Ethiopia, Mali, Somalia, South Sudan, Sudan). While there has been progress with peacemaking efforts in the Democratic Republic of Congo and Ethiopia, there has been increased political instability in several other LICs, with coups d'état in Niger (2023), Burkina Faso (2022), and Chad, Mali, and Sudan (2021). Further violence and conflict would depress growth more severely than in the baseline and result in extended humanitarian crises in these countries that already exhibit an array of macroeconomic vulnerabilities, such as high debt or debt distress, heavy reliance on food or fuel imports, and elevated inflation.

> last June's projections, the forecast for 2023 has been revised up by 0.5 percentage point, mainly reflecting the strength of the U.S. economy, whereas that for 2024 is unchanged, with a sizable upgrade to U.S. growth accompanied by a downward revision to euro area activity. Growth is forecast to pick up slightly to 2.7 percent in 2025, owing mainly to firming advanced-economy activity, as inflation continues to soften and interest rates decline. EMDE growth is projected to be virtually unchanged, at about 3.9 percent a year through 2024-25, with growth in China set to slow while that in other EMDEs picks up. EMDE growth is expected to be supported by a modest firming of export and investment growth (figure 1.11.B). However, it is still expected to be weaker than its average pace over the past two decades, though broadly in line with estimated potential growth.

> While the moderation in commodity prices in 2023 contributed to a decline in global headline inflation, services inflation has proved more persistent, especially in advanced economies, reflecting still-tight labor markets. As such, the easing of advanced-economy policy interest rates will likely proceed at a measured pace, implying a

Economic growth and poverty reduction in LICs could slow markedly if the adverse effects of climate change become more severe. Extreme weather events have already had catastrophic consequences in several LICs, especially in the Sahel region, which is warming faster than the global average and is also particularly susceptible to desertification (World Bank 2022b). Additionally, the current El Niño weather pattern could bring further devastation and increase the incidence of vectorborne and waterborne diseases (WHO and WMO 2023). The number of people facing extreme hunger remains high, especially across Eastern Africa. This situation could worsen if global greenhouse gas emissions continue to rise and LICs with substantial adaptation gaps fail to improve their climate resilience because of inadequate financing and support from the international community.

> continued period of elevated real interest rates. This will be particularly challenging for vulnerable EMDEs with lower sovereign creditworthiness. For most such countries, dollar-denominated bond yields have moved well above nominal GDP growth (in U.S. dollars), squeezing fiscal space (figure 1.11.C).

> Notwithstanding the projected firming of global growth, the outlook remains subdued by historical standards: the forecast for global growth over 2024-25, about 2.5 percent a year on average, is 0.6 percentage point below the 2010-19 average rate. This partly reflects the lingering effects of recent shocks, including the pandemic, the invasion of Ukraine, the sharp increase in inflation, and the associated tightening of global financial conditions. Another contributing factor is the weakening of trade growth, partly attributed to more inward-looking policies. However, the subdued expected pace of global growth also reflects a longer-term downtrend in potential growth. The structural slowdown in EMDEs, and especially in China, is due to several forces: labor force growth has slowed because of demographic shifts; productivity growth has weakened as growth dividends from improvements in health

and education have diminished, and as some EMDEs have moved closer to productivity frontiers; and the pace of capital accumulation has declined, in part as a result of debt overhangs (figure 1.11.D).

Risks to the outlook

Risks to the global growth outlook have become somewhat more balanced since last June, as banking system stress in advanced economies has receded and inflation has declined. Nevertheless, risks remain tilted to the downside. The possibility of an intensification of the conflict in the Middle East represents a major downside risk. This, or rising geopolitical tensions elsewhere, could have adverse impacts through commodity markets, trade and financial linkages, uncertainty, and confidence. Weak growth, elevated debt, and stillhigh interest rates heighten the risk of financial stress, especially in the more vulnerable EMDEs. Higher or more persistent inflation may require a longer-than-assumed period of tight monetary policy. Subdued recent activity in China raises the possibility of slower-than-expected growth, which would have adverse global spillovers. Trade fragmentation and climate-related disasters could also result in weaker growth in the near and longer terms. On the upside, recent surprisingly strong economic activity in the United States, along with declining inflation, points to the possibility that growth may be stronger than projected, perhaps as a result of improved supply conditions.

Conflict and geopolitical risks


Geopolitical risks have increased sharply in the wake of the recent conflict in the Middle East, which comes on top of Russia's invasion of Ukraine (figure 1.12.A). Any escalation of these conflicts could have significant consequences in commodity markets and for economic activity.

While the effects of the conflict in the Middle East on commodity prices have so far been muted, historical precedents suggest that an escalation could lead to significant oil supply disruptions and large spikes in commodity prices, especially if major oil producers became embroiled (figure 1.12.B). At the global level, soaring energy prices could push up inflation, reduce business and


FIGURE 1.10 Per capita income growth

A. Change in per capita income relative to advanced economies since 2019




B. Share of EMDEs with lower GDP per capita in 2024 than in 2019



consumer confidence, and lead to a tightening of financial conditions, dampening investment and overall activity. Indeed, oil price fluctuations have been the predominant driver of global inflation volatility over the last 50 years, especially during the past two decades (Ha et al. 2023).


Heightened uncertainty about the geopolitical environment and conflict outcomes could compound these effects (Caldara et al. 2023). Geopolitical events can prompt a flight to safety in international capital markets, resulting in

> exchange rate depreciations in economies deemed riskier, which can be an important source of inflation in EMDEs (Forbes and Warnock 2012, 2021). Wars can also reduce global supply capacity by diverting international trade and capital flows and disrupting supply chains, including key global shipping routes. Recent attacks on commercial vessels in the Red Sea have prompted the rerouting of much of the freight that usually transits the Suez Canal, lengthening delivery times and increasing costs. These delays

increase the likelihood of inflationary supply bottlenecks, although the extent of this risk will depend on the degree and duration of disruptions, as well as interactions with other supply chain problems such as weather-related capacity reductions in the Panama Canal.

In the regions directly affected-such as the Middle East and Europe and Central Asiaprotracted conflict could severely impact growth and development through many channels. The loss of human life, disabling injuries, and the destruction of capital would directly impair the productive capacity of an economy. More precautionary behavior by consumers and businesses would lower demand substantially. Increased debt-financed military spending may offset these negative demand effects in the short term, but it is likely to sap resources from more productive long-term uses (Caldara and Iacoviello 2022).

A sharper-than-expected slowdown in China would adversely affect global trade as well as commodity and financial markets. The property sector could fail to stabilize if persistent uncertainty holds back prospective buyers, or if mounting financial stress among developers constrain the financing of new projects or force a halt to existing ones. Persistent uncertainty and weak sentiment could hold back household spending and private investment. Against the backdrop of high and rising public and private debt, a sharp slowdown could weaken credit quality and become selfreinforcing, with financial stress exacerbating the challenge of servicing existing debts, generating negative feedback loops to activity.


FIGURE 1.12 Risks to the outlook

The international spillovers of a sharp slowdown in China could be severe. China's importance as an export destination has continued to grow in recent decades, especially for EMDEs (figure 1.12.C). At the same time, China has become a much more important source of demand for commodities, notably energy and metals (figure 1.12.D). More recently, the country has emerged as a major consumer of commodities central to the green energy transition (Baffes and Nagle 2022).

The direct spillovers would be most acute for countries deeply engaged in trade with China particularly those enmeshed in global value chains with China, including many export-oriented economies in the East Asia and Pacific region. In addition, exporters of commodities in Latin America, notably iron ore and copper, would face particularly adverse effects. Weaker activity in China would also weigh on global energy demand and prices, adversely impacting energy exporters.

A slowdown in China could also adversely affect global financial conditions. Although direct linkages between China's economy and global financial markets are limited, the macroeconomic effects of China's credit cycles can drive shifts in investor sentiment. Thus, if the downturn in the real estate sector were to intensify, the resulting increase in non-performing loans could cause domestic lenders to retrench in order to preserve capital and liquidity. The knock-on effects on demand in China and their repercussions could lead market participants to revise global growth expectations down, causing sentiment to weaken and risk aversion to rise, thereby resulting in a tightening of global financial conditions (Ahmed et al. 2019). China's position as a large bilateral creditor to many EMDEs poses a further possible channel for adverse spillovers. Pressure on the balance sheets of domestic lenders could lessen their readiness to extend credit overseas. This, in turn, could exacerbate the already-strained financial positions of some low- and lowermiddle-income countries.


Financial stress


Interest rates in advanced economies have risen markedly over the past couple of years, as central banks have acted to rein in inflation. There have also been occasional surges in long-term bond yields, which have been associated with episodes of financial stress, including instability in U.K. gilt markets in 2022 and the failures of several U.S. banks early last year. These bouts of financial instability were stemmed by timely and extensive policy responses. There remains a risk, however, that renewed increases in market interest rates, or an extended period of elevated real policy rates, could expose latent financial and economic vulnerabilities, precipitating a souring of risk

A. Geopolitical risk index and conflicts





appetite and a sharp tightening of global financial conditions.

There could be several triggers for such an outcome. Monetary easing in advanced economies could be postponed if progress returning inflation to targets were to slow or if labor markets tightened unexpectedly. Alternatively, a negative supply shock, such as a sizable increase in oil prices related to geopolitical developments, could see inflation resurge. Following a lengthy spell of above-target inflation, central banks might judge that surging non-core prices could raise inflation expectations, necessitating tighter monetary


FIGURE 1.13 Risks to the outlook (continued)





A. Average monthly EMDE portfolio

policies. In circumstances like these, heightened uncertainty over the path of policy rates, abetted by expansive government borrowing or quantitative tightening, could prompt sharp increases in term premia, driving bond yields higher (Cohen, Hördahl, and Xia 2018). Estimates of U.S. term premia in 2023 exhibited substantial volatility, which could continue into 2024. Sudden moves in yields could be amplified by the unwinding of the leveraged positions of non-bank financial institutions, including those intended to profit from arbitrage strategies in government bond markets (Avalos and Sushko 2023).

Such developments could drive borrowing rates higher, choke off credit growth, and prompt sharp falls in asset prices. For financial institutions, a sudden and pronounced steepening of the yield curve, driven by a rise in the term premium on long-dated securities, could lead to capital impairment and further exacerbate the credit crunch—a potential outcome made more likely by the lenient regulatory treatment of sovereign risk (BIS 2018). For businesses in interest-sensitive sectors, including commercial real estate, rolling over loans could become challenging. Over time, a rising proportion of households could struggle to service loans, including adjustable-rate mortgages, eroding the quality of bank assets.

EMDEs would be heavily exposed to spillovers from tighter financial conditions caused by higher U.S. interest rates or surging risk aversion. The U.S. dollar would strengthen against EMDE currencies, driving up the cost of servicing dollardenominated debt and likely exerting a near-term drag on EMDE activity, as well as raising inflation (Boz et al. 2020; Greenwood et al. 2020). EMDEs with twin fiscal and current account deficits would be at particular risk of rapid capital outflows, which tend to accompany sudden increases in U.S. term premia (figure 1.13.A). Inflationary pressures associated with weakening currencies could lead EMDE central banks to delay monetary easing, dampening growth further. The number of EMDEs experiencing debt distress could also increase, raising the probability of a new wave of costly sovereign debt defaults. These dynamics could be exacerbated by negative feedback loops generated by the large exposures of many EMDE banking sectors to local government debt (Feyen and Zuccardi 2019).

Trade fragmentation

Increasing trade restrictions, which have become more common in recent years, present another risk of damage to both near- and long-term global growth prospects. Trade restrictions tend to

reduce economic efficiency and often fail to meet their primary objectives because of avoidance efforts. The result may be just a shift in the pattern of interdependence among countries, with increasing indirect linkages through supply chains (Alfaro and Chor 2023; Freund et al. 2023). For instance, following the increases in tariffs imposed by the United States on imports from China in 2018 and 2020, countries that expanded their market shares in the United States also strengthened their trade ties with China. Such tariff increases may therefore not have achieved their primary objective of reducing U.S. economic dependence on China, but they are likely to have led to higher prices of imported goods for U.S. consumers by increasing the length and complexity of supply chains. Other efforts at friendshoring, near-shoring, or on-shoring, motivated by geopolitical tensions, could have similar results.

Survey data, as well as recent foreign direct investment (FDI) announcements, suggest that firms in some advanced economies have been reassessing global value chain exposures and diverting investment to domestic or regional supply chains to reduce vulnerabilities to geopolitical risks and trade policy shocks (figure 1.13.B; Alicke et al. 2022). However, wellfunctioning and diversified global value chains are a source of resilience more than vulnerability, and their unraveling could lead to significant welfare losses (Bonadio et al. 2021; di Giovanni and Levchenko 2009; Javorcik et al. 2022).

Global trade growth could also be dampened by other policies, including increases in subsidies for domestic industries in large economies. Over the longer term, the greater fragmentation of investment and trade networks could weaken potential growth by limiting cross-border technological diffusion, reducing efficiency, and raising prices (Branstetter, Glennon, and Jensen 2018; Buera and Oberfield 2020; Góes and Bekkers 2022).

More frequent natural disasters with worsening impacts

The possibility of increasingly frequent and severe natural disasters resulting from climate change poses a global threat, with the potential to generate significant losses in lives, livelihoods, and output (Casey, Fried, and Goode 2023). Natural disasters, including those linked to climate change, impacted 130 million people and caused more than 40,000 deaths annually, on average, over the past three decades (Song, Hochman, and Timilsina 2023). Climate change-related disasters have caused severe damage to private and public infrastructure, disrupted output, and reduced productivity (Dieppe, Kilic Celik, and Okou 2020; Hallegatte, Jooste, and McIsaac 2022).

The adverse effects of climate change and natural disasters on growth could be amplified by limited fiscal capacity to respond to them, or through their impact on public sector balance sheets (Milivojevic 2023). Natural disasters could also pose risks to the stability of banking sectors by compromising loan collateral and triggering increases in non-performing loans (Nie, Regelink, and Wang 2023). At the same time, the financial sector faces balance sheet risks from the green transition, such as from stranded assets in high-carbon sectors.

Climate change-related natural disasters will likely affect different countries to different extents, depending on their geography and their economic structures. Relative to advanced economies, EMDEs have less capacity to respond to these disasters, while intensive urbanization in some EMDEs may increase vulnerability to such hazards as floods (Rentschler et al. 2022). Moreover, the impacts of natural disasters are likely to be uneven across populations and to increase poverty (Hallegatte and Rozenberg 2017; Jafino et al. 2020).

Climate change and the associated increase in natural disasters can exacerbate poverty through several channels. For example, changing environmental conditions that worsen the spread of disease may result in deteriorating health outcomes for low-income households, including increased prevalence of child stunting (figure 1.13.C). Adverse effects on agricultural yields could also raise food prices, which is especially problematic for poorer households that spend a large share of their income on food. In some countries, poor and vulnerable populations live in informal settlements or may lack access to adequate housing, leaving them more vulnerable to the impacts of extreme weather events, other natural disasters, and associated diseases (Dodman, Archer, and Satterthwaite 2019). Climate change-related and other natural disasters could also disproportionately affect agricultural workers in many EMDEs and increase food insecurity in regions with large numbers of subsistence farmers who lack the resources to maintain consumption in the face of crop failures (Khanal et al. 2021).

Upside risk: Stronger growth in the United States

Growth in the United States proved more resilient than expected in 2023, with unemployment remaining low, despite the sharpest monetary policy tightening in decades. At the same time, inflation continued to retreat from mid-2022 peaks, partly on account of waning energy and food prices, as well as some moderation in core inflation. These developments-resilient growth, low unemployment, and easing inflation-rarely coincide and represent a break from the generally negative historical relationship between labor market slack and inflation (Hazell et al. 2022). The disinflation is likely attributable to a combination of positive supply developments, including a rebuilding of global supply chains and a gradual post-pandemic recovery in labor supply, and anchored inflation expectations. In addition, a post-pandemic shift of demand, from goods back to services, is likely to have contributed to disinflation in goods prices, with services inflation slower to react.

Looking ahead, further positive developments on the supply side, including continuing increases in labor force participation and efficiency gains in global supply chains, could lift productivity growth (Fernald and Li 2023). This could lead to higher U.S. output growth than projected in the baseline, combined with continued disinflation. The reduction in labor supply caused by the early retirement of older workers during the pandemic has been almost fully offset by increased participation by the prime working-age population (figure 1.13.D). A continuation of this trend would help further boost labor supply and employment; it could be prompted by abundant job opportunities, a continued recovery in immigration, past wage increases, or depleted savings.

In these conditions, continued employment gains would help support household incomes, while the increased supply of labor, along with productivity gains, would help contain increases in firms' labor costs. Relative to the baseline projection, such a supply gain would allow declining core inflation to be coupled with solid economic growth in the United States, while facilitating the maintenance of healthy household balance sheets. This would generate positive trade spillovers across EMDEs. The impact on global financial conditions would likely also be positive, as prospects for improved growth, lower inflation, and faster easing of U.S. monetary policy would buoy investor risk appetite.

Growth outcomes under alternative scenarios

If any of the risks discussed above were to materialize, it could likely lead to different growth outcomes from baseline projections. Using a global macroeconomic model, the growth implications of three downside risk scenarios are examined—an increase in oil prices due to a rise in geopolitical tensions, financial stress in EMDEs driven by a reassessment of risk in the context of elevated debt and high borrowing costs, and weaker growth in China because of an intensification of strains in the real estate sector.¹ In addition, one upside scenario is considered, centered on a continuation of robust growth in the United States driven by rising labor supply.²

Higher oil prices. In the baseline forecast, oil prices are assumed to decline gradually in 2024 and 2025. An alternative scenario envisages oil


prices surging 30 percent above the baseline in the first quarter of 2024 (and 20 percent on average in 2024), driven by disruptions in crude oil supply arising from an escalation of conflict in the Middle East or elsewhere. The initial 30 percent increase is calibrated to mimic price changes seen during similar past episodes (World Bank 2023a). After the first quarter of 2024, oil prices are assumed to gradually return to the baseline. As a result of the jump in oil prices, global consumer price inflation increases by 0.8 percentage point relative to the baseline in 2024, before easing in 2025. Rising gasoline prices reduce real household incomes, while higher input costs drive businesses to curtail investment.³ As a result, global growth in 2024 is 0.2 percentage point below the baseline. A partial recovery from the oil shock takes hold in 2025, with growth 0.1 percentage point above the baseline (figure 1.14.A).

Financial stress in EMDEs. In 2023, financial markets remained generally sanguine about debtrelated risks in most EMDEs, despite broadly elevated debt levels and rising advanced-economy bond yields. However, investor risk perceptions, and thus their risk appetite, could deteriorate suddenly, as a result of a wide range of factors. These include the continued buildup of EMDE debt in the context of high global real interest rates, or a surge in term premia on bonds, driven by large fiscal funding requirements in some advanced economies. Such a decline in risk appetite could become self-reinforcing, as currency depreciations and capital outflows put pressure on EMDE balance sheets.

In an EMDE financial stress scenario, spreads on sovereign and corporate debt in EMDEs are assumed to increase by 100-150 basis points in the first quarter of 2024 relative to baseline assumptions, with more vulnerable EMDEs experiencing larger increases. This shock dissipates over the forecast horizon, with spreads gradually returning to baseline levels. As a result, growth in EMDEs in 2024 is 0.6 percentage point below the baseline, as consumers and businesses reduce spending, and global growth is 0.2 percentage point below the

baseline (figure 1.14.B). Advanced economies are initially not significantly affected by the decline in EMDE activity because of the offsetting positive impact of lower commodity prices on domestic demand, but this mitigating factor fades in 2025. Inflation in EMDEs is little changed, with the disinflationary effect of weaker domestic demand offset by the inflationary impact of depreciating currencies. In advanced economies, inflation is reduced significantly in 2024, compared with the baseline, partly on account of weaker commodity prices and appreciating currencies.

Weaker growth in China. In the baseline forecast, output in China is projected to grow by 4.5 percent in 2024 and 4.3 percent in 2025.

However, these projections are subject to various downside risks. An alternative scenario envisages China's real estate sector slowing more sharply than expected, with a corresponding decrease in household spending relative to the baseline. The more pronounced slowdown could be driven by tighter credit conditions and weaker confidence. As a result, growth in China is reduced by 1 percentage point in 2024, before recovering in 2025. Other EMDEs are affected by weaker demand from China, particularly for commodities, as well as by increased financial volatility. Thus, aggregate EMDE growth in 2024 is reduced by 0.5 percentage point below the baseline, and global growth by 0.2 percentage point below the baseline, before a rebound in 2025, reflecting the recovery in China (figure 1.14.C).

Stronger growth in the United States. The baseline projects that growth in the United States moderates in 2024, partly because some of the supply factors supporting robust growth last year are expected to diminish. Given the possibility of a sustained increase in labor force participation and resilient labor productivity, an alternative scenario is constructed in which the labor force participation rate continues to increase by 0.1 percentage point per quarter-the average pace seen between the fourth quarter of 2020 and the third quarter of 2023-to above pre-pandemic levels. The additional job seekers are absorbed into the labor market with little change in the unemployment rate relative to the baseline. The strong employment growth supports household incomes and spending, raising U.S. growth by 0.5 percentage point in 2024, and 0.7 percentage point in 2025, relative to the baseline. Stronger U.S. activity generates positive spillovers, boosting growth in EMDEs by 0.2 percentage point in 2024. The increase in growth in EMDEs in 2025 is smaller, as monetary policy is adjusted in response to higher demand and inflation.

In all, global growth is 0.2 percentage point higher in 2024 and 0.3 percentage point higher in 2025 than in the baseline (figure 1.14.D). Global inflation is 0.4 percentage point higher in 2024 compared with the baseline, as a result of higher commodity prices and increased activity, before it retreats toward baseline projections in 2025. U.S. inflation rises by approximately 0.5 percentage point in 2024 above the baseline, before declining in line with lower commodity prices. The Federal Reserve's response to higher inflation is muted given that core prices remain broadly unaffected. Although this leads to no additional increases in U.S. policy rates, the easing path over 2024 is more gradual than in the baseline.

Policy challenges

Policy makers around the world are facing enormous challenges, many of which pose exacting trade-offs. Global policy efforts are needed to address debt challenges and climate change, and to support populations affected by food insecurity. Boosting international trade is also a key priority given increasing signs of fragmentation and the use of restrictive measures. EMDE policy makers need to strike a difficult balance between ensuring fiscal sustainability and support providing targeted to vulnerable households, while addressing wide investment gaps. This challenge has become harder given weakened fiscal capacity amid higher public debt, increasing debt-servicing costs, and foregone revenues from the persistence of pandemic-related tax cuts. Tight monetary policy or rising bond yields in advanced economies may force EMDEs to delay monetary easing in order to prevent capital outflows and currency pressures. To meet development goals and bolster long-term growth prospects, policy actions to strengthen investment growth are needed.

Key global challenges


FIGURE 1.15 Global policy challenges

Elevated debt. High debt, weak growth, and elevated interest rates pose considerable challenges for many EMDEs, especially the poorest countries, given the resulting increase in debtservicing burdens (figure 1.15.A). Currently, 13 LICs and 23 middle-income countries have fallen into, or are at high risk of, debt distress. Several countries have entered debt restructuring in the past year, but progress toward adequate resolution has been slow in many cases. The international community needs to pre-emptively address developing risks to avoid the economic costs of debt crises. Crucially, the debt restructuring and relief process, particularly the G20 Common Framework, needs to be adapted to the changing sovereign debt landscape characterized by more diverse creditors and more complex debt instruments. Greater concessional lending enabled in part by easier access—and more grants are also needed.

Climate change. Bolstering global efforts to address climate change is another critical development challenge. Progress by countries that pledged to cut their greenhouse gas emissions under the 2015 Paris Agreement has fallen short, with vast gaps remaining between the actions needed and those that have been planned and executed (United Nations 2023). Decarbonizing the global economy will require sizable investments and finance-climate finance must increase at least five-fold annually over 2023-50 to contain climate change and avoid its worse effects-at a time when investment growth is set to remain weak (figure 1.15.B; chapter 3; Buchner et al. 2023; World Bank 2022c). Globally, fossil fuel subsidies were 40 percent higher than global investment in climate finance between 2011 and 2020 (Naran et al. 2022). Cutting fossil fuel subsidies can free up significant resources and alleviate the trade-off between financing climate change goals and investing in other longer-term development needs. Moreover, repurposing fossil fuel subsidies toward incentivizing greener production could potentially reduce emissions and pollution while enhancing productivity (Damania et al. 2023).


Upper-middle-income and high-income countries account for nearly three-fourths of greenhouse gas emissions per capita (figure 1.15.C). At the same time, the adverse effects of climate change and natural disasters are disproportionately impacting the poorest, with 40 percent of people affected by disasters living in LICs (Neunuebel 2023). The most vulnerable economies, including LICs and small island developing states, are particularly exposed to droughts, floods, heat waves, rising sea levels, and storms, and often lack the resources to confront these challenges, especially given other pressing development needs (Jafino et al. 2020; Kenworthy, Kirby, and Vorisek 2023). Financing from higher-income economies and the mobilization of private capital will accordingly be needed.


A. Government net interest payments in EMDEs

B. Global investment growth






C. Net greenhouse gas emissions per capita in 2019, by country income group



Decarbonization will require well-targeted regulations that can encourage steps to boost energy efficiency and advance greener technologies (OECD 2023a). As the energy transition will entail substantial redeployments of workers and reallocations of capital from emission-intensive to greener activities, structural reforms and fiscal measures will be needed to reduce labor market


FIGURE 1.16 EMDE monetary policy challenges



> frictions and ameliorate uneven distributional impacts across sectors and populations. Sectors such as the mining of fossil fuels and fossil-fuelintensive industries will face the highest costs of the energy transition, and workers in these sectors lacking the skills needed in greener activities will be at the greatest risk of job losses (OECD 2023a). Cushioning vulnerable groups could increase public support for climate changemitigation policies (Dechezleprêtre et al. 2022).

Introducing carbon pricing instruments and reducing fuel subsidies could not only help to reduce the carbon intensity of growth but also provide governments with room for transfer payments to vulnerable households (World Bank 2023d).

Trade fragmentation. Boosting international trade is another key priority, especially in light of its anemic growth last year and subdued near-term outlook amid the increasing use of restrictions and other signs of fragmentation. Disruptions to global value chains, whether from geopolitical conflict or trade policy restrictions, can lead to significant welfare losses globally. The largest such potential losses are estimated to be in lower-income regions, due to reduced technology spillovers (Eppinger et al. 2021; Góes and Bekker 2022). To guard against the fragmentation of trade and investment networks, the rules-based international order needs to be bolstered, including through improved multilateral cooperation and the expansion of trade agreements. This can be complemented by policies that lower trade costs, encourage the diversification of trade partners and inputs, and attract capital and FDI flows. Such measures include streamlining border procedures with the help of digital technologies and easing other constraints on trade flows, such as uncompetitive logistics sectors. Countries can also invest in modernizing trade information systems, strengthening contract enforcement and addressing market distortions, facilitating trade finance, and promoting competitiveness.

Food insecurity. Food price inflation remains elevated, worsening food insecurity and increasing the number of people affected by hunger in many EMDEs, including in FCS economies (figure 1.15.D). Between 691 million and 783 million people are estimated to have gone hungry globally in 2022-122 million more than in 2019effectively erasing progress made since 2015 (FAO 2023b). The global community can help address food insecurity by avoiding imposing export restrictions, offering technical assistance to strengthen agricultural food systems, and through targeted social protection and cash transfers to poor and vulnerable households. Governments can also shift their focus from costly agricultural

subsidies toward measures that sustainably support agricultural producers, such as additional investments in research and development to boost agricultural productivity (World Bank et al. 2023).

Challenges in emerging market and developing economies

EMDE monetary and financial policy challenges

Global monetary policy tightening is nearing an end, with inflation continuing to decline and the share of EMDEs with above-target inflation falling sharply in recent months (figure 1.16.A). A number of EMDE central banks-some of which were the first, globally, to raise rates in 2021have already cut policy rates and more are expected to do so in the coming months. In contrast, policy rates are likely to decline more slowly in advanced economies, potentially leading to narrowing differentials between interest rates in advanced economies and EMDEs. In real terms, the policy rate in the United States is already close to parity with the average rate in EMDEs excluding China (on a GDP-weighted basis; figure 1.16.B).

A further shift in real interest rate differentials in favor of advanced economies could increase the risk of EMDE capital outflows, currency depreciations, and resulting surges in inflation (figure 1.16.C). Moreover, a renewed rise in U.S. yields could induce conditions similar to the 2013 "taper tantrum," spurring sudden increases in risk premia and rapid portfolio outflows from EMDEs (Arteta et al. 2015; Sahay et al. 2014). Indeed, there was a marked deterioration in EMDE portfolio flows in September-October last year, when U.S. term premia and longer-term yields increased sharply.

EMDE policy makers can mitigate such risks by indicating their readiness to tighten monetary policy again in response to signs of upward pressure on inflation, including from currency depreciation. This could help keep inflation expectations anchored (figure 1.16.D). More broadly, transparent communication by EMDE monetary authorities, combined with clear and decisive commitment to price stability, can buttress the credibility of their monetary frameworks, thereby lessening long-term inflation pressures (Ha, Kose, and Ohnsorge 2019). In addition, EMDEs can act to conserve or replenish foreign currency reserves, including by demonstrating commitment to policies that boost investor confidence and attract foreign capital.

Heightened volatility in global financial markets could increase liquidity and solvency risks in EMDE financial sectors. In banking sectors, currency and maturity mismatches between assets and liabilities need to be monitored, with prompt action taken to manage emerging issues. The concentration of held-to-maturity securities on the balance sheets of some EMDE banks merits scrutiny, given that carrying values are not marked to market. Highly leveraged non-bank corporations in EMDEs are also vulnerable to rising interest rates (Koh and Yu 2020). Timely and transparent reporting of nonperforming loans is therefore crucial for effective monitoring of banking sector health. Over the medium term, frameworks to address potential banking sector stress in EMDEs could be improved. For example, liquidity requirements could be refined to better address foreign currency liquidity and to ensure assets deemed liquid are of sufficiently high quality (IMF 2023a).

EMDE fiscal policy challenges

Fiscal space in EMDEs remains limited, with median government debt worth 53 percent of GDP in 2023 and debt-to-GDP ratios above prepandemic decade averages in more than two-thirds of EMDEs (figure 1.17.A). High debt levels undermine fiscal sustainability, thereby eroding investor sentiment and increasing financing costs. They therefore reduce the effectiveness, as well as the feasibility, of fiscal stimulus measures (figure 1.17.B). The number of EMDEs in sovereign debt distress has risen to its highest level since 2000 (Ohnsorge and Pallan 2023). Past debt defaults suggest that more than one-third of these countries failed to durably reduce their debt or borrowing costs after a default. With global real interest rates expected to remain high, EMDE governments need to prioritize policies that boost growth and safeguard fiscal sustainability.

FIGURE 1.17 EMDE fiscal policy challenges









The combination of weak growth, high government debt, and elevated interest rates has contributed to a sharp increase in net interest payments as a share of government revenues in EMDEs. Moreover, the persistence of pandemicrelated measures, such as tax cuts, has reduced revenues, compounding the challenges of revenue mobilization for many EMDEs, including LICs (figure 1.17.C). Such measures risk becoming permanent, absent a return to fiscal rules and sunset clauses. Weakened revenue collection also limits the potential redistributive power of taxation and the financing available for social protection systems, thus hindering poverty reduction (Lopez-Acevedo et al. 2023). The erosion of revenue capacity is a particular concern in LICs, where about 10 percent of revenue is spent on servicing external debt and governments are already severely constrained in meeting key development goals (Chuku et al. 2023).

Policy makers face a difficult trade-off between ensuring fiscal sustainability and providing targeted support to vulnerable households. Improving the efficiency of spending can help balance these competing priorities. In most EMDEs, the efficiency of spending on infrastructure, health, and education is lower than in advanced economies (figure 1.17.D; Herrera et al., forthcoming). Spending efficiency in EMDEs with limited fiscal space can be improved by strengthening institutions and governance, bolstering fiscal and public financial management, and improving the effectiveness of fiscal rules and expenditure reviews. Such measures can also support the effective management of debt, especially if complemented with policies that strengthen transparency and legal frameworks (IMF 2023b). Enhancing revenue mobilization is also crucial. Without it, efforts to shore up debt sustainability may be at the expense of critical spending, such as investment in infrastructure and human capital, as has often been the case in EMDEs. Protecting such public investment, while eliminating wasteful spending, is crucial given the projected slowdown in overall investment growth alongside large development needs (chapter 3).

Over the longer term, the trade-off between promoting fiscal sustainability and meeting

development needs can be mitigated by marketoriented reforms that both support growth and strengthen fiscal positions by lifting revenues, attracting foreign capital, and lowering borrowing costs. Such reforms can include reductions in barriers to firm entry and trade, measures to bolster financial supervision, and regulatory frameworks that promote competition and contain monopoly power (Aligishiev et al. 2023).

Fiscal space will also be needed to ease the tradeoff between responding to climate change challenges and financing other development needs. EMDEs can balance these priorities both by raising revenues through carbon pricing instruments, which have been implemented or scheduled in 14 EMDEs, and by reducing fossil fuel subsidies, which cost 5.6 percent of GDP in EMDEs excluding China in 2022 (Carbon Pricing IEA database). Dashboard; Countries can reprioritize spending on fuel subsidies toward measures that help accelerate the green transition, including by boosting public investment and research and development on low-carbon electricity generation, transport, and technologies.

Commodity-exporting EMDEs face unique fiscal challenges, stemming both from the need to cope with large fluctuations in commodity prices and from the effects of the projected slowdown in China's demand for commodities, notably metals. Declines in commodity prices can trigger procyclical cuts in public expenditures due to reduced revenues, while rising commodity prices can lead to procyclical increases in public spending. As a result, fiscal policy in commodity exporters tends to be more procyclical than in non-commodity exporters, often amplifying the impact of commodity price cycles on economic growth and hence the business cycle (chapter 4; figure 1.17.E). Associated with this issue, fiscal policy tends to be generally more volatile in commodity exporters, adding to the volatility of their economies and thus damaging longer-term growth (figure 1.17.F).

Sustainable, well designed, strong, and stabilityoriented fiscal frameworks, such as fiscal rules and sovereign wealth funds, along with strong institutions, can help countries build buffers during commodity price booms to prepare for subsequent slumps. In addition, medium-term expenditure frameworks are vital for strengthening fiscal space, reducing fiscal policy volatility, and supporting countercyclical fiscal policy.

EMDE structural policy challenges

EMDEs face the difficult challenge of boosting investment to close significant development gaps in an environment of weak growth prospects and limited fiscal resources. Decarbonization alone will require a significant scaling up of investment, combined with structural reforms to promote the green transition. Shoring up food security is also critical, especially given growing trade restrictions. In some countries, closing gender gaps in labor markets could help offset demographic headwinds and bolster longer-term growth prospects.

Accelerating investment

Continuing a decade of weakness prior to the pandemic, the growth of fixed investment in EMDEs in 2023-24 is expected to average 4.1 percent per year, just over half the average pace over 2000-19. The broad-based investment slowdown has exacerbated large unmet investment needs in many EMDEs (Rozenberg and Fay 2019; World Bank 2022c). Substantial public investment is needed for countries to adapt to, and help contain, climate change; accelerate the digital transition; improve social outcomes; and support long-term growth. At the same time, tight financial conditions, heightened uncertainty, and, in some cases, limited access to international capital markets, continue to weigh on public and business investment, curbing capital deepening and job creation. Given constrained fiscal space for additional public investment and the challenging macroeconomic environment for private investment, there is a clear need for policies that encourage a sustained acceleration of investment in EMDEs (chapter 3).

Investment acceleration episodes have been associated with higher growth, boosted not only by rapid capital accumulation but also by increased growth of employment and productivity, the latter being supported by sectoral shifts of resources facilitated by greater investment (figure







1.18.A). These episodes have also been frequently accompanied by a range of other economic improvements, such as strengthened fiscal positions, enhanced credit growth, increased trade openness, and greater progress with poverty reduction.

Country case studies of investment accelerations suggest that a wide-ranging package of policies

that both ensures macroeconomic stability and promotes private-sector development (for instance, Malaysia in the mid-2000s and India since the 1990s) is more likely to trigger investment accelerations. Empirical cross-country evidence also suggests that improvements in economic policy—such as the strengthening of fiscal positions, the adoption of inflation targeting, and reforms to promote trade and financial integration—have been important drivers of investment growth accelerations, particularly when combined with well-functioning institutions (figure 1.18.B).

Confronting food insecurity

Food security has deteriorated in recent years, with about 30 percent of the global population facing moderate or severe food insecurity in 2022, up from 25 percent in 2019. Factors contributing to this rise in food insecurity include geopolitical conflict, more adverse weather patterns intensified by climate change, and proliferating food-related trade restrictions (figure 1.18.C). Russia's invasion of Ukraine and the reduction of Ukrainian export capacity, including through the destruction of agricultural land and facilities and the partial blockage of the country's exports, has curtailed an important source of grain supply (Mottaleb, Kruseman, and Snapp 2022). An escalation of the conflict in the Middle East, and the associated disruptions in energy supply and ensuing surge in energy prices, could also substantially exacerbate food insecurity by raising food production costs (World Bank 2023a).

Measures to increase agricultural yields and improve food supply chains in EMDEs could bolster economic resilience while adding to global food supplies. Such policies can include investments in infrastructure to better transport perishables and withstand extreme weather; improvements in market competitiveness, including by reducing barriers to entry; and reforms to formalize and secure land rights, which can incentivize efficient land use and improve access to finance (FAO et al. 2023; Laborde, Lakatos, and Martin 2019; van Berkum 2021). Countries can also improve food security by boosting the technical knowledge of, and advisory services to, those employed in the agriculture sector, including to better monitor weather and

flood risks; by enhancing financial support to farmers to cover imports of inputs for planting season; and by encouraging investment in climatesmart technology for agricultural production (Gautam et al. 2022). Repurposing support for fertilizer use could not only free up resources to address food security issues but also support greener production, given that fertilizer is a contributor to nitrogen pollution (Chatterjee et al. 2022; Damania et al. 2023; Ding et al. 2021).

Closing gender gaps in the labor market

Improving gender parity in labor markets remains a major challenge, particularly across EMDEs. Barriers to female labor force participation include mismatches in skills; lack of access to child or elderly care; discrimination in hiring and retention; and restrictive policies, laws, and social norms. Globally, average female labor force participation in 2011-22 was 50 percent, compared with 70 percent for men, and the gender participation gap in EMDEs was slightly wider, at 23 percentage points.

The pandemic has resulted in persistent adverse effects in the labor market, particularly for women and vulnerable groups such as the young, lowwage workers, and workers with fewer years of education—a common outcome following large external shocks (Lopez-Acevedo and Robertson 2023). As a result, there has been a widening of gender gaps in labor force participation, and to a greater extent in EMDEs than in advanced economies (figure 1.18.D; WEF 2023). In many EMDEs, women also continue to face higher unemployment rates, lower wages, and more limited access to managerial positions (ILO 2023). While female employment in EMDEs has recovered since the pandemic recession of 2020, it remains lower compared with men, and four-fifths of the jobs created for women in 2022 were in the informal economy compared with two-thirds for men (ILO 2023). Since informal sector jobs tend to be lower paid and less secure, and to provide fewer opportunities for advancement, policies are needed to strengthen inclusion in formal employment (OECD 2023b).

Gender parity in the labor market is particularly lacking in the Middle East and North Africa and South Asia, where female labor force participation is about one-half the EMDE average. If measures were taken in these two regions to gradually raise female participation to the EMDE average by the end of this decade, potential growth in the period could be boosted by about 1.2 percentage points per year (Kose and Ohnsorge 2023). These gains could be amplified by the provision of more and higher-quality education for women. In other regions, particularly East Asia and Pacific and Europe and Central Asia, increasing female labor participation could partly offset the slowing of labor force growth owing to population aging. Female labor force participation can be encouraged by social protection measures that provide adequate social safety nets, access to education, and support for childcare and job re-entry programs. Such policies can be supplemented by investments in safe transport; measures to broaden access to finance, inputs, and markets; information campaigns to address restrictive social norms; and legislative and regulatory changes (Bussolo et al. 2022; World Bank 2022d).

CHAPTER 2

REGIONAL OUTLOOKS

EAST ASIA and PACIFIC



Growth in the East Asia and Pacific (EAP) region is projected to slow to 4.5 percent in 2024 and to 4.4 percent in 2025, from an estimated 5.1 percent in 2023, mostly owing to an anticipated deceleration in economic activity in China. Amid protracted property sector weakness, growth in China is expected to decline from 5.2 percent in 2023 to 4.5 percent in 2024 and 4.3 percent in 2025. In the rest of the region, growth is projected to edge up from an estimated 4.4 percent in 2023 to 4.7 percent in 2024 and 2025, underpinned by solid domestic demand. Risks to the outlook are skewed to the downside and include a more severe downturn in China, with adverse spillovers to the broader region, and heightened geopolitical tensions—including those from the conflict in the Middle East—which could spur higher energy and food prices and inflation. Weaker-than-expected global demand and trade, as well as climate-change-related extreme weather events, pose further downside risks.

Recent developments

Growth in the EAP region rebounded to an estimated 5.1 percent in 2023, mainly reflecting a short-lived activity surge in China early in the year following from the reopening pandemic restrictions (figure 2.1.1.A). In China, the reopening effects faded fast, resulting in a 0.4 percentage point downgrade to estimated growth in 2023 compared with the June forecast. Investment growth in the country was weighed down by continued weakness in the real estate sector, with property developers facing renewed financial pressure amid declining sales and prices (figures 2.1.1.B and 2.1.1.C). Feeble external demand weighed on exports, and while consumption firmed somewhat toward the end of the year, consumer confidence remained well below pre-pandemic levels (figure 2.1.1.D).


FIGURE 2.1.2 EAP excluding China: Recent developments

In EAP excluding China, growth eased to an estimated 4.4 percent in 2023, as declining international goods trade weighed on activity (figures 2.1.2.A and 2.1.2.B). This was 0.4 percentage point lower than previously projected, partly reflecting spillovers from the surprisingly weak growth in China. In several large economies,

falling goods exports through much of 2023 were partly offset by firming services exports, buoyed by the continued recovery in international tourism. In most economies, goods trade weakness was also offset by robust household consumption, which in many cases continued to be supported by buoyant labor market conditions and cooling inflation.


In 2023, the combined Pacific Island economic output is estimated to have finally exceeded prepandemic levels. However, this recovery is not uniform across the subregion, particularly for those economies dependent on tourism, like Palau and Samoa, where recessions were most severe and recoveries slowest. In contrast, in East Asia, output remains below pre-pandemic levels only in Myanmar, reflecting the effects of ongoing conflict and political disruption.


Headline consumer price inflation fell through much of 2023 in most of the region's economies, supported by moderating commodity prices (figure 2.1.2.C). In China, falling food prices and weak demand put further downward pressure on inflation, which was barely positive in the second half of the year. In many economies, headline and core inflation toward the end of the year hovered at about or below central bank targets amid moderate demand pressures, with regulated prices in some cases helping to offset higher oil prices in the second half of the year.

FIGURE 2.1.1 China: Recent developments


Growth in China rebounded in early 2023 following the lifting of pandemic restrictions but slowed through the middle of the year. Slowing growth in 2023 partly reflected a renewed downturn in the property sector, including further declines in sales and prices, which contributed to increased financial stress for developers. Meanwhile, consumer confidence remained weak.

Monetary policy actions across the region diverged somewhat in the second half of 2023. Interest rates were hiked further in Indonesia, the Philippines, and Thailand, reflecting varying factors including currency depreciation in the face of U.S. dollar strength, inflationary pressures and, in the case of Thailand, policy normalization following a period of low interest rates. In Malaysia and Viet Nam, rates were held steady, while in China, weak activity prompted cuts to interest rates and required reserve ratios; in tandem, downpayment requirements for property purchases were lowered to stimulate real estate demand. Easing monetary policy in China widened interest rate spreads with advanced economies, which, together with subdued domestic activity and sentiment, contributed to a

decline in net capital inflows to the country and further depreciation of the renminbi (figure 2.1.2.D). Elsewhere in the region, net capital inflows were generally more resilient, sustained by firmer domestic activity.

Outlook

Growth in EAP is forecast to decelerate to 4.5 percent in 2024 and to 4.4 percent in 2025, largely reflecting slower growth in China (figure 2.1.3.A). In EAP excluding China, growth is projected to edge up to a solid 4.7 percent in 2024 and 2025, with a more pronounced uptick in Pacific Island economies this year, reflecting continued tourism recoveries (figure 2.1.3.B). Compared with previous projections, growth in EAP is expected to be 0.1 percentage point lower in 2024 and 2025. The projection downgrades mean that EAP output is now expected to fall even further below its pre-pandemic trend over the forecast horizon.

In China, growth is projected to slow to 4.5 percent in 2024, and further to 4.3 percent in 2025. Compared with the June forecasts, growth has been revised down by 0.1 percentage point in 2024 and 2025, primarily as a result of somewhat weaker domestic demand. Consumption is envisaged to slacken sharply amid weak sentiment and heightened economic uncertainty. Investment growth is expected to remain subdued, supported by infrastructure spending but hobbled by continued property sector weakness, after construction starts last year fell to their lowest level since 2006 (figure 2.1.3.C). Over the projection horizon, structural headwinds from rising indebtedness, an aging and shrinking workforce, and narrowing room for productivity catch-up growth are expected to weigh on economic activity (World Bank and DRC 2022).

Elsewhere in the region, solid domestic demand, particularly private consumption, is expected to be the main driver of growth. Modest inflation, and in many cases robust labor markets supported by buoyant services activity, are anticipated to sustain household spending. In some economies, increased government spending, including on social protection and public sector wages, will also support demand. Investment growth is projected to be more subdued, falling short of pre-pandemic averages in most economies through 2024 and 2025. This reflects various headwinds facing private investment, including the lagged effects of monetary policy tightening, policy uncertaintyassociated in some countries with government transitions-and rising indebtedness (World Bank 2023a). Elevated public debt and reduced fiscal space are envisaged to constrain public investment growth.

Trade growth is projected to pick up modestly in the near term, supported by a recovery in global trade. Export growth is expected to remain sluggish, falling short of both output growth and pre-pandemic trend rates. Given the high share of intermediate inputs in the region's trade, particularly relating to manufactured goods, weak goods exports are anticipated to also weigh on imports. This will be compounded by soft domestic demand in China, where continued property sector weakness is expected to weigh on global commodities demand, with adverse spillovers to the region's commodity exporters. In contrast, international tourism in the region is envisaged to largely recover from the pandemic in 2024, supported by a continued revival in outbound tourism from China. This will support services exports, particularly in tourism-reliant economies like Cambodia and Thailand.

Headline consumer price inflation is expected to slow slightly in most EAP countries in 2024, aided by moderating global commodity prices, improved food supplies, and well-anchored inflation expectations. However, in some economies, including the Lao People's Democratic Republic, Mongolia, and several Pacific Island states, inflation is expected to remain elevated, reflecting various country-specific factors. These include exchange rate weakness and associated higher import prices, and robust growth. In China, following a temporary decline in food prices, inflation is anticipated to edge up slightly but remain subdued amid weak demand.

With interest rates higher than a year ago in some cases, the lagged effects of monetary policy tightening since 2022 will continue to weigh on economic activity in the near term (figure 2.1.3.D). Despite inflation receding below target

In the East Asia and Pacific region, excluding China, growth mostly slowed in 2023, dampened by shrinking goods exports amid weak global demand. In most economies in the region, headline inflation fell markedly. Capital inflows to China receded, reflecting weak sentiment and activity, as well as widening interest rate spreads with respect to advanced economies. Nevertheless, capital inflows proved more resilient elsewhere in the region.



in many economies, interest rates are expected to remain broadly unchanged in 2024 on account of tight monetary policy in major advanced economies, lingering concerns about weakening exchange rates and capital outflows, and the potential for a resurgence in inflation. With little expected change in nominal interest rates, easing inflation will raise real interest rates through 2024, dampening demand. Moreover, in China, the effectiveness of recent monetary policy easing is likely to remain blunted by high debt, depressed sentiment, and weak credit demand.

In many economies in the region, amid solid government consumption but constrained public

investment, fiscal policy will overall exert a neutral influence on activity through 2024 and 2025. In China, fiscal policy will provide some demand support, including from a pickup in infrastructure spending in the second half of 2023. However, weakened revenues, mounting debt, and financial pressures will continue to constrain local government spending efforts (World Bank 2023b).

Risks

Risks to the baseline growth forecast for the region are tilted to the downside and focus on weakerthan-expected growth in China and heightened geopolitical tensions. The conflict in the Middle East could escalate, increasing uncertainty and disrupting energy supply. Other downside risks include prolonged global trade weakness, tighterthan-expected financial conditions, and damaging climate-change-related extreme weather events. Elevated uncertainty or persistent trade weakness could lead to sustained sluggishness in investment growth and harm potential output growth in the region, which is already expected to soften (Kose and Ohnsorge 2023). In contrast, stronger-thanexpected growth in the United States poses an upside risk to the forecast.

China could experience a worse-than-expected property sector downturn, with large and protracted falls in prices and activity (chapter 1). Such a scenario would not only lead to a decrease in household wealth but also amplify financial stress on developers, their creditors, and suppliers. Additionally, it could undermine broader demand and squeeze local government revenue. From their peak in mid-2021, existing property prices have fallen by about 6 percent nationally-a smaller decrease and over a shorter period compared to past major property market corrections in other large economies. Protracted weak consumer sentiment, triggered by additional property sector turmoil or broader uncertainty, could spur precautionary saving, dampening consumption growth. Heightened uncertainty could also erode business sentiment, weakening investment and labor market conditions, while high debt and slower growth could lead to a deterioration in credit quality and increased financial pressures.


FIGURE 2.1.4 EAP: Risks

Given the strong trade links between China and other economies in the region, slower-thanexpected growth in China would have negative spillovers to demand and activity across EAP (figure 2.1.4.A). Slower manufacturing growth in China would depress regional processing trade, particularly in economies with large integrated export sectors such as Malaysia and Viet Nam (World Bank 2022a). Commodity exporters in the region, including Indonesia, Mongolia, Myanmar, and the Solomon Islands, would endure reduced Weaker discretionary demand and prices. household spending in China would also spill over to the region, including through dampened demand for international travel, curtailing the tourism recovery in some of the region's economies, including Cambodia and Thailand. Rising global tensions and trade protectionism, could also dampen trade growth, with adverse effects on domestic activity.


An escalation in the conflict in the Middle East also represents a significant downside risk to the outlook. EAP's economies, being generally exportoriented and in many cases dependent on imported energy, particularly petroleum, are especially vulnerable to heightened geopolitical tensions and global energy supply disruptions (figure 2.1.4.B). Escalating conflict in oilexporting countries in the Middle East or elsewhere could disrupt oil supply, spurring sharp increases in prices for energy and food. This could have broader adverse knock-on effects for prices, stoke inflation, and prompt renewed monetary policy tightening, which could dampen growth.


Global financial conditions could also become tighter than assumed in the baseline, which would weigh on activity and increase risks of financial stress. Borrowing costs could rise if persistently elevated inflation prompts major central banks to pursue tighter-than-expected monetary policy. This would further depress external demand and weaken exports of EAP economies. It would also add downward pressure on exchange rates in the region, making it more difficult for central banks to ease monetary policy to support economic activity. Additionally, the mounting debt levels observed in many EAP economies, with China being a notable example though not the only one, heightens vulnerability to higher borrowing costs (figure 2.1.4.C).

Extreme weather events, the frequency of which has increased in recent decades as a result of climate change, also pose a downside risk to the regional outlook (figure 2.1.4.D). Pacific Island economies are particularly exposed to extreme weather events, notably highly damaging and frequent tropical storms. However, extreme weather events also present a serious threat to larger economies, recently underscored by damaging heatwaves and floods in China, and a cyclone and floods in Myanmar (World Bank 2022b).

A dependence on imported petroleum in many EAP economies exposes them to higher oil prices from escalating conflict in the Middle East, which could disrupt global oil supply. Rising debt leaves the region vulnerable to unexpected tighter financial conditions, while more frequent climate-change-related extreme weather events present further downside risks to the outlook.

On the upside, growth in the United States was stronger than expected last year, with resilient labor markets underpinning robust consumption in the face of significant monetary policy tightening. While China's share of exports for most EAP economies has increased markedly in recent decades, the United States remains a key export market for many. Unexpectedly strong growth in the United States would lift external demand in the EAP region, supporting faster exports and output growth.

EUROPE and CENTRAL ASIA

Growth in Europe and Central Asia (ECA) is expected to moderate to 2.4 percent this year, and then firm to 2.7 percent in 2025, supported by strengthening domestic demand and a gradual recovery in the euro area. In the near term, persistently high inflation will prevent a rapid easing of monetary policy in most economies and weigh on private consumption. Projected fiscal consolidation further dampens the outlook. Downside risks continue to predominate. An escalation of the conflict in the Middle East could increase energy prices, tighten financial conditions, and negatively affect confidence. Geopolitical risks in the region, including an escalation of the Russian Federation's invasion of Ukraine, are elevated and could materialize. Higher-than-anticipated inflation or a weaker-than-expected recovery in the euro area would also negatively affect regional activity.

Recent developments


FIGURE 2.2.1 ECA: Recent developments

Growth in Europe and Central Asia (ECA) is estimated to have picked up to 2.7 percent in 2023 from 1.2 percent in 2022. This recovery primarily reflects firming private consumption, supported by additional fiscal support, robust labor market conditions, and the resumption of growth in Russia and Ukraine. The 1.3 percentage point upward revision from the June 2023 forecast is mainly due to upgrades for these two countries and Türkiye. Excluding them, growth in ECA in 2023 markedly decelerated, to an estimated 1.8 percent, with particularly weak outcomes in Central Europe. Manufacturing activity remained subdued in the second half of the year, while retail sales continued to soften (figure 2.2.1.A).

In Russia, output expanded by an estimated 2.6 percent in 2023. This stronger-than-expected recovery was fueled by substantial fiscal support, including additional military spending. Oil production and exports contracted modestly, and the authorities announced end-2023 an extension of the export curbs of 300,000 barrels per day as well as a deepening by 200,000 barrels per day starting in January 2024. Exchange rate depreciation led to an inflation uptick, prompting

subsequent increases in the policy interest rate. Migration from Central Asia to Russia increased after the invasion, with 43 percent of all entrants migrating for work purposes in 2023 (figure 2.2.1.B).

Growth in Türkiye moderated to an estimated 4.2 percent in 2023. Following the May elections, there were significant hikes in the policy interest rate, from 8.5 percent in May to 42.5 percent in December 2023. Additionally, regulatory changes slowed credit expansion, which started to weigh on growth. Nonetheless, activity expanded more than previously anticipated, thanks to resilient private consumption and substantial post-earthquake fiscal outlays. Inflation exceeded 60 percent in the second half of 2023.

In Ukraine, growth expanded by an estimated 4.8 percent in 2023, following the preceding year's steep contraction. Nonetheless, output remained about 30 percent lower in 2023 than its preinvasion level (figure 2.2.1.C). Growth was underpinned by improved electricity access, a better harvest, and additional government spending, albeit at the cost of increasing fiscal and current account deficits. While the unraveling of the Black Sea Grain Initiative in July 2023 continues to exert downward pressure on grain exports, Ukraine has successfully identified alternative routes for grain exports that have supported the sector.

High-frequency indicators suggest only modest growth in major ECA economies. Following the Russian Federation's invasion of Ukraine, more migrants from Central Asia have entered Russia for work purposes. Ukraine's GDP has declined by about 30 percent since the beginning of the invasion. Tight monetary policies have weighed on regional activity, but several countries have initiated policy interest rates cuts.


A. High-frequency indicators for major economies




B. Migration from Central Asia to the Russian Federation, by purpose

Elsewhere in the region, weak external demand from the euro area affected economic activity, especially in Central Europe and the Western Balkans. Remittance flows to ECA supported demand in remittance-intensive countries such as Armenia, Kyrgyz Republic, and Tajikistan. In 2023, remittances declined by 1.4 percent in the region, after an increase of 18.5 percent in 2022, which was a record-high year (World Bank 2023c). Fiscal consolidation efforts were limited due to increasing public sector wages, indexed social benefits, and rising interest payments (World Bank 2023d). Median headline inflation in the region slowed to 5.4 percent in November, alongside easing energy and food price pressures. Amid subdued activity, policy interest rates have likely peaked in many economies, with several central banks, including Poland, starting to lower rates (figure 2.2.1.D). However, Russia and Türkiye embarked on a tightening cycle.

Outlook


FIGURE 2.2.2 ECA: Outlook

Economic activity in ECA is projected to moderate to 2.4 percent this year and then firm to 2.7 percent in 2025. The main drivers of growth include private consumption supported by reduced inflationary pressures, and exports boosted by a gradual recovery in the euro area. The 0.3 percentage point downward revision for ECA in 2024 primarily reflects a forecast downgrade in Türkiye due to further monetary policy tightening (figure 2.2.2.A). Uncertainty surrounding the evolution of Russia's invasion of Ukraine plays an important role in shaping the regional outlook. Excluding these two economies, growth in the region is expected to accelerate to 3.1 percent this year and to 3.7 percent in 2025.

Most ECA countries are likely to continue easing monetary policy, as inflation is projected to decline. However, core inflation exceeds the headline inflation, which remains above the targets in most countries. Fiscal consolidation is projected to gather pace in half of the economies in 2024.

Growth in Russia is projected to slow to 1.3 percent in 2024, and then to 0.9 percent in 2025, near its potential rate. Tightening monetary policy is expected to dampen domestic demand. Trade diversion to China, India, and Türkiye is evident for both exports and imports (figure 2.2.2.B). However, for products affected by sanctions in response to the invasion, the increase in imports from China only offsets about a quarter of the decrease in imports from the European Union (EU) in 2022 (Grekou, Mignon, and Ragot 2023). Capacity constraints, including tight labor market conditions and scarcity of domestic labor due to the invasion, will continue to restrict growth.

Growth in Türkiye is forecast to moderate to 3.1 percent in 2024 before picking up to 3.9 percent in 2025. The outlook considers further monetary policy tightening and gradual fiscal consolidation. It also assumes improving financial stability, rising net exports, larger support for exporters, and rebalancing in economic activity. While inflation is expected to remain elevated in the first half of 2024, it is anticipated to gradually ease off starting in the second half of the year, alleviating the negative impact on private consumption.

In Ukraine, the outlook remains highly uncertain. Growth is projected to be 3.2 percent in 2024 and 6.5 percent in 2025. Active hostilities are expected to continue throughout 2024, with base effects and one-off factors including agricultural harvest which should fade. A partial resolution of uncertainty in 2025 would facilitate a resumption of exports and a gradual increase in reconstruction investment.

In Central Europe, the expansion is set to accelerate to 2.8 percent in 2024 and 3.5 percent in 2025. The outlook reflects firming external demand from the euro area, improving domestic demand on the back of a recovery in real wages, and the absorption of EU funds through the Recovery and Resilience Facility.

In the Western Balkans, output is anticipated to rebound by 3 percent in 2024 and 3.5 percent in 2025. Economic activity in the subregion is expected to be underpinned by firming consumption as inflationary pressures ease, a gradual recovery in the euro area, increasing public spending on EU infrastructure projects, and a continuing but slower demand in tourism earnings. Labor markets will continue to be tight and fiscal space will remain limited due to rigidities in non-discretionary spending, such as pensions and wages (World Bank 2023e).

In South Caucasus, growth is projected to hold steady at 3.3 percent a year over 2024-25. While further unwinding in money transfer inflows from Russia is expected, re-exports and tourism will continue to support economic activity. However, long-term growth will remain hampered by commodity dependence, weaknesses in connectivi-




B. Change in exports to Central Asia and the Russian Federation from 2019 to 2023

ty and logistics, and possible continuing geopolitical tensions between Armenia and Azerbaijan.

Growth in Central Asia is forecasted to be broadly stable at about 4.8 percent a year over 2024-25, the highest among subregions. Still-high commodity prices, resilient consumer spending amid cooling inflation, and sustained export growth benefiting from rising oil production capacity in Kazakhstan, are expected to support the activity. Trade diversion triggered by the invasion, leading to increased exports to the region from countries that have reduced their exports to Russia, is expected to persist (figure 2.2.2.B). The flow of remittances from Russia will wind down but remain well above pre-invasion levels.

Regional growth is projected to remain below its pre-pandemic trend, reflecting the lingering effects of the pandemic and Russia's invasion of Ukraine. The pace of income per capita convergence in ECA is expected to remain sluggish, with average income per capita reaching 24 percent of the EU level in 2025 (figure 2.2.2.C). Average income per capita is expected to remain the highest in Central Europe, reaching 41 percent of the EU level in 2025.

Accelerated progress on gender equality could deliver faster and more inclusive growth. Although the ECA region, on average, exhibits a lower gender gap than other EMDE regions, countries in Central Asia and Türkiye still face gender inequality and labor gender gaps. Fast-tracking gender-related reforms could enhance human capital accumulation (figure 2.2.2.D; World Bank 2023f). These reforms involve improving access to quality childcare and safe transport for women, mitigating the double burden of domestic and professional work, and reducing pressure to adhere to traditional gender roles.

Risks

Risks to the baseline forecast remain tilted to the downside. The ongoing conflict in the Middle East, especially if prolonged or spread, could negatively impact the region (World Bank 2023g). A resurgence in energy prices, particularly European natural gas, would make reducing inflation more challenging, while potential benefits would be limited to energy-exporting economies like Russia and countries in Central Asia. Additionally, elevated uncertainty could tighten financial conditions, hampering investment and consumption.


FIGURE 2.2.3 ECA: Risks

Geopolitical tensions continue to pose downside risks. The year-to-October number of political violence events and demonstrations in the region almost trebled between 2021 and 2023, concentrated especially in Russia and Ukraine (figure 2.2.3.A). Intensifying tensions and conflicts could worsen already-heavy human and economic losses. Other geopolitical strains—such as tensions between Armenia and Azerbaijan and between Kosovo and Serbia —could re-emerge. The high number of presidential, parliamentary, and local elections in 2024 also increases uncertainty about future economic policies.

More persistent inflation than currently envisaged could keep monetary policies tighter for longer and weigh on activity. Most of the countries are not likely to reach their inflation targets by the end of 2024 (figure 2.2.3.B). A wage-price spiral in the Western Balkans, Central Europe, and Türkiye, or higher-than-projected commodity prices-potentially driven by an escalation of the conflict in the Middle East-could fuel such inflation. External vulnerabilities are significant in the region, with almost three-fourths of ECA countries having external debt levels exceeding the EMDEs median level in 2022 (figure 2.2.3.C). If global financial conditions tighten, this could trigger capital outflows and increase borrowing costs. Financial stability risks may arise in Central Asia due to underdeveloped banking systems and increasing credit risk. Delayed impacts of sanctions in response to the Russia's invasion of Ukraine could result in higher costs for international payment settlements in the Kyrgyz Republic and Tajikistan.


Weaker-than-expected growth in the euro area, the region's main trading partner, would adversely impact ECA via trade channels. Central Europe, the South Caucasus, and the Western Balkans would be particularly affected, given that half of their goods exports, on average, are destined for the euro area. Increasing trade restrictions could also push further trade fragmentation. Additionally, a more significant slowdown in China or a sharper-than-expected reduction in remittances from Russia would represent external headwinds to Central Asia and the South Caucasus.


Further delays in the disbursement of EU funds pose another downside risk for Central Europe, as do delays in reforms tied to EU accession in the Western Balkans. Concerns about governance have hindered disbursements from the EU to Poland, while political instability has affected Bulgaria (World Bank, forthcoming). In contrast, disbursements to other Central European countries have proceeded, following progress in the implementation of the Recovery and Resilience Facility in the categories of smart, sustainable, and inclusive growth and health, economic, social, and institutional resilience (figure 2.2.3.D).

An ambitious implementation of structural reforms poses an upside risk to the growth outlook. The simultaneous implementation of a large set of reforms (market competition and regulation, taxation, skills, labor market, research and development) among EU's member states could yield substantial GDP gains for Bulgaria and Romania (Pfeiffer, Varga, and in't Veld 2023). Additionally, the EU's new growth plan for the Western Balkans allocates six billion euros in non-repayable support and loans to advance economic integration with the European Union's single market and the Common Regional Market, as well as to accelerate fundamental reforms. Strengthening institutions, especially in Central Asia, would create conditions for promoting investment growth (chapter 3). Reducing the state's presence could increase productivity and financial performance. The green transition would be facilitated through reforms improving the investment climate, encouraging financial sector development, and reducing the carbon footprint of financial flows. The energy sector requires a profound transformation to achieve the net-zero emissions target by 2050, potentially strengthening growth and sustainability (World Bank 2023h, 2023i).

B. Gaps between inflation and expected inflation, versus inflation targets






LATIN AMERICA and THE CARIBBEAN

Growth in Latin America and the Caribbean is forecast to edge up from 2.2 percent last year to 2.3 percent in 2024 and then to 2.5 percent in 2025. The drag on economic activity from earlier monetary policy tightening is expected to diminish throughout 2024. Additionally, the expected further easing in policy rates amid moderating inflation is set to bolster growth in 2025. Though commodity prices fell last year, they remain at levels that still support economic activity. Improved prospects among major trading partners will also contribute to growth. Most large regional economies are expected to expand at about their potential rate. Risks to the forecast are tilted to the downside. The conflict in the Middle East could result in higher energy prices, which could alter expected monetary policy paths. In addition, tighter global financial conditions could weigh on private demand and accelerate fiscal consolidation in the region. Extreme El Niño weather events related to climate change pose another downside risk.

Recent developments

Growth in Latin America and the Caribbean (LAC) slowed to an estimated 2.2 percent in 2023—about half the growth rate of 2022. In many economies, elevated inflation, tight financial conditions, weak trade, and adverse weather events dampened investment and output growth.

Regional growth in 2023 was 0.7 percentage point higher than previous projections, largely due to upward revisions in the growth forecasts for LAC's two largest economies—Brazil and Mexico. In Brazil, the upward revision to growth in 2023 was mostly due to better-than-expected outturns in agricultural production, private consumption, and exports in the first three quarters of the year. In Mexico, both private consumption and investment growth were stronger than previously envisaged. In contrast, growth was weaker than expected in other large LAC economies, including Argentina, Colombia, and Peru, with recent business surveys pointing to weakening confidence and manufacturing activity (figures 2.3.1.A-C).

Inflation in the region has generally continued to ease, with Argentina being an important exception. Headline consumer price inflation has recently fallen close to targets of most central banks, in part reflecting moderating energy prices. Core inflation has also continued to moderate but remains slightly above headline inflation (figure 2.3.1.D). Additionally, indicators of inflation expectations have declined in recent months, except in Argentina and Peru. The deceleration in core inflation in most of the region likely reflects the early monetary tightening measures initiated in 2021. As a result, real interest rates have risen over the past year as inflation has fallen.

Outlook


Growth in LAC is projected to increase slightly in 2024, to 2.3 percent, before firming further to 2.5 percent in 2025. The lagged effects of past monetary tightening will continue to weigh on near-term growth, but with diminishing potency. With inflation in the region anticipated to continue slowing, converging to national targets by late 2024, central banks are expected to continue reducing rates (figure 2.3.2.B). As monetary policy eases, investment growth is expected to pick up in 2024 and 2025. However, fiscal policy is not projected to support growth during this period (figure 2.3.2.A).

The upward revision to LAC's growth forecast in 2024 reflects stronger external demand due to

improved U.S. growth expectations, as well as higher-then-expected government spending. The downgrade to China's growth is anticipated to have limited effects on commodity prices, and therefore is not projected to substantially affect LAC. More broadly, commodity price changes over the forecast period are expected to be modest, and not a major driver of regional growth.

Brazil's economy is forecast to grow 1.5 percent in 2024, about half the estimated pace in 2023. The expected decrease in GDP growth reflects both carry-over from the slowdown in the second half of last year and moderating agricultural harvests in

2024. However, a gradual decrease in both headline and core inflation should allow further interest rate cuts, supporting medium-term investment prospects and consumption. Accordingly, output is forecast to increase by 2.2 percent in 2025, even as fiscal support is constrained by the authorities' aim to achieve a primary surplus.

Growth in Mexico is expected to ease to 2.6 percent in 2024 and 2.1 percent in 2025, down from 3.6 percent in 2023. While inflation has fallen, it remains above the central bank's target range. Policy rate cuts are likely to progress gradually, with real interest rates remaining elevated, albeit on a downward path. The anticipated slowdown in activity in 2024 partly reflects a weakening external environment, mitigated to some degree by increased public investment and fiscal transfers for social programs. Investment is expected to continue to perform well amid increasing nearshoring by firms.

Argentina's economy is projected to rebound, expanding 2.7 percent in 2024 and 3.2 percent in 2025. The pickup reflects a recovery from the drought in 2023, which caused a decline in the country's major commodity exports—maize and soybeans—worth almost 3 percent of GDP. The country is nonetheless facing significant economic and policy uncertainty amid high inflation and steep currency depreciation, which continues to erode consumer confidence. Annual inflation has recently surpassed 150 percent, with no signs of easing. There is also little leeway for fiscal spending to support activity, as the government seeks to address pressing fiscal sustainability issues.

Colombia's growth is expected to increase from 1.2 percent in 2023 to 1.8 percent in 2024 and 3 percent in 2025, close to the economy's potential growth rate. The central bank is expected to cut interest rates later than its regional peers in the face of persistent inflation. As a result, private consumption and investment growth are not expected to gather pace until 2025.

Chile's economy is forecast to expand by 1.8 percent in 2024, after contracting an estimated 0.4 percent in 2023. Growth is expected to further increase to 2.3 percent in 2025. Falling core and headline inflation should allow interest rates to be

lowered over the forecast period, gradually unwinding the central bank's restrictive monetary policy stance. The drag on Chile's growth from weak external conditions is also expected to ease as demand for commodities related to green energy continues to expand.


Growth in Peru is projected to rebound to 2.5 percent in 2024 and 2.3 percent in 2025, after contracting 0.4 percent in 2023. Expanding output from major copper mines is expected to contribute to stronger activity. In addition, with inflation on a downward path, further reductions in policy interest rates are likely to support growth over the forecast period. However, political uncertainty continues to affect consumer and business confidence and hinder investment projects. Although the price of copper is expected to decline modestly in 2024, increased mining production will still contribute to overall export growth.

The Caribbean economies are expected to grow 7.6 percent in 2024 and 5.4 percent in 2025, after expanding 4.6 percent in 2023. Excluding Guyana, which remains in a resource-based boom since the discovery of oil in 2015, the region's growth is expected to accelerate to 4.1 percent in 2024 and 3.9 percent in 2025. However, prospects are uneven across the sub-region. The Dominican Republic is forecast to grow by 5.1 percent in 2024 and 5 percent in 2025, amid structural reforms to attract FDI. In contrast, under an optimistic scenario, Haiti's growth is expected to recover slowly, reaching only 1.3 percent in 2024 and 2.2 percent in 2025, following five years of economic contraction. The postpandemic recovery of tourism in the subregion is incomplete and is expected to continue driving growth (figure 2.3.2.C; Maloney et al. 2023). Remittances into the Caribbean are also expected to continue increasing, albeit at a slower pace (World Bank 2023c).

Growth in Central America is expected to remain broadly steady, at 3.7 percent in 2024 and 3.8 percent in 2025, after an estimated 4.1 percent pace in 2023. As in the Caribbean, moderate remittance growth (except for Costa Rica and Panama) is expected to support activity in 2024.

FIGURE 2.3.2 LAC: Outlook

Given limited fiscal space, fiscal policy in LAC is generally not expected to support growth over the next two years. At the same time, with core inflation easing across the region, policy rates are expected to be cut over the forecast horizon. Tourism continues to recover toward pre-pandemic levels. Potential output growth in the region is estimated to be lower for the remainder of this decade.




Inflation in Central America has eased but remains high, particularly for food. Within the subregion, growth projections differ. Panama's economy is forecast to expand by 4.6 percent this year, reflecting strong services exports and despite recent shocks from protests, lower copper exports, and the impact of El Niño, while Costa Rica is expected to grow 3.9 percent as domestic demand eases. El Salvador, however, will grow at a more

FIGURE 2.3.3 LAC: Risks

> modest 2.3 percent amid slower consumption growth.

Potential economic growth in LAC in 2011-21 is estimated to have declined significantly from the preceding decade (figure 2.3.2.D). Over the remainder of the 2020s, growth of both total factor productivity and the labor force are expected to slow further (Kose and Ohnsorge 2023). In part, this reflects the long-term negative effects of the pandemic, particularly on human capital. Weak potential growth prospects remain a major challenge for the region over the medium term.

Risks to the baseline forecast are tilted to the downside (chapter 1). An escalation of the conflict in the Middle East could disrupt energy markets, sending oil prices soaring. Persistent core inflation in advanced economies could lead to higher-thanexpected global interest rates and tighter financial conditions, constraining monetary and fiscal policies in LAC. Spillovers from a worse-thanprojected slowdown in China could weigh heavily on growth in South America's commodity exporters. Meanwhile, the ongoing El Niño weather pattern heightens the risk of climaterelated disruptions and disasters.

The conflict in the Middle East has heightened geopolitical risks globally, with potentially serious implications for commodity markets and growth in LAC. In particular, any further escalation of the conflict that leads to substantial energy market disruptions could send oil prices soaring, dampening confidence and reversing recent disinflation trends in the region (World Bank 2023g). The inflationary effects of rising oil prices would likely be exacerbated by accompanying increases in prices for other energy commodities and fertilizers. Rising inflation could induce central banks in LAC to hold policy rates at levels higher than previously assumed. Falling real incomes and higher borrowing costs could lead to weaker consumption and investment.

Even in the absence of a renewed supply shock, persistent core inflation in advanced economies could result in more restrictive monetary policies than currently priced into financial markets. Consequently, growth in advanced economies could slow more than projected, potentially impacting the prices of commodities exported by LAC (figure 2.3.3.A; Arteta, Kamin, and Ruch 2022). The U.S. dollar is likely to strengthen, with concomitant depreciations of LAC currencies, and hence renewed upward pressure on inflation in the region. This could prompt monetary authorities in LAC to pause interest rate cuts. On the fiscal side, given the context of elevated government debt, the fiscal balances of most LAC economies are insufficient for ensuring debt sustainability (figure 2.3.3.B). Financial stress and high interest rates would exacerbate fiscal challenges by increasing

the cost of debt service. This could force governments in LAC to tighten fiscal policy more quickly than currently envisioned, dampening demand.

Growth in China is forecast to slow in 2024-25. Should China's growth prove weaker than projected, there could be substantial external demand spillovers to LAC. In particular, weaker growth of construction and manufacturing in China would translate into softer demand for LAC's key industrial commodity exports, particularly metals. This represents a significant vulnerability for several economies in the region, but particularly to Chile and Peru. Weaker terms of trade would likely result slower income and consumption growth in these economies (figure 2.3.3.C).

Extreme weather events, partly related to climate change, pose an ever-present risk, especially to climate-sensitive sectors like agriculture, energy, and fishing. Climate change can strengthen disruptive El Niño effects, including heavy rains and droughts (figure 2.3.3.D; Cai et al. 2015; Wang et al. 2019). Should weather-related natural disasters intensify in LAC in the coming years, the production of food and other primary goods could be disrupted (Jafino et al. 2020). This, in turn, could affect not only growth, but also the conduct of monetary policy authorities in the region. The adverse effects of disasters on growth would likely be most serious in the region's poorer countries, which tend to have less resilient infrastructure.

MIDDLE EAST and NORTH AFRICA

The ongoing conflict in the Middle East has heightened uncertainty and geopolitical risks in the Middle East and North Africa (MNA) region. Assuming the conflict does not escalate, growth in the region is forecast to reach 3.5 percent in 2024 and 2025—which is stronger than previously envisioned—as oil-exporting economies benefit from the unwinding of oil production cuts. In contrast, the outlook for oil-importing economies has deteriorated on account of weakening domestic conditions, including persistently high inflation. Risks to the outlook are tilted to the downside. Owing to the possibility of escalation in the conflict, potential benefits to oil exporters from higher oil prices, resulting from disruptions in commodity markets, would likely be more than offset by weakened regional activity. Other downside risks include climate-change-related weather shocks and adverse spillovers from further monetary policy tightening in advanced economies and tighter financial conditions.

Recent developments

The ongoing conflict has increased geopolitical and policy uncertainty, disrupted financial markets, and damaged investor confidence in MNA (figure 2.4.1.A). It has also dampened tourism-related activity, particularly in neighboring countries. International tourist arrivals in these countries slowed down in late 2023, following robust activity prior to the onset of the conflict. MNA already faced multiple headwinds, including oil production cuts, elevated inflation, and weak private sector activity in oil-importing economies. Accordingly, growth in MNA is estimated to have slowed sharply in 2023, to 1.9 percent, after reaching 5.8 percent in the previous year.

In MNA's oil exporters, while non-oil sector activity was robust, the oil sector weakened markedly as a result of oil production cuts, which dampened growth. Growth in oil importers also slowed somewhat last year, reflecting anemic private sector activity (figure 2.4.1.B).

Oil production in MNA declined in 2023, mainly driven by production cuts in member countries of the Gulf Cooperation Council (GCC), especially Saudi Arabia, which announced the extension of its voluntary oil production cut until early 2024 (figure 2.4.1.C). Member countries of the Organization of the Petroleum Exporting Countries Plus (OPEC+) also agreed in April on the production cut until the end of 2023. In contrast, oil supply from other economies in the region increased, including the Islamic Republic of Iran, which was exempted from the OPEC+ agreement.


Growth in GCC countries is estimated to have decelerated sharply in 2023 because of the decline in oil production, which more than offset robust non-oil activity driven by strong labor markets, moderating inflation, and supportive fiscal policies. In Saudi Arabia, output is estimated to have fallen by 0.5 percent in 2023, as the contraction in oil activity and exports was dampened somewhat by strong private consumption and public investment. Similarly, Bahrain, Kuwait, Oman, Qatar, and the United Arab Emirates also experienced a downturn in 2023.

In other oil exporters, growth picked up in the Islamic Republic of Iran, as increases in oil production and exports more than offset weak external non-oil demand. In Libya, which was also exempted from the OPEC+ production cut agreement, growth rebounded, as industrial



FIGURE 2.4.1 MNA: Recent developments


The onset of the recent conflict in the Middle East disrupted financial markets in the region, raising geopolitical and policy uncertainty. Activity in the private sector remained robust among oil exporters, led by non-oil activity, while activity in oil importers was subdued. Oil production has declined in line with announced production cuts, particularly in GCC countries. In some oil importers, elevated inflation was accompanied by significant depreciation of their currencies.

> activity was strengthened by oil production, which was unaffected by September's flooding. In contrast, activity in Algeria and Iraq was adversely affected by oil production cuts and declining exports.

> In oil-importing economies, growth softened amid elevated macroeconomic imbalances and vulnerabilities. In the Arab Republic of Egypt,

growth is estimated to have slowed to 3.8 percent in fiscal year (FY) 2022/23. Import restrictions constrained access to inputs for domestic production and exports, while declining purchasing power of households and sluggish corporate activity weighed on investment and private consumption. In contrast, growth is estimated to have picked up in Morocco, despite the earthquake in September that caused major humanitarian losses and infrastructure damage. The agricultural sector recovered following a severe drought in 2022.

Inflation was well-contained in GCC countries by late 2023, while it remained elevated in other oil exporters, notably the Islamic Republic of Iran, as well as in some oil importers, despite the decline in oil prices in 2023. In oil importers, food price inflation remained stubbornly high, and elevated headline inflation was often driven by large currency depreciations (figure 2.4.1.D). Consequently, monetary policy was tightened in oil importers; in contrast, policy rates stabilized in GCC countries in late 2023.

Outlook

The conflict in the Middle East has heightened uncertainty around growth forecasts in the region. Assuming the conflict does not escalate, growth in MNA is expected to pick up to 3.5 percent in 2024 and 2025-0.2 and 0.5 percentage point higher, respectively, than previously projected (figure 2.4.2.A; table 2.4.1). These upward revisions assume improved economic performance among oil exporters, driven by a stronger rebound in oil activity and export growth, following deeper production cuts in 2023 than previously expected. In contrast, the outlook for oil importers appears weaker than previously expected, owing to the adverse impact of the ongoing conflict, including that on tourism, and slower growth in private consumption and investment, as a result of higher inflation and input costs.

Growth in GCC countries is forecast to rise to 3.6 percent in 2024 and 3.8 percent in 2025. In Saudi Arabia, growth is projected to rebound to 4.1 percent in 2024 and 4.2 percent in 2025 (table 2.4.2). The country's oil output and exports are

expected to expand, despite an extension of voluntary oil production cuts for early this year. As part of the government's Saudi Vision 2030, investment related to non-oil activity will also be a major driver of growth going forward. An increase in oil production will help boost growth in other GCC countries.

Among other oil exporters, growth is expected to pick up in Algeria and Iraq but to slow in the Islamic Republic of Iran and Libya. In Algeria and Iraq, the expansion of oil production as a result of relaxed production cuts in early 2024 is projected to contribute to faster growth. In contrast, in the Islamic Republic of Iran and Libya, growth is forecast to moderate as oil production stabilizes.


In oil importers, growth is expected to edge up to 3.2 percent this year and 3.7 percent in 2025. In Morocco, the strengthening of growth will be bolstered by a continued recovery in agriculture, an expected rebound in tourism despite the recent earthquake, which is expected to have limited macroeconomic consequences, and fiscal support through the government's reconstruction plan.

In Tunisia, growth is expected to rise to 3 percent in both 2024 and 2025, conditional on the easing of drought conditions and a decrease in inflation. In Djibouti, investment in several large infrastructure projects is expected to boost growth, with increased use of the country's port services by Ethiopia being another positive factor.


In contrast, in Egypt, growth is expected to slow to 3.5 percent in FY2023/24 (July 2023 to June 2024), before rising to 3.9 percent in FY2024/25. The conflict in the Middle East will likely exacerbate the inflation problem, eroding households' purchasing power and constraining activity in the private sector, and intensify pressures on external accounts through implications on tourism, remittances, and oil trade balance. In Jordan, household income growth may be constrained by weak private sector job creation, while the tourism sector will be adversely affected by the conflict in the Middle East. Growth in the Republic of Yemen is expected to be tepid on account of weak governance, political instability, and conflict.

FIGURE 2.4.2 MNA: Outlook



B. Fiscal balances




C. GDP forecasts for oil importers




The outlook for West Bank and Gaza is highly uncertain but growth is projected to shrink 6 percent in 2024 after contracting 3.7 percent in 2023. Massive destruction of fixed assets and industrial facilities in Gaza, which represents roughly 16 percent of output in West Bank and Gaza, will cause a significant contraction of economic activity. The ongoing conflict will also exacerbate already-dire economic conditions in West Bank. Heightened restrictions on the free movement of goods and people between and within cities, including access to the Israeli market, will continue to have negative effects on trade and output. Assuming the situation around the conflict cools down, the reconstruction efforts

The escalation of the recent conflict in the Middle East could cause further damages in growth potential, as historically conflicts in the region have been associated with a huge decline in productivity. The number of refugees in the region has continued to increase, particularly in fragile countries. Deaths from natural disasters, including earthquakes and floods, increased substantially last year. > are expected to contribute to a rebound of growth to 5.4 percent in 2025.

> Fiscal deficits are expected to widen in 2024 in MNA, with a notable deterioration in the fiscal positions of oil importers (figure 2.4.2.B). In oil exporters, fiscal surpluses in 2023 will shrink to almost zero, on average, but with diverging trends in GCC and non-GCC oil exporters. Recoveries in oil production are expected to support the improvement of fiscal balances in several GCC

countries, while deficits are projected to widen in some non-GCC oil exporters, as expenditures are likely to outpace revenues. In oil importers, fiscal deficits are expected to widen in 2024, partly reflecting weak revenue, rising debt-service costs, and rising subsidies related to food and energy. In West Bank and Gaza, fiscal deficits are expected to increase significantly in 2024, owing to a decline in both domestically managed tax instruments and the "clearance revenues" transferred from Israel. Additionally, in 2025, the deficits are likely to grow further as a result of expansionary fiscal policy aimed at aiding the recovery from the conflict.

Projected growth in oil importers will be insufficient to return output to its pre-pandemic trend. Output losses relative to the pre-pandemic projections will increase over the forecast period (figure 2.4.2.C). In addition to the ongoing conflict, subdued growth in oil importers-and in some cases persistently high inflation-will also limit progress in reducing poverty and inequality. After experiencing a surge in poverty in 2023, oil importers will likely see elevated poverty rates in the near term (figure 2.4.2.D).

Risks

A severe downside risk to the baseline growth forecast is the intensification of the ongoing conflict. The escalation of the conflict could result in an increase in energy prices and benefit energy exporters, but this would be more than offset by weakened activity due to a surge in geopolitical tensions in the region. Natural disasters, including climate-change-related weather events, and adverse spillovers from tighter global financial conditions pose further downside risks.

A substantial escalation of the conflict would have significant implications for growth prospects in MNA and increase forecast uncertainty (Gatti et al. 2022). Economies directly affected could see significant declines in investment and productivity growth owing to damage to infrastructure and human losses (figure 2.4.3.A; Dieppe, Kilic Celic, and Okou 2020). Adverse impacts of an escalation of the conflict could spill over into neighboring economies. It could increase uncertainty and

dampen investor confidence, reduce tourism, cause capital outflows and instability in financial markets, weigh on investment growth, and subsequently weaken prospects for output and productivity growth in the region. Disruptions in energy markets driven by the escalation of the conflict could lead to increased prices of food and metals by raising production and transportation costs (World Bank 2023g). Such disruptions could also be caused by increased security threats in major shipping lanes in the region. Additionally, the price of gold may rise as the conflict increases uncertainty and reduces investors' risk appetite.

The conflict could be further escalated or protracted because of a surge in refugees or internal displacement of people. It would result in an erosion of human capital via losses of access to essential health and education services (Schady et al. 2023). In MNA, particularly its economies in fragile or conflict-affected situations, the number of refugees has already been increasing (figure 2.4.3.B). As the number of affected people increases, social tensions could rise. Increased violence driven by elevated social tensions could spur greater food insecurity, exacerbated by a rise in food prices. Heightened food insecurity could worsen poverty and inequality outcomes in the region.

MNA is vulnerable to natural disasters, which, apart from their humanitarian toll, can cause severe damage to infrastructure and reduce output, incomes, and productivity. Total deaths from natural disasters rose significantly last year (figure 2.4.3.C). As climate change continues to increase the frequency and severity of adverse weather events, the lack of weather-resilient buildings and infrastructure, along with inadequate maintenance of existing structures and mitigation facilities, could amplify damage (OECD 2018). The impact of extreme weather events tends to be particularly large and persistent in countries without fiscal buffers to enable adequate responses (Pigato 2019). Access to basic services, especially among the vulnerable, could be constrained, further increasing poverty and inequality.

Oil exporters are typically heavily dependent on a single commodity for their output, exports, and government revenues. Weaker global demand relative to the baseline forecast-for example, owing to softer growth in China-would put downward pressure on global oil prices and on growth in MNA's oil exporters. Should oil prices fall or demand weaken, oil production might be curtailed or prolonged in several oil exporters, negatively impacting growth prospects in MNA. In commodity-exporting economies, fiscal policy tends to be more volatile than in other economies, and volatility is negatively associated with economic growth (chapter 4; Arroyo Marioli, Fatás, and Vasishtha 2023). Furthermore, the volatility of terms of trade has been consistently higher in oil exporters in MNA than in other economies and elevated particularly in GCC countries (Gatti et al. 2023).

In advanced economies, interest rates might need to be raised further, given still-elevated inflation. Larger-than-anticipated increases in interest rates, or an extended period of elevated rates, could expose latent economic and financial vulnerabilities and tighten global financial conditions. Such tightening, relative to the baseline forecast, could increase financial instability and lead to capital outflows and currency depreciations, particularly in oil importers. External financing needs are expected to increase in both oil exporters and importers in 2024, but to be more elevated in the latter (figure 2.4.3.D). Given the large external deficits in many oil importers and their limited access to external financing sources, tighter financial conditions would further weaken growth.

SOUTH ASIA



Growth in South Asia (SAR) is expected to edge marginally lower from an estimated 5.7 percent last year to 5.6 percent in 2024—still the fastest pace among all emerging market and developing economy (EMDE) regions and then firm to 5.9 percent in 2025. Growth in India is projected to remain strong, largely driven by robust investment and services. In other economies, the adverse effects of persistently high inflation and monetary and fiscal policy tightening, as well as policy uncertainty, will weigh on growth. Risks to the outlook are tilted to the downside, with the most pressing concerns being higher energy and food prices caused by the ongoing conflict in the Middle East and adverse spillovers from elevated policy rates in advanced economies. Risks of financial and fiscal stress, extreme weather events, slowing activity in China, and election-related uncertainty in some countries pose further downside risks for the region.

Recent developments

Growth in SAR is estimated to have slowed slightly, from 5.9 percent in 2022 to a still-strong 5.7 percent in 2023—still the fastest of all EMDE regions. This primarily reflected a robust expansion in India, which accounted for more than three-fourths of regional output in 2023 (figure 2.5.1.A). Excluding that in India, however, activity was more subdued.

In India, the slowdown in growth to 7.2 percent in fiscal year (FY) 2022/23, which ended in March 2023, was primarily due to a weakening postparticularly in private pandemic rebound, investment and consumption. However, a strong performance in 2023 was underpinned by robust public investment growth and vibrant services activity, thanks to resilient domestic demand for consumer services and exports of business services. In contrast, merchandise exports slowed, reflecting weak external demand. Headline consumer price inflation remained within monetary authorities' target band of 2-6 percent throughout most of 2023, with policy rates being kept unchanged since February 2023.

In Bangladesh, growth is estimated to have slowed to 6 percent in FY2022/23, as activity was

hampered by import restrictions and rising material and energy costs, as well as mounting external and financial pressures. Headline consumer price inflation increased in 2023, mainly driven by rising food prices and currency depreciation, resulting in tighter monetary policy (figure 2.5.1.B). Balance of payments deteriorated, along with a decline in foreign exchange reserves. Financial sector vulnerabilities rose, as nonperforming and other stressed loans increased (World Bank 2023j).

In Pakistan, output contracted an estimated 0.2 percent in FY2022/23 as a result of the effects of damage from the 2022 floods and increased political uncertainty. Consumer price inflation remained elevated, partly reflecting currency depreciation in early 2023 (figure 2.5.1.C). However, by late 2023, the rupee showed signs of stabilization, driven by a variety of factors. These included increased liquidity in the foreign exchange market due to tighter enforcement of regulations, a shrinking money supply, a balance-of-payments surplus on account of low import demand, and a moratorium on Chinese debt repayments.

In Sri Lanka, the economy contracted an estimated 3.8 percent in 2023. Credit to the private sector remained subdued throughout last year, adversely affecting activity. With weaker demand, consumer



> price inflation declined, and the central bank started to reduce policy rates from mid-2023. Progress was also made in sovereign debt restructuring, as the authorities reached agreements with major official creditors, including China and the Paris Club, as well as the implementation of a domestic debt optimization plan.

> In Nepal, growth is estimated to have slowed markedly in FY2022/23, partly reflecting earlier monetary policy tightening to curb credit growth. Import restrictions also weighed on growth, though they were lifted in January 2023 (World

Bank 2023k). Inflation remained high, partly driven by an increase in food price inflation.

For Afghanistan, economic data are sparse. Despite declining food prices in 2023, poverty rates remained high, exacerbated by strong earthquakes in October 2023. The country also faced an increase in unemployment and underemployment, as the rise in the labor supply outpaced the subdued demand (World Bank 2023l).

The recovery in global tourism continued to benefit the region, including Bhutan and Maldives (figure 2.5.1.D). The number of tourist arrivals in Maldives increased by 13 percent in the first ten months of 2023, relative to the same period of 2022. In Bhutan, tourism-related fees were reduced to attract more tourists in September 2023.

Economic growth in SAR is expected to edge slightly lower to a still-robust 5.6 percent pace in 2024, and then strengthen to 5.9 percent in the following year (figure 2.5.2.A; table 2.5.1). Domestic demand, including public consumption and investment, will remain major drivers of economic growth. A pickup in external demand, albeit still subdued, is also expected to contribute to growth. Excluding that in India, output in the region is projected to expand by 3.8 percent in 2024 and 4.1 percent in 2025.

India is anticipated to maintain the fastest growth rate among the world's largest economies, but its post-pandemic recovery is expected to slow, with estimated growth of 6.3 percent in FY2023/24 (April 2023 to March 2024; table 1.1). Growth is then expected to recover gradually, edging up to 6.4 percent in FY2024/25 and 6.5 percent in FY2025/26 (table 2.5.2). Investment is envisaged to decelerate marginally but remain robust, supported by higher public investment and improved corporate balance sheets, including in the banking sector (World Bank 2023m). Private consumption growth is likely to taper off, as the post-pandemic pent-up demand diminishes and persistent high food price inflation is likely to constrain spending, particularly among lowincome households. Meanwhile, government consumption is expected to grow slowly, in line with the central government's efforts to lower the share of current spending.

In Bangladesh, growth is forecast to slow to 5.6 percent in FY2023/24 (July 2023 to June 2024). Inflation is likely to remain elevated, weighing on private consumption. As foreign exchange reserves are likely to stay low, import restrictions are expected to continue and impede private investment. In contrast, public investment is envisaged to remain resilient. Growth is expected to rise in FY2024/25 as inflationary pressure recedes.

In Pakistan, the economic outlook for FY2023/24 (July 2023 to June 2024) remains subdued, with growth projected at only 1.7 percent. Monetary policy is expected to remain tight to contain inflation, while fiscal policy is also set to be contractionary, reflecting pressures from high debt-service payments. Weak confidence stemming from political turmoil will contribute to the slow growth in private demand. As inflationary pressure eases, growth is expected to pick up to 2.4 percent in FY2024/25.


Maldives' economy is projected to expand by 5.2 percent in 2024 and 5.5 percent in 2025. A continued recovery in tourism from major economies, including China, is expected to contribute to robust growth. Investment related to the tourism sector, particularly the expansion of Velana International Airport, will also support growth.

In Bhutan, growth is expected to slow to 4 percent in FY2023/24 (July 2023 to June 2024), partly reflecting reductions in public investment and capital expenditure. Despite this, the economy will still benefit from a strong performance in tourismrelated services. In FY2024/25, growth is projected to pick up to 4.6 percent, reflecting a recovery in industrial and services activities and the commissioning of a new hydro plant.

In Nepal, growth is projected to pick up to 3.9 percent in FY2023/24 (mid-July 2023 to mid-July 2024) and 5 percent in FY2024/25. Expansion of industrial and services activities will be supported

by monetary policy easing and the lagged effects of the removal of import restrictions. In Sri Lanka, the economic outlook remains uncertain, amid debt restructuring negotiations with private creditors and the implementation of structural reforms to improve growth potential.

Fiscal policies in the region are expected to be a modest drag on growth, with deficits set to narrow marginally in 2024 (figure 2.5.2.B). In India, government revenues are expected to gain from solid corporate profits, and current expenditures are likely to decrease with the conclusion of pandemic-related measures. Interest payments are projected to be large in countries with elevated debt levels, including India, Pakistan, and Sri Lanka.

Over the long run, growth prospects in the region are expected to remain strong, despite some moderation (figure 2.5.2.C). Potential growth in the region is expected to be broadly stable, partly supported by demographic dividends (Kose and Ohnsorge 2023). However, the region will see a shift in the distribution of workers toward older cohorts, underscoring a need to raise labor supply. As gender inequality is widespread in regional labor markets, there is ample opportunity to advance female labor force participation, which could, in turn, enhance the potential for economic growth.

Per capita income growth is projected to fall to 4.5 percent in 2024, from a 2010-19 average of 5.4 percent a year. Excluding India, regional per capita income growth is expected to be a modest 2.3 percent a year. Despite the slowdown, the decline in poverty in the region is expected to continue (figure 2.5.2.D).

Risks

Risks to the baseline forecast remain tilted to the downside, with the most pressing concerns revolving around higher energy and food prices caused by an escalation of the conflict in the Middle East and adverse spillovers stemming from larger-than-expected increases in policy rates in advanced economies. Other downside risks in the region include large financing needs, extreme weather events, further weakness in China, and heightened uncertainty around elections in some countries. However, the implementation of growth-friendly policies following these elections could improve growth prospects.

An escalation of the conflict in the Middle East, as well as elevated geopolitical risks because of Russia's invasion of Ukraine, could have significant implications for commodity markets. A surge in oil prices caused by the intensification of the conflict would likely raise the cost of food and other commodities due to higher production and transportation expenses (World Bank 2023g). SAR is vulnerable to higher prices of food and energy, as a surge in global prices would lead to a deterioration in external positions and destabilize the economy by dampening investment and overall economic activity. Food accounts for a significant share of household consumption baskets in the region (World Bank 2023n).


FIGURE 2.5.3 SAR: Risks

As poorer households spend more on food, rising food prices would disproportionately affect the poor and the vulnerable, resulting in an increase in poverty and inequality. The risk is particularly high in countries with limited fiscal buffers to mitigate adverse effects, including Nepal and Pakistan, and in countries under major security threats, including Afghanistan. In addition, an increase in food insecurity could be exacerbated by the escalation of the ongoing conflict in the Middle East (figure 2.5.3.A).

There remains uncertainty about the trajectory of global interest rates. Larger-than-anticipated increases in policy rates, particularly in advanced economies, driven by limited progress in reducing inflation, could cause further tightening of global financial conditions. Adverse spillovers from tighter financial conditions could undermine financial stability and economic activity in SAR, especially through increased borrowing costs, currency depreciations, and declines in foreign reserves. The effects could be compounded by elevated debt levels, as the financial sector is highly exposed to sovereign debt in SAR via the sovereign-bank nexus (World Bank 2023o). In addition, region-wide inflation expectations are increased among financial market participants (figure 2.5.3.B). If inflation expectations remain persistently high and are unanchored, additional domestic monetary policy tightening would be required, weighing on activity.

External and fiscal financing needs are elevated in several SAR economies, including Maldives, Pakistan, and Sri Lanka, increasing vulnerabilities to financial market disruptions (figure 2.5.3.C). In these economies, market sentiment can suddenly shift in response to financial sector stress or weakening fiscal positions. Vulnerability to such shifts is particularly high in countries with limited international reserves or fiscal buffers, or weak governance in the financial sector.

Extreme weather events also pose a major risk. In SAR, an increase in extreme weather events would contribute to an increase in poverty through multiple channels, including the deterioration of health conditions and a rise in food prices (Jafino et al. 2020). In 2023, the death toll from natural disasters remained high in SAR, mainly because of the devastating earthquake in Afghanistan and floods in India (figure 2.5.3.D). The growing frequency and severity of extreme weather events also pose risks to food production in the region.


Because SAR is relatively less open to trade, spillovers from weaker-than-projected growth in China would be smaller than in other EMDE regions. However, in countries where China is a major trading partner or key source of foreign investment, a sharper-than-expected slowdown in China could undermine growth. Additionally, in Bangladesh, slower-than-anticipated growth in its export destinations, particularly in the European Union, could pose a risk to growth prospects.


In a number of SAR economies (Bangladesh, Bhutan, India, Maldives, and Pakistan), parliamentary or national assembly elections are scheduled or planned in 2024. The heightened uncertainty around these elections could dampen activity in the private sector, including foreign investment. If combined with political or social unrest and elevated violence, this could further disrupt and weaken economic growth. In addition, particularly in countries with the weak fiscal positions, an increase in spending prior to these elections could exacerbate macro-fiscal vulnerabilities. However, the implementation of policies to reduce uncertainty and strengthen growth potential after elections could lead to an improvement in prospects.











C. External and fiscal financing needs, 2024

SUB-SAHARAN AFRICA

Growth in Sub-Saharan Africa (SSA) is projected to rebound to 3.8 percent in 2024 and 4.1 percent in 2025 as country-specific factors that have temporarily weighed on growth, including reduced fiscal support and metalexporting economies' adjusting to lower prices, gradually ease. Nevertheless, elevated costs of living continue to limit consumption growth, and political instability has increased in parts of the region. High debt burdens and interest rates have narrowed fiscal space and heightened financing needs. Despite the projected pickup in growth, increases in per capita incomes will remain inadequate to enable the region's economies make significant progress in reducing extreme poverty. Risks to the baseline growth forecast remain tilted to the downside. They include a further rise in global or regional instability, such as the possible escalation of the conflict in the Middle East, which could drive up global energy and food prices; a sharper-than-expected global economic slowdown; increased frequency and intensity of adverse weather events; and increased defaults if attempts to reduce elevated public debt burdens were to fail. Materialization of these risks would also exacerbate poverty and limit the ability of many countries to cope with climate change.

Recent developments

Growth in SSA decelerated to an estimated 2.9 percent in 2023, which is 0.3 percentage point lower than projected in June. Various countryspecific challenges, including higher input prices for businesses in Nigeria and an energy crisis in South Africa, contributed to a slowdown in the region's economic activity during 2023 (figure 2.6.1.A). Growth in the region's three largest economies-Nigeria, South Africa, and Angolaslowed to an average of 1.8 percent in 2023. In the region's other countries, growth softened to 3.9 percent, partly reflecting a sharp decline in metal exporters' growth alongside lower global metals prices (chapter 1). Moreover, growth in several countries was hampered by intense and protracted conflicts, most notably that in Sudan, and recent flareups of violence in Chad and Niger, contributing to an increase in violent events in the region (figure 2.6.1.B). Moreover, post-pandemic recoveries were slowed by weakening external demand and domestic policy tightening to address persistent inflation.

In *Nigeria*, the region's largest economy, growth softened to an estimated 2.9 percent in 2023. While services growth weakened markedly in 2023, partly driven by a disruptive currency demonetization policy in the first quarter of 2023, annual oil production increased after a notable decline in previous years (figure 2.6.1.C).

In *South Africa*, growth weakened further in 2023, to an estimated 0.7 percent, reflecting the effects structural constraints, especially the energy crisis and transport bottlenecks, and weaker demand in a context of weak job creation, high prices and monetary policy tightening. Power outages hit record highs in 2023, holding back manufacturing and mining production.


Growth in *Angola* weakened to an estimated 0.5 percent in 2023, with maturing oil fields contributing to markedly lower oil production, leading to revenue shortfalls and triggering public expenditure cuts.

Elsewhere in the region, activity in resource-rich countries weakened. Growth in Botswana softened owing to declines in global demand and prices for diamonds, while growth in Namibia, a mineral and metal resource-rich country, slowed owing to

> the loss of momentum in mining output growth and tighter monetary policy weighing on domestic demand. In Niger, also a metal exporter, growth slowed sharply following a coup in late July, which was followed by international economic and financial sanctions against the junta. More broadly, lower metal prices weighed on growth in many metal-exporting economies (Botswana, Democratic Republic of Congo, Liberia, Sierra Leone, Zambia).

> Amid persistently large current account and fiscal deficits, and the associated need for fiscal consolidation, growth in non-resource-rich countries generally weakened in 2023, even

though most of these countries are agricultural commodity exporters benefiting from declining fertilizer prices. Despite a pickup in its agricultural sector, Ethiopia—SSA's largest agricultural commodity producer and its most populous lowincome country—saw its growth slow to 5.8 percent in 2023, as a result of increased fiscal and external pressures. In contrast, growth in Tanzania and Uganda edged up in 2023, supported by higher government spending.

Headline consumer price inflation in SSA moderated in 2023 following sharp rises in global food and energy prices in 2022, yet it remained elevated (figure 2.6.1.D). The cost of living continues to be high, which has worsened the economic hardship of the poor and increased food insecurity across the region. In West Africa, a significant portion of the population—often even the majority in countries like Burkina Faso, Chad, Guinea, Mali, Niger, and Sierra Leone—has insufficient food (World Bank 2023p).

Outlook

Growth in SSA is expected to accelerate to 3.8 percent in 2024 and firm further to 4.1 percent in 2025 as inflationary pressures fade and financial conditions ease (table 2.6.1). The projections for regional growth in 2024 and 2025 are little changed from June forecasts, but these aggregates mask a mix of upgrades and downgrades at the country level. While growth in the largest economies in SSA is expected to lag the rest of the region, non-resource-rich economies are forecasted to maintain a growth rate above the regional average. Excluding the three largest SSA economies, growth in the region is expected to accelerate from 3.9 percent in 2023 to 5 percent in 2024, and further 5.3 percent in 2025 (figure 2.6.2.A). Non-resource-rich countries are expected to continue benefiting from the moderation in fertilizer prices. Although metal exporters are expected to recover from their growth slump in 2023, downgrades are still concentrated among these economies, with continued weak growth in demand from China expected to be a drag on activity (figure 2.6.2.B).

More broadly, limited fiscal space, resulting from high debt levels and increased borrowing costs, along with tight monetary policies, are expected to weigh on investment growth across the region. Although waning inflationary pressures should allow for a gradual easing of interest rates, thereby bolstering private consumption and investment during the forecast period, the weaknesses in the region's three largest economies will limit the pickup in SSA's growth.

Growth in *Nigeria* is projected at 3.3 percent this year and 3.7 percent in 2025—up 0.3 and 0.6 percentage point, respectively, since June—as macro-fiscal reforms gradually bear fruits. The baseline forecast implies that per capita income will reach its pre-pandemic level only in 2025. Growth is expected to be driven mainly by agriculture, construction, services, and trade. Inflation should gradually ease as the effects of last year's exchange rate reforms and removal of fuel subsidies fade. These structural reforms are expected to boost fiscal revenue over the forecast period.

Growth in South Africa is projected to firm to a still-subdued 1.3 percent in 2024 and then edge up to 1.5 percent in 2025. While energy sector reforms are expected to improve energy availability in the medium term, increasingly prevalent infrastructure bottlenecks, exacerbated by the slow pace of structural reforms, are likely to continue to limit the country's growth potential. Domestically, fiscal pressures from underperforming revenue and the rising costs of social transfers and subsidies of state-owned enterprises, as well as rising public sector wages and debt-service payments, may require curbs on other government spending to reduce the fiscal deficit. In addition, constrained rail and port capacity are expected to weigh on export performance.


Growth in *Angola* is projected to pick up to 2.8 percent this year, half a percentage point lower than anticipated in the June *Global Economic Prospects* report, as investment grows more slowly than expected. Non-oil economic activity will be the main driver of growth, while the oil and gas industry is expected to grow by a mere 1 percent a year on account of field depletion and lack of investment. Projected growth is broadly in line with Angola's population growth, implying that

FIGURE 2.6.2 SSA: Outlook

Growth in SSA is expected to pick up in 2024-25, approaching its average rate of the past two decades. Growth in the largest economies in SSA is expected to lag that in the rest of the region, while it is forecast to remain above the regional average in non-resource-rich countries. average per capita incomes will be broadly unchanged at the end of 2025 from current levels, which are nearly 13 percent lower than before the pandemic. Inflationary pressures are expected to ease in 2024, declining toward the central bank's target of 7 percent.

Growth in SSA's resource-rich countries is expected to pick up in 2024 and 2025. Industrial commodity exporters in the region, excluding the three largest economies, are forecast to grow by 3.8 percent in 2024 and 4.1 percent in 2025, up from 2.0 percent in 2023. This uptick is due to the diminishing impact of the sharp fall in commodity prices from their 2022 peak. Growth in the non-mining sectors, especially services, is expected to pick up as inflation gradually declines (Botswana, Cameroon, Democratic Republic of Congo).

Growth in non-resource-rich countries is projected to strengthen to 5.4 percent in 2024 and 5.7 percent in 2025. Increasing investment is expected to drive growth in Kenya and Uganda, partly owing to improved business confidence. Uganda will also benefit from infrastructure investment ahead of new oil production in 2025, and investment in Kenya should be boosted by increased credit to the private sector as the government reduces domestic borrowing. In Tanzania, reforms to improve the business climate are expected to lift growth.

Per capita income in SSA, on average, is projected to grow by a meager 1.2 percent this year and 1.5 percent in 2025 (figure 2.6.2.C). However, per capita income is expected to fall in both years in Chad, Equatorial Guinea, and Sudan, with particularly sharp declines in Sudan. Additionally, it is anticipated to stagnate in 2025 after shrinking in 2024 in Angola and the Central African Republic. By 2025, per capita gross domestic product (GDP) in about 30 percent of the region's economies, with a total population of more than 250 million, will not have fully recovered to their pre-pandemic levels. This implies that these economies will have lost several years in advancing per capita income.

External financing needs across the region have increased since the onset of the pandemic, partly reflecting higher import bills and debt-service costs. Consequently, current account deficits remain elevated in many economies. Higher deficits for industrial-commodity-exporting countries outweigh improvements for nonresource-rich economies (figure 2.6.2.D). The gross financing needs of the median SSA country in the Low-Income Country Debt Sustainability Framework have more than quadrupled since 2012, rising from 2.4 percent to 11 percent of GDP in 2022 (World Bank 2023q). Meanwhile access to external finance has become more challenging with the tightening of global financial conditions, especially for countries with reduced donor support or shrinking foreign exchange reserves. The need to boost fiscal revenues, and, where adequate, implement fiscal consolidation has become even more pressing throughout SSA, especially in highly indebted countries facing risks of debt distress.

Risks

Risks to the baseline growth forecast are tilted to the downside. They include a rise in political instability and violence, such as the intensification of the conflict in the Middle East, disruptions to global or local trade and production, increased frequency and intensity of adverse weather events, a sharper-than-expected global economic slowdown, and higher risk of government defaults, especially if debt restructuring attempts by highly indebted countries prove unsuccessful.


FIGURE 2.6.3 SSA: Risks

An escalation of the conflict in the Middle East could acerbate the situation in SSA in terms of food insecurity (figure 2.6.3.A; World Bank 2023g). A conflict-induced sustained oil price spike would not only raise food prices by increasing production and transportation costs but could also disrupt supply chains, leading to less affordable food and an uptick in malnutrition rates in the region.

Although global food and energy prices have retreated from their peaks in 2022, disruptions to global or local trade and production could reignite consumer price inflation, especially food price inflation, throughout the region. Such disruptions, especially in mining and agriculture, could be triggered by extreme weather events linked partly to climate change. The region is highly vulnerable to such events. For instance, the current El Niño weather pattern could bring above-average rainfall and flooding to East Africa, and drought to Southern Africa (figure 2.6.3.B; WMO/WHO 2023). Subsistence agriculture is the main source of livelihood and employment for many poor and vulnerable people in SSA. An increase in the frequency and severity of droughts, floods, and tropical cyclones would aggravate poverty across

SSA, while increasing food insecurity in many countries. Over the period 1991-2021, SSA has been the most affected region in terms of lost value added in agriculture due to extreme events affecting crops and livestock (FAO 2023). In the long term, climate change-induced rises in average temperatures could adversely affect crop yields across the region, reducing food supplies as well as exports.

Global growth could weaken more than expected, perhaps owing to tighter financing conditions or further deterioration in China's growth (chapter 1). In such a scenario, the prices of many of SSA's export commodities, especially metals and minerals, could weaken. Countries that rely heavily on China as an export destination for these commodities would be hit especially hard by slower-than-projected Chinese growth.


Public-debt-service costs have risen sharply in many SSA economies since the pandemic (figure 2.6.3.C). This has increased the need for debt reduction, particularly in highly indebted countries. If global or domestic inflation turns out to be higher than expected, interest rates could remain elevated for a longer duration than assumed in the baseline scenario, leading to tighter financial conditions globally and in SSA. This could limit access to financial markets and increase risks of financial distress and government debt defaults (figure 2.6.3.D).

Many SSA economies suffer from fragility stemming from persistent poverty, as well as festering violence and conflict, including the Democratic Republic of Congo, Ethiopia, Somalia, South Sudan, and Sudan. Peacemaking efforts in the Democratic Republic of Congo and Ethiopia have borne fruit, but recent coups d'état-in Niger and Gabon in 2023; Burkina Faso in 2022; and Chad, Guinea, Mali, and Sudan in 2021-have resulted in an escalation of political instability in much of the region. Further increases in violent conflicts could push growth below the baseline and result in extended humanitarian crises in many of SSA's most economically vulnerable countries. These nations are already frequently facing high levels of debt (or even debt distress), heavy dependence on food and fuel imports, and elevated inflation.

Food insecurity in the region remains elevated and could worsen if the conflict in the Middle East intensifies. The share of the population affected by adverse weather events has increased in recent years. Interest payments on public debt are expected to rise as a result of the increase in global interest rates, while the number of countries in debt distress or facing high risk of debt distress will likely remain elevated.


A. Food insecurity in SSA




B. Share of population affected by adverse weather events

THE MAGIC OF INVESTMENT ACCELERATIONS

Investment powers economic growth, helps drive down poverty, and will be indispensable for tackling climate change and achieving other key development goals in emerging market and developing economies (EMDEs). Without further policy action, investment growth in these economies is likely to remain tepid for the remainder of this decade. But it can be boosted. This chapter offers the first comprehensive analysis of investment accelerations—periods in which there is a sustained increase in investment growth to a relatively rapid rate—in EMDEs. During these episodes over the past seven decades, investment growth typically jumped to more than 10 percent per year, which is more than three times the growth rate in other (non-acceleration) years. Countries that had investment accelerations often reaped an economic windfall: output growth increased by about 2 percentage points and productivity growth increased by 1.3 percentage points per year. Other benefits also materialized in the majority of such episodes: inflation fell, fiscal and external balances improved, and the national poverty rate declined. Most accelerations followed, or were accompanied by, policy shifts intended to improve macroeconomic stability, structural reforms, or both. These policy actions were particularly conducive to sparking investment accelerations when combined with well-functioning institutions. A benign external environment also played a crucial role in catalyzing investment accelerations in many cases.

Introduction


FIGURE 3.1 Evolution of investment growth

Over the past two decades, capital accumulation is estimated to have accounted for more than half of potential output growth in emerging market and developing economies (EMDEs), highlighting the critical role of investment in driving economic growth (figure 3.1).1 Yet, investment growth in these economies is going through a prolonged, broad-based slowdown since the global financial crisis that began in 2008. Investment growth in EMDEs (excluding China) averaged about 6 percent per year in the 2000s, before slowing to an annual average of 3 percent in the 2010s (World Bank 2023a). During the 2020 global recession COVID-19 triggered by the pandemic, investment contracted much more deeply than it did during the 2009 global recession. Despite a cyclical rebound in 2021, investment growth in EMDEs will likely be subdued over the medium term.

Prolonged weak investment growth dampens potential output growth and makes it more difficult to achieve climate-related and other development goals. It also exacerbates the challenges associated with sizeable unmet investment needs in many EMDEs: substantial investment is required to fill infrastructure gaps, enable adaptation to climate change, facilitate the energy transition away from fossil fuels, accelerate poverty reduction, and advance shared prosperity (G20-IEG 2023; Rozenberg and Fay 2019; Stamm and Vorisek 2023; UNEP 2023).²

Although there is extensive discussion about the urgent need to raise investment growth, there is insufficient research on past investment accelerations—defined as periods in which there is a sustained increase in investment growth to a relatively rapid rate. A fuller understanding of these accelerations could provide useful lessons for achieving long-term growth and development goals in EMDEs.

This chapter examines the drivers of investment accelerations and associated economic outcomes by addressing the following questions:



²To reach the climate targets of the Paris Agreement alone, there is a global need of more than US\$4 trillion in annual investment through 2030 (IRENA 2023). EMDEs are projected to require annual investment equivalent to 1 to 8 percent of GDP through 2030 to reduce greenhouse gas emissions by 70 percent by 2050 and meet other development goals (World Bank 2022a). The costs of adaptation are estimated to be in a plausible range of US\$215 billion-US\$387 billion per year through 2030 (UNEP 2023). Even if these needs are fulfilled, there would be significant investment gaps for delivering the nationally determined contributions of the Paris Climate Agreement (IEA and IFC 2023; McCollum et al. 2018). These gaps imply that large amounts of private funding must be mobilized to complement the limited public sources (G20 and IEG 2023; Zattler 2023).


A. Contributions to average annual potential output growth




C. Average annual investment growth, by income level




B. Average annual investment growth, by country group




D. Investment growth forecasts

- What are the main features of investment accelerations?
- What are the key macroeconomic and development outcomes associated with investment accelerations?
- What policy interventions are most likely to spark investment accelerations?

Contributions

The chapter makes the following contributions to the literature:

Exclusive focus on investment accelerations. This is the first study that examines periods characterized by a sustained increase in investment growth to a relatively rapid rate.³ The earlier literature often examined the drivers of investment growth in the context of standard cross-country growth regressions. The event-study approach employed here demonstrates a stronger link between investment accelerations on the one hand and initial conditions and policy interventions on the other.⁴

Detailed analysis of investment accelerations. The chapter presents a comprehensive analysis of the evolution of investment, output, and other key macroeconomic and financial variables during investment accelerations. It examines 104 economies-35 advanced economies and 69 EMDEs-from 1950 to 2022. This analysis documents the macroeconomic correlates of investment accelerations, such capital as accumulation, total factor productivity (TFP) growth, and employment growth, which contribute to output growth. It also studies how

some key macroeconomic and financial indicators—such as fiscal balances, trade, exchange rates, and credit—evolve around these episodes. Finally, this study analyzes the association between investment accelerations and key development outcomes, such as changes in poverty and inequality.

In-depth study of policies. The chapter draws both on empirical models and country case studies (box 3.1) to analyze the linkages between policies and investment accelerations. The empirical models assess the roles played by various initial conditions and policy interventions in triggering an investment acceleration. They also consider the interplay between policies and institutional environments in accelerating investment. The case studies zoom in on the experiences of selected countries to present more detailed accounts of the roles of policies, initial conditions, and the external environment in specific investment accelerations.

Main findings

The chapter's principal findings are:

Investment accelerations have happened in many EMDEs, but they have become less common. The chapter identifies 192 investment accelerations in 93 economies (34 advanced economies and 59 EMDEs) over 1950-2022. On average, the probability that an EMDE experienced an investment acceleration in any decade was 40 percent. Along with the protracted slowdown in investment growth since the global financial crisis, the number of investment accelerations in EMDEs has declined over time. In parallel, the external environment has become less supportive and domestic reform drives of the early 2000s lost momentum (Kose and Ohnsorge 2019; Stamm and Vorisek 2023).

Faster investment growth has often been driven by both the public and private sectors. The median annual growth of investment was 10.4 percent in EMDEs during investment accelerations, slightly more than three times the growth rate of 3.2 percent in other years. Often, both public and private investment growth have picked up during these episodes. Although the extent of the increase in public and private investment growth around investment accelerations differs across EMDE regions, the differences were relatively small.

Investment accelerations often coincided with periods of transformative growth. During investment accelerations, output growth in EMDEs reached 5.9 percent per year, which is 1.9 percentage points higher than in other years. This rapid growth rate translates into an expansion of almost two-fifths in GDP over six years, almost one-and-a-half times the median expansion during comparable period outside accelerations. a Investment accelerations are associated with higher output growth as they help boost capital accumulation, increase employment growth and strengthen growth of TFP-that is, the portion of growth that is not due to increased inputs of labor and capital and is generally considered a measure of efficiency. Specifically, an investment acceleration in EMDEs, on average, was associated with an increase of almost 1.3 percentage points in annual TFP growth, from slightly above zero in other years. Also, there was much higher growth of employment and output in the manufacturing and services sectors because investment accelerations support faster shifts of resources from less productive sectors, mainly agriculture, to more productive sectors.

Accelerations have coincided with better macroeconomic and development outcomes. Investment accelerations have also frequently been accompanied by improved fiscal balances, faster credit expansion, and larger net capital inflows. In addition, they have tended to coincide with better development outcomes, including faster poverty reduction, lower inequality, and improved access to infrastructure, such as the internet.

Policies have helped to ignite investment accelerations. Both the chapter's empirical analysis and its country case studies arrive at three key observations about the role of policies in investment accelerations:

 Policy interventions that improve macroeconomic stability—such as fiscal consolidations (actions to reduce deficits) and inflation targeting—and structural reforms, including measures that ease cross-border trade and financial flows, have been instrumental in sparking investment accelerations.

- Although individual policy interventions have played a role, country-specific comprehensive packages of policies fostering macroeconomic stability and addressing structural issues have tended to be more potent in driving investment accelerations. When a country's primary fiscal balance and openness to trade and financial flows have substantially improved, the probability of igniting an investment acceleration has increased by 9 percentage points. Country cases, such as the Republic of Korea in the late 1990s and Türkiye in the early 2000s, illustrate the potential efficacy of comprehensive policy packages.
- Having high quality institutions (such as a well-functioning and impartial legal system) is critical for the success of policy interventions in starting investment accelerations. The likelihood of investment accelerations and the ultimate impact of policy reforms have been greater in countries with better institutions.

Database and identification methodology

Database

Investment is defined as real gross fixed capital formation, including both private and public investment (World Bank 2023a). Data on investment are taken from Penn World Table 10.01 (PWT), extended to 2022 using data from Haver Analytics, and databases from the World Bank's World Development Indicators and Global Economic Prospects (see annex 3.2 for details on data). This chapter focuses on growth in investment per capita because it presents a clear parallel with growth in GDP per capita, which is the most basic measure of growth in living standards and, as such, central to the analysis of long-term economic growth (Libman, Montecino, and Razmi 2019). Investment and output data are converted into per capita terms using population data from PWT and the United Nations World

Population Prospects database. The dataset covers up to 35 advanced economies and 69 EMDEs for 1950-2022. The IMF Investment and Capital Stock dataset, which covers the period 1960-2019, is used to separate public from private investment (for information on other data used in the chapter, see annex 3.2).

Identification methodology

A simple event study approach is employed to identify investment accelerations. The approach follows earlier studies on accelerations of output and capital stock, but it is adjusted to ensure that the identified episodes are characterized by *sustained increases in per capita investment growth to a relatively rapid rate.*⁵ The methodology imposes the following rules, based on the data and the literature:

- Sustained. Each episode must be sustained for at least six years. The duration of episodes is selected to exclude purely cyclical rebounds in investment growth (Barro and Sara-i-Martin 1992; Christiano and Fitzgerald 2003).
- *Rapid.* The average annual growth rate of investment in the acceleration (of at least six years) must be at least 4 percent. Only one-third of the countries in the sample had a median annual per capita investment growth rate exceeding 4 percent between 1950 and 2022. Because of the volatile nature of investment growth, a 4 percent threshold was selected because it is sufficiently high, and surpassing an average growth rate of 4 percent is unlikely to be driven by one year of very high growth.
- *Higher growth rate.* To ensure that the episode is an acceleration, the average per capita growth rate of investment must be at least 2 percentage points higher than the average of

the previous six years. In addition, to ensure that the episode is not merely a cyclical recovery, the capital stock at the end of the period must exceed its pre-episode peak.

An acceleration is considered to end when per capita investment growth turns negative, or when the inclusion of the current year reduces the average annual per capita investment growth rate since the start of the acceleration to below 4 percent. Investment accelerations can end for a variety of reasons: diminishing returns to capital stock that naturally reduce the average investment growth rate, domestic shocks driven by the accumulation of macroeconomic and financial imbalances, or external shocks such as a regional or global financial crisis. In general, accelerations have rarely been followed by crises or major recessions: four-fifths of those in the sample were not followed by a currency, debt, or banking crisis in the four years after the acceleration.

The rest of the chapter focuses on growth rates of investment, output, and other macroeconomic variables in the three stages around an investment acceleration—namely *before*, *during*, and *after*, with *during* capturing the full duration of acceleration years. To report comparable statistics across these three stages, the analysis focuses mainly on the medians of changes in variables in each stage.

Features of investment accelerations

Number of accelerations

The method identifies 192 investment accelerations in 93 economies (34 advanced economies and 59 EMDEs) over the period 1950-2022 (see annex 3.1). For a typical country, the probability of an investment acceleration in any given decade was 44 percent, slightly higher than the probability in an EMDE (40 percent). Among the countries that experienced at least one investment acceleration, fewer than one-third of them had three or more investment accelerations. In countries with multiple accelerations, the average time between two episodes was about 10 years, with a few exceptions.

Eleven of the 104 countries in the sample experienced no acceleration. These countries had periods of rapid investment growth, but no true accelerations. In some countries, investment was so volatile that no significant increase in investment growth lasted as long as six years (Guatemala, and Iceland). In other countries, periods of rapid investment growth followed declines in the capital stock, were relatively shortlived, and were insufficient to raise the capital stock to its preacceleration peaks (Côte d'Ivoire, Ghana, Niger, South Africa).

Distribution of accelerations over time and across countries

Globally, 42 percent of countries had an investment acceleration in the 2000s. In the following decade only about a quarter of the world's economies had one. This decline was fully accounted for by EMDEs, as the share of advanced economies with accelerations was virtually unchanged (figure 3.2). The wave of investment accelerations in these economies during the early 2000s was partially supported by benign global conditions, strong cross-border trade and financial flows, and structural reforms that improved many countries' policy frameworks (Kose and Ohnsorge 2019). Since the global financial crisis, the combination of an increasingly difficult external environment and a loss of domestic reform momentum has weighed on investment growth in EMDEs (Stamm and Vorisek 2023).

An EMDE, on average, experienced about 1.7 investment accelerations between 1950 and 2022, compared with about 2.2 such episodes in the average advanced economy. A typical low-income country (LIC) experienced fewer investment accelerations than a high-income country, but its number was similar to those in a typical EMDE. Across EMDE regions, the highest number of investment accelerations per country (nearly 2.4) occurred in East Asia and Pacific, which registered much higher investment growth than other regions over the past seven decades. Reflecting the high volatility of their investment, commodity exporters, economies facing fragile and conflictaffected situations (FCS), and small states experienced fewer investment accelerations than other country groups.

FIGURE 3.2 Frequency of investment accelerations

For EMDEs, the share of investment accelerations peaked in the 2000s and fell by about half in the 2010s. More investment accelerations per country have been observed in East Asia and the Pacific, on average, than in other EMDE regions. Investment accelerations have occurred less frequently in commodity exporters, fragile and conflict-affected situations, and small states – groups of countries where output growth performance is relatively volatile.






A. Share of countries with investment accelerations, by decade





Amplitude and duration of accelerations

In EMDEs, the median annual growth rate of investment was 10.4 percent in a typical investment acceleration during 1950-2022, just over three times the median growth rate in other years of 3.2 percent (figure 3.3). The rate of investment growth typically exceeded 5 percent in the first year of an acceleration episode and peaked at 13 percent in the following year. In one-fourth of the episodes, annual investment growth reached a peak of at least 21 percent. EMDEs typically experienced a greater increase in investment growth than advanced economies. Reflecting the higher volatility of investment, EMDEs also typically experienced a larger decline in investment growth in the six years following the end of an acceleration than did advanced economies. The basic pattern of investment growth over the three stages of acceleration episodes shows only minor differences across EMDEs in different regions and country groups. Most accelerations lasted six to seven years, with a median duration of seven years. One-fifth of accelerations lasted longer than 10 years.

During a typical investment acceleration, median private and public investment growth both improved significantly from the preceding six years—by about 7 percentage points per year globally—and by somewhat more in EMDEs than in advanced economies (figure 3.4). Of the 192 accelerations, just over half saw higher private than public investment growth. The subsequent decline in growth was slightly more pronounced in private than public investment-by about 1 to 2 percentage points a year-perhaps because of the supportive role that fiscal policy tends to play in periods of weaker private investment growth. The decline in private investment after accelerations was also more pronounced in EMDEs than in advanced economies. The behavior of public and private investment growth around investment accelerations did not differ much across EMDE regions. Across the six regions, LAC and SSA had the lowest share of accelerations with higher private than public investment growth, with 37 percent in LAC and almost 32 percent in SSA.

Correlates of investment accelerations

Investment accelerations are associated with faster output growth because they help boost capital accumulation and the growth of productivity and employment, and also because they tend to be accompanied by significant shifts of resources from less productive to more productive uses. Investment accelerations tend to coincide with improvements in some key macroeconomic and financial variables. In addition, they are associated with stronger progress toward some of the key development goals, such as reduction in poverty and inequality and increased access to infrastructure.


Output growth and its underlying channels

Output growth. Output growth has tended to surge during investment accelerations (figure 3.5). In EMDEs, output growth reached 5.9 percent per year during investment accelerations over the period 1950-2022-1.9 percentage points more than in other years. This rapid growth rate translates into an expansion of almost 40 percent in GDP over a six-year period, more than oneand-a-half times the expansion in a comparable six-year period outside acceleration years. In LICs, output growth was higher during accelerations than before and after them, but not to a statistically significant extent. This is partly due to the highly volatile nature of output growth in these economies and the small sample of LICs. Similarly, FCS display very volatile growth in periods before accelerations, with higher growth during and after accelerations. For small states, GDP growth rose particularly rapidly during accelerations, from 2.5 percent before a typical investment acceleration to more than 7.4 percent during one. After accelerations, output growth fell back to 4.7 percent. For small states, these changes in output growth are statistically significant.


Investment accelerations are associated with higher output growth through their impact on capital accumulation and the growth of both TFP and employment.

C. Investment growth around investment accelerations, by country







Both public and private investment growth have increased during investment accelerations. While the rise and subsequent decline in growth has been similar in magnitude in regard to both private and public investment in EMDEs, the rise and decline in private investment has been more notable than that in public investment in advanced economies. The behavior of public and private investment growth before and during investment accelerations has not differed notably across EMDE regions, except that public investment has accounted for a larger share of accelerations in Latin America and the Caribbean and Sub-Saharan Africa.







E. Share of investment accelerations driven by private investment








FIGURE 3.6 Contributions to GDP growth during investment accelerations

- Capital accumulation. Investment accelerations are associated with stronger output growth directly through their links with faster capital accumulation (Kose and Ohnsorge 2023; Loayza and Pennings 2022). Capital accumulation alone accounted for 45 percent of output growth during investment accelerations globally in 1950-2022 (figure 3.6). The share of output growth explained by capital accumulation is markedly higher in EMDEs-almost half-than in advanced economies, where it accounts for one-third during these episodes. This contribution remains sizable after accelerations, contributing to 77 percent of growth in EMDEs, compared with 48 percent in the years before an acceleration. Globally, the annual growth rate of the capital stock increased by almost 50 percent from its preceding level during a typical investment acceleration, reaching 5.2 percent, and kept growing at a faster rate after an acceleration compared with before. For EMDEs, the pickup in capital stock growth during investment accelerations was significantly larger, and from lower initial levels, than for advanced economies. Growing at 6.2 percent a year, the capital stock in EMDEs expanded by nearly 44 percent over the first six years of an investment acceleration, almost 45 percent more than the expansion over a similar period outside an acceleration.


FIGURE 3.7 Total factor productivity growth, employment growth, and sectoral shifts around investment accelerations

- Productivity growth. Heightened output growth during an investment acceleration is also often accompanied by increased TFP growth (figure 3.7). During 1950-2022, TFP typically grew by 1.7 percent a year in EMDEs during accelerations, significantly faster than in other years. While TFP growth tended to return close to its preceding rate after accelerations in advanced economies, it dropped below its preacceleration pace in EMDEs. Along with TFP growth, labor productivity growth, one of the main drivers of per capita income growth, also significantly increases during these episodes.
- Employment growth. Investment accelerations were often accompanied by significant increases in employment growth (figure 3.7).

Globally, the employment rate expanded significantly by 0.3 percentage point a year during accelerations, compared with slight contractions in the six years before and after accelerations. Though still significant, the pickup in employment growth during investment accelerations in EMDEs was smaller than in advanced economies, while EMDEs avoided a decrease in the employment rate after accelerations and advanced economies did not.

Sectoral shifts. Investment accelerations are also associated with higher productivity growth through intersectoral resource shifts (Dieppe 2021; Hoyos, Libman, and Razmi 2021). During a typical investment acceleration, the composition of employment has moved significantly away from the agriculture sector toward manufacturing and services, and output growth in manufacturing and services has registered significant increases (figure 3.7). The pace of sectoral shifts has tended to gain momentum during accelerations as the growth rates of employment in the manufacturing and services sectors tend to be significantly higher than in other years. The reallocation of workers from less productive sectors to more productive sectors is a substantial source of productivity growthparticularly in recent decades in EMDEs, such as China. It is estimated, for instance, that such reallocations accounted for two-thirds of productivity growth in LICs in the decades leading up to the global financial crisis (Dieppe 2021).


Other macroeconomic and financial correlates




FIGURE 3.8 Macroeconomic indicators around investment accelerations

Consumption. During investment accelerations, both public and private consumption growth improved significantly, by about 1 and 1.6 percentage point a year globally, respectively (figure 3.8). In EMDEs, the increase in the growth of public consumption (including all government current expenditures) during accelerations was comparable to that in private consumption, whereas in advanced economies, public consumption increased much less. Both public and private consumption growth tended to fall back to preacceleration rates.








D. Cumulative change in output country group




E. Output growth around investment accelerations, by EMDE country group















E. Capital stock growth around investment accelerations, by income level







Fiscal positions. Fiscal balances have tended to improve during investment accelerations (figure 3.8). Globally the primary balance (which excludes net interest on government debt) shifted from a small deficit in the preceding six years to a small surplus during accelerations. In EMDEs, it remained unchanged, while the overall fiscal deficit narrowed by about 1 percentage point of GDP. During accelerations, the ratio of government debt to GDP fell by 9 percentage points both in EMDEs and globally, largely reflecting, in EMDEs, both faster GDP growth and improvements in primary balances. However, as output growth moderated after investment accelerations, improvements in fiscal and primary balances have tended to erode.

International trade. Trade growth has tended to increase significantly during investment accelerations, partly reflecting shifts of resources to the tradeable manufacturing sector and increased growth in imports of capital goods (figure 3.8; Irwin 2021; Lee 1995). Both import and export growth increased markedly during accelerations, with import growth roughly tripling the rate prior to accelerations. The surges in import and export growth were slightly larger in EMDEs than in advanced economies; the larger increase in import growth in EMDEs may partly reflect EMDEs' greater reliance on imports for capital goods (Bustein, Cravino, and Vogel 2013). As a result of the growth of imports relative to exports, current account deficits tended to widen somewhat in EMDEs and globally during and after accelerations.

Capital inflows. Capital inflows increased notably during investment accelerations (figure 3.8). In EMDEs, capital inflows rose by about 2 percentage points of GDP during accelerations, relative to their preceding levels, partly on account of increases in FDI inflows relative to GDP. Increases in capital inflows seem to have supported some investment accelerations in EMDEs—such as those in Türkiye in the 2000s and Poland in the 1990s (box 3.1). Increases in capital inflows were often sustained after the acceleration.

Credit and saving. Both domestic credit and gross domestic saving grew significantly faster during investment accelerations. In EMDEs, credit


growth increased by about 4.5 percentage points a year during accelerations, while the real interest rate fell by more than half. Growth of saving increased by 3 percentage points a year. The increases in both credit growth and saving growth were larger in EMDEs than in advanced economies. While saving growth tended to moderate after investment accelerations in EMDEs, credit growth tended to remain elevated. Accelerations that were supported by credit growth lasted longer and saw significantly higher output growth than accelerations that were not accompanied by credit growth.


Inflation and real effective exchange rates. Falling inflation rates have often preceded or accompanied investment accelerations (for example, Korea in the late 1990s; see box 3.1). Globally, annual inflation fell during 1950-2022, from about 7 percent before to about 4 percent during accelerations, while in EMDEs, it dropped from 8 percent to 6 percent. The low inflation rates were typically sustained after investment accelerations (especially after the 1980s).

Real effective exchange rates have not changed materially during investment accelerations, but rose slightly (statistically significantly) afterward, with domestic currencies thus appreciating in real effective terms. There is evidence that, at least in EMDEs, a competitive exchange rate can facilitate capital accumulation both through households' saving and investment behaviors and by expanding the tradeable sector, which supports investment growth.⁶ Some countries, such as Germany, Japan, and Korea, have at times relied largely on exports to achieve faster growth. These countries eventually had to allow their currencies to appreciate after the period of rapid growth (Rodrik 2010).

Investment accelerations have often been accompanied by improvements in productivity growth, stronger employment growth, and greater reallocation across sectors.







C. Change in labor productivity growth around investment accelerations




D. Change in employment rate around investment accelerations, by country group



⁶Rodrik (2008) argues that currency undervaluation helps the rapid development of the tradeable sector, which is more reliant on investment in EMDEs. Bleaney and Greenaway (2001) suggest that there are two reasons why currency overvaluation can hurt investment in Sub-Saharan Africa: first, overvaluation reduces the returns to investment in the tradables sector, and second, the accompanying current account deficit may cause a tightening of import licensing procedures, which further reduces the returns to investment. There are also drawbacks, such as increases in income inequality and lack of product diversification, associated with currency undervaluation (Bergin 2022; Ribeiro, McCombie, and Lima 2020).







Development outcomes


FIGURE 3.9 Development outcomes during investment accelerations

Poverty and inequality. During investment accelerations, more progress has often been made in reducing both poverty and inequality (figure 3.9). The share of the population in extreme poverty barely changed in the six years before a typical investment acceleration in 1950-2022, but declined significantly, by 0.2 percentage point per year, during the acceleration. Similarly, the Gini coefficient, which measures income inequality, fell significantly during the typical investment acceleration after rising slightly in the years preceding it. Measured at national poverty lines, the fall in poverty was even more pronounced with a 0.5 percentage point improvement in the national poverty headcount ratio per year.

Income convergence. These gains in poverty and equality are underpinned by the rapid increase in per capita output growth during investment accelerations, which led to faster income convergence toward advanced-economy income levels. Specifically, the median per capita output growth in EMDEs was 0.6 percentage point higher than in advanced economies (4.3 percent compared with 3.7 percent). In contrast, EMDEs registered weaker per capita output growth than advanced economies in other years (1.8 percent versus 2.1 percent per year).

Access to infrastructure. Access to infrastructure improved during investment accelerations. For example, the share of the population with access to basic sanitation increased by 0.4 percentage point globally during investment accelerations, while the incidence of stunting among children aged 5 or younger fell by 0.6 percentage point. Since the 1990s, access to the internet has also tended to rise significantly during investment accelerations: 2.4 percent of the population per year gained access to the internet during a typical acceleration, two times the increase during the prior period.

Drivers of investment accelerations

A rich body of empirical research has shown that investment growth in a country is affected by both global (or regional) conditions and the country's



initial conditions, economic policies and institutional settings.⁷ However, this literature has not considered the roles of these factors in sparking investment accelerations. This section presents the results of a series of empirical exercises and compares these with insights from the country case studies (box 3.1) on how these factors help trigger investment accelerations.

Initial conditions


FIGURE 3.10 Initial conditions and the start of investment accelerations

Initial conditions have influenced the onset of investment accelerations (figure 3.10). For example, economies with higher institutional quality have been more likely to experience an investment acceleration: specifically, moving from the bottom quartile to the top quartile in institutional quality increases the probability of starting an investment acceleration by 5.6 percentage points. Similarly, a more undervalued currency is associated with a significantly higher likelihood of an investment acceleration, whereas overvalued currencies have often been a sign of macroeconomic and financial imbalances. In EMDEs, a competitive exchange rate can facilitate capital accumulation either by boosting higherincome households' propensity to save and invest or by supporting the tradables sector (Gluzmann, Levy-Yeyati, and Sturzenegger 2012, 2013; Guzman, Ocampo, and Stiglitz 2018). In both cases, maintaining a competitive currency may help initiate and sustain investment accelerations.

Benign global economic conditions, proxied by strong global output growth, also substantially increase the likelihood of an acceleration. In the sample period of this study, raising global GDP growth from the bottom to the top quartile from 2.1 percent to 3.5 percent—increased the









(2017) show how the slowdown in investment growth in EMDEs following the global financial crisis was driven by spillovers from slowing growth in advanced economies, heavier debt burdens, and falling commodity prices. Libman, Montecino, and Razmi (2019) show how capital stock accumulation is positively correlated with higher human capital endowments, exchange rate undervaluation, low capital-output ratios, and net capital outflows. Manzano and Saboin (2022) find that higher institutional quality is correlated with capital stock accelerations. 

C. Probability an acceleration will start, by global GDP growth



probability of starting an investment acceleration for an average economy by 4.7 percentage points. Several of the country case studies (box 3.1) illustrate how commitment to comprehensive reforms enables countries to seize on supportive external factors, such as high commodity prices or international assistance. The probability of an investment acceleration also increased significantly in countries with lower per capita income. For instance, the likelihood of an acceleration was about one-fourth higher in countries in the bottom quartile of income per capita compared with those in the top quartile.

Macroeconomic policies and structural reforms


FIGURE 3.11 Policy improvements and the start of investment accelerations

Investment accelerations have often been preceded or accompanied by policy measures to improve macroeconomic stability or reduce restrictions on cross-border trade or financial flows. An improved primary fiscal balance or reduced capital flow restrictions tended to precede or accompany about a third of investment accelerations during 1956-2017. Trade restrictions were relaxed by policy measures prior to 70 percent of accelerations in this period. The adoption or tightening of an inflation target was followed or accompanied by 10 percent of accelerations (figure 3.11).⁸

A combination of more stringent fiscal policies, the adoption of an inflation target, and structural reforms to promote trade and financial openness can raise the likelihood of an investment acceleration by more than might be deduced from the effects of each of these individual policy improvements in isolation. Using the sample of accelerations, it is estimated that if the primary balance and trade and financial openness indices were all improved by one standard deviation, there would be a marked increase of 9 percentage points in the probability of starting an investment acceleration. If these reforms were also accompanied by the adoption of an inflationtargeting regime, the probability would be raised by an additional 33 percentage points.9 These results underline the case for a comprehensive package of stabilization and reform policies to spark an investment acceleration.

The country cases also highlight the role of policies aimed at stabilizing the macroeconomy and implementing structural reforms, particularly when these are part of a comprehensive package, in initiating accelerations (box 3.1). In general, the country cases show that investment accelerations were preceded by at least one of the two types of policy intervention: those aimed at improving macroeconomic stability (such as Türkiye in the early 2000s) and those intended to address structural shortcomings (such as ending publicsector monopolies in India in the 1990s). Often, comprehensive packages containing both types of policy intervention (such as in Korea in the late 1990s and Morocco in the 1990s and 2000s) or preceded strong accompanied growth accelerations. Demonstrated commitment to such reforms allowed countries to seize favorable external conditions and turn them into investment accelerations.

Institutional quality

The effect of economic policies on the likelihood of accelerations depends on institutional quality. There was a greater likelihood that improved fiscal policies and trade reforms were associated with investment accelerations in countries with better institutions than in those with weaker institutions. Specifically, in countries with institutional quality in the top quartile of the sample, improvements in the primary fiscal balance or reductions in trade restrictions significantly increased the likelihood of starting an acceleration, whereas such policies had no statistically significant impact in countries where the quality of institutions was in the bottom quartile of the sample (figure 3.11).


Robustness

A broad array of robustness exercises was conducted, including employing different thresholds to identify investment accelerations; adding additional control variables to check whether the results were driven by global economic conditions or financial cycles; and using aggregate investment growth, rather than per capita investment growth (see annexes 3.3 and 3.4). These changes did not alter the headline results.


A. Share of investment accelerations preceded by fiscal or monetary policy improvements




C. Average marginal effect of an improvement in fiscal or monetary policy




E. Average marginal effect of an improvement in primary balance, by institutional quality







Policies to start investment accelerations

To promote investment accelerations, EMDEs need to implement a comprehensive package of policies, tailored to their specific circumstances. This package typically includes fiscal and monetary interventions, structural policies, and efforts to improve institutional quality (figure 3.12).

Fiscal and monetary policies

Both the empirical analysis and country cases highlight the important role that fiscal policy can play in sparking investment accelerations. Expenditure and revenue measures, and fiscal rules, can help improve fiscal positions.

Revenue measures that can improve fiscal balances include reforming tax administrations, enlarging tax bases, and increasing tax rates. In many EMDEs, particularly those in South Asia and Sub-Saharan Africa, revenue-to-GDP ratios are much lower than in advanced economies (World Bank 2015, 2016b). Eliminating tax exemptions and strengthening the administration of tax collection could improve fiscal positions by increasing revenues. Tax policies can also be used to improve incentives, particularly for investment in the private sector (Djankov et al. 2010). For example, the elimination of fossil fuel subsidies, together with the introduction of carbon taxes, can incentivize investment into energy-efficient technologies (World Bank 2023b).

Expenditure measures that can improve fiscal balances include eliminating distortive agriculture and fossil fuel subsidies, which currently account for sizable shares of government expenditure in many EMDEs. EMDEs can also enhance the efficiency and predictability of their expenditures. By eliminating wasteful spending and prioritizing public investment in assets such as productive infrastructure and human capital, through education and healthcare spending, they can improve fiscal positions and contribute to both investment accelerations and improved output growth. Efficient public investment in infrastructure ture can also crowd in private investment by

stimulating economic development (Ansar et al. 2016; World Bank 2023b).

Fiscal rules, over the past three decades, have reduced the volatility of fiscal policy in EMDEs and allowed governments to respond to adverse events countercyclically by conserving fiscal space (IMF 2022; Marioli, Fatas, and Vasishtha 2023). Fiscal rules that ensure that current expenditures are fully financed by revenues over the cycle can provide appropriate protection for public investment. By implementing fiscal rules and utilizing stabilization funds, commodity-exporting EMDEs can improve budget positions while reducing the procyclicality of fiscal policies (World Bank 2022e).

If excessive, government borrowing to fund deficits can put pressure on credit markets, tighten financial conditions, and crowd out private investment (Huang, Pagano, and Panizza 2020; World Bank 2023c). Conversely, improving fiscal positions can, under certain circumstances, boost (crowd in) private investment (Essl et al. 2019). This is particularly true for EMDEs that are in or near debt distress, as measures to improve their fiscal positions, when feasible, can yield benefits. In many EMDEs, fiscal policy in the near term needs to be calibrated to regain the ability to take appropriate expansionary measures when needed—creating so-called "fiscal space," which was eroded during the pandemic.

Monetary policy reforms, such as the establishment or reinforcement of central bank independence or the adoption of an inflation-targeting regime, may also be important to securing a stable macroeconomic environment that supports investment growth. Low and stable inflation in the medium term is a key requirement of macroeconomic stability and healthy investment growth.

Structural policies

A broad range of structural policies can promote investment accelerations.

Trade policy. Reducing restrictions on crossborder trade can play an important role in sparking investment accelerations. Such measures have significantly increased the likelihood of starting an investment acceleration and have often preceded accelerations, such as in India, Morocco, and Türkiye (box 3.1). In recent decades, tariffs have been lowered substantially in many EMDEs, but costly and widespread non-tariff barriers remain.

Easing these de facto restrictions, which include unwieldy customs procedures, poor trade-related uncompetitive domestic infrastructure, and logistics sectors, can significantly improve trade flows and support investment growth (Kose and 2023, Breton, Farrantino, Ohnsorge and Maliszewska 2022; World Bank 2021a). A comprehensive reform package could lower trade costs by more than one-half among the EMDEs that perform worst in shipping and logisticswhich account for the bulk of trade costs. Digital technology can facilitate many of these reforms, for example, by enabling the electronic processing of documents ahead of time, linking logistics services at borders, and helping lower barriers to entry for small and medium-sized enterprises.

The nontariff costs involved in border crossings can be reduced by lessening wait times created by lengthy administrative procedures and unclear or extensive documentation requirements. The WTO Agreement on Trade Facilitation, for example, provides a framework to simplify border procedures. Harmonizing inspection requirements and labeling standards between countries can also lower firms' costs and smooth border crossings (World Bank 2021a). Regarding logistics, improving physical infrastructure, like ports, airports, and roads, can reduce travel time and variability.

Membership in trade agreements-for example, the African Continental Free Trade Area agreement-can help solidify trade facilitation reforms and lower tariffs. Further, trade treaties can boost economies of scale and lower costs by standardizing regulatory requirements across multiple jurisdictions. Trade agreements also promote regional and global value chain participation by codifying intellectual property rights, and competition and investment protocols. This can significantly benefit small countries and countries that are geographically isolated from trade hubs (Echandi, Maliszewska, and Steenbergen 2022; Moïsé and Le Bris 2013; World Bank 2020b).

Financial sector policies. Improvements in access to external finance have tended to raise the probability of starting an investment acceleration. Actions to enhance access to external finance include the loosening of regulations on capital flows (Alesina et al. 2020). Since restrictions on outflows tend also to discourage inflows, the easing of restrictions on both capital inflows and outflows will generally need to be considered (Chinn and Ito 2008; Lee 1997). Nevertheless, the easing of capital flow restrictions may need to be accompanied by measures to mitigate risks arising from instability in capital inflows and outflows, which could destabilize the domestic economy. Such measures include safeguards to prevent capital inflow surges from generating boom-and-bust cycles, as was experienced by Malaysia in the 1990s (box 3.1). A well-regulated domestic financial sector is essential. Also important are measures to reduce country risk, including sound macroeconomic policies (Fratzscher 2012; Koepke 2019).

Policies that help develop domestic capital markets can also support investment accelerations. Capital market development can improve access to credit and financing in local currency, especially long-term financing. Policies to promote capital market development include improving contract enforcement to reduce collateral requirements, mitigating country-specific risks or market failures through partial credit guarantees to intermediaries, and developing digital infrastructure to allow small firms and financial institutions to participate in financial markets at low cost (United Nations 2022; World Bank 2022d).

The establishment of local currency equity and debt markets can help attract institutional investors to EMDEs with less-developed financial intermediation infrastructure. For instance, pension funds and private equity firms, which tend to have higher risk tolerance, may provide financing in situations where traditional banks are unwilling to do so (United Nations 2022). Multilateral development banks play a critical role in supporting these markets by providing liquidity through innovative products, including catastrophe bonds, blue and green bonds, provisioning of loans in local currencies in the most illiquid markets and offering guarantees

against political and other noncommercial risks (World Bank 2015a, 2022d).

In many EMDEs, it is critical to improve the digital and technological infrastructure. This enhancement is essential to lower the costs of access to finance and running a business, and to enable rural residents to access broadband networks. Facilitating investment in digital infrastructure requires aligning regulations with international standards, encouraging competition among providers to lower prices and improve services, and educating the workforce in relevant skills (OECD and IDB 2016). Increasing access to the internet has been shown to boost foreign direct investment, increase the incomes of rural households, and lower poverty rates (Bahia et al. 2020; Mensah and Traore 2022).

Institutional quality

In EMDEs with better institutions, particularly those emphasizing the improvement in law and order and property rights protection, the likelihood of initiating an investment acceleration is higher. Additionally, in such environments, policies have been more effective in leading to investment accelerations. The potential for institutional improvements in EMDEs is indicated by the fact that the quality of institutions is much lower than in advanced economies (figure 3.12).

Policymakers can improve institutions by, for example, defining property rights more clearly and protecting them more effectively, increasing the independence of the judiciary and strengthening the rule of law, and improving the enforcement of contracts. In many EMDEs, reforms are also needed to improve and unify regulatory and institutional structures, which are often fragmented, to help ease excessive constraints on private investors and businesses, and to ensure the effective enforcement of necessary regulations.

To enhance the quality of public infrastructure investment, countries can establish public investment management systems, robust project appraisal systems, and effective procurement and monitoring frameworks to mitigate the problems of asymmetric information and moral hazard (Gardner and Henry 2021; Kim, Fallov, and Groom 2020). Public-private partnerships are commonly utilized for delivering public investment and services, while limiting fiscal risks, provided that a robust framework of contract preparation, procurement and management is in place (Dappe et al. 2023; Dappe, Melecky, and Turkgulu 2022; Engel, Fischer, and Galetovic 2020). These reforms tend to be especially important in LICs, where regulatory frameworks are often inadequate (World Bank 2020a). Countries with better governance of public investment projects tend to register larger improvements in macroeconomic and fiscal outcomes (Schwartz et al. 2020).

Interventions at the micro level


In addition to macro-level policy interventions, micro-interventions also play a pivotal role in supporting investment, especially in the private sector. For instance, training and mentorship programs targeted at entrepreneurs can enhance their capabilities in scaling up their businesses, adopting new technologies, and conducting longterm profitable investment (Donald et al. 2022; Karlan, Knight, and Udry 2012; McKenzie and Woodruff. 2014). Providing financial education to the general public can improve financial literacy, which is positively correlated with planning for savings and wealth accumulation (Hastings, Madrian, and Skimmyhorn 2013; Kaiser and Menkhoff 2017).

Designing a policy package

Policies to accelerate investment need to take account of country-specific conditions, be formulated in a well-designed package, and be carefully sequenced. The empirical analysis and country case studies demonstrate the importance of combining policies that enhance macroeconomic stability with policies that address structural barriers facing private-sector development and institutional weaknesses. Country experiences, such as those in Korea in the late 1990s and Türkiye in the early 2000s, support the view that a comprehensive package of policies can be potent in triggering an investment acceleration.

When designing a policy package, the sequencing of measures should be carefully planned. For example, fiscal measures may need to take precedence in countries with significant fiscal challenges. The implementation of institutional policies, including measures to improve the business climate and regulatory structures, may need to be advanced particularly in countries that have difficulty mobilizing private investment. Policies to strengthen the regulation of the financial system and reform exchange rate arrangements may need to be implemented before the liberalization of capital flows. Such careful sequencing helps countries gird against potential disruptions that could otherwise imperil reform efforts, and lays the groundwork to take advantage of any favorable turn in the external environment.

In the absence of additional policy reforms, potential output growth in EMDEs is projected to decline from an annual average of 4.9 percent in 2011-21 to 4.0 percent a year in 2022-30 (figure 3.13; Kose and Ohnsorge 2023). Nevertheless, if the EMDEs that registered an investment acceleration since 2000 were able to spark another such episode between 2022 and 2030, their annual potential output growth would be 0.3 percentage point higher than projected in the baseline.¹⁰ Furthermore, in a scenario where all EMDEs replicated their best 10-year performance in labor force participation reforms, as well as health and education improvements, potential growth for 2022-30 could increase by 0.5 percentage points per year higher, reaching 4.6 percent. This increase would almost eliminate the decline projected in the baseline (figure 3.13).

Conclusion

Raising investment growth is a critical objective for EMDEs. They have significant investment needs to enable them to deliver sustainable and inclusive output growth, cope with climate change, and make progress toward broader development goals. Nevertheless, EMDEs face many obstacles in seeking to accelerate investment: the near-term investment growth outlook is weak, long-term growth prospects have deteriorated, fiscal resources are limited, and external borrowing costs are elevated.

This chapter has presented the first study of investment accelerations using a large sample of countries over an extended period. Investment accelerations are often associated with much improved macroeconomic and development outcomes. The median annual growth rate of investment jumped to 10.4 percent during these episodes, three times the median in other years. Investment accelerations also coincided with substantial increases in output growth coming alongside faster capital accumulation and growth of TFP and employment, relative to nonacceleration years. In addition, poverty and inequality declined during these episodes.

These results collectively suggest a strong association between investment accelerations and improved macroeconomic and development

outcomes. However, it is important to highlight that they do not imply a one-way causal link. Indeed, there can be self-reinforcing dynamics between investment accelerations and other beneficial developments during these episodes. That said, the regular coincidence of investment accelerations and transformative phases of macroeconomic and developmental progress underscores the critical importance of periods of rapid and sustained investment growth.

National policies have played an important role in sparking investment accelerations. For example, both fiscal consolidation measures and structural reforms to liberalize international trade and financial flows have facilitated investment accelerations. However, while individual policy can help ignite accelerations, measures comprehensive packages of measures have tended to be more effective. In addition, an enabling institutional environment has tended to significantly amplify the impact of policies on investment growth and increase the likelihood of accelerations. A country that is bolstering its institutions, fostering macroeconomic stability, and demonstrating commitment to structural reforms is particularly well placed to turn supportive external conditions into а transformative investment acceleration.

To boost private capital mobilization, multilateral development banks (MDBs) can offer various financial instruments and support (G20-IEG 2023). providing These include credit enhancement and disaster risk management instruments, enhancing liquidity in local-currency debt and equity markets in EMDEs with lessdeveloped financial markets, and promoting innovative investment products such as blue and green bonds. In situations where market failures prevent investors from insuring risks, MDBs can also offer loan guarantees. Additionally, MDBs can provide technical assistance by advising governments on creating the regulatory and institutional framework for well-functioning markets. This assistance extends to supporting the formulation of prudent fiscal policies, and providing guidance on achieving the energy transition and facilitating adaptation to climate change.

BOX 3.1 Sparking investment accelerations: Lessons from country case studies

Investment accelerations often have been preceded by at least one of two types of policy intervention: measures to improve macroeconomic stability and reforms to address structural problems. While each type of policy measure has helped trigger investment accelerations, comprehensive packages of policies that combine both types appear to have sparked faster investment and output growth than might have been expected from the individual effects of each type of measure. A benign external environment has also played a crucial role in catalyzing investment accelerations in most cases.

Introduction

The empirical analysis in this chapter documents the common features of investment accelerations—periods in which there are sustained increases in investment growth to a relatively rapid rate—and the policies that have been associated with them. It also highlights some substantial differences across investment accelerations. This box presents a brief account of notable investment accelerations in select countries. Specially, it aims to answer the following questions:

- What types of policy changes have triggered investment accelerations?
- How have the macroeconomic implications of investment accelerations differed depending on the underlying policy drivers?

The box focuses on 13 investment accelerations in 10 countries (tables B3.1.1, B3.1.2, and B3.1.3): Chile (1986-93), Colombia (2001-07), India (1994-99), Malaysia (1988-97), Morocco (1996-2009), Poland (1992-2000 and 2003-08), Republic of Korea (1985-96 and 1999-2007), Türkiye (2003-08), Uganda (1993-2012), and Uruguay (1991-98 and 2004-14).^a

East Asia and Pacific

Malaysia (1988-97)

Economic performance. Malaysia experienced an investment acceleration from 1988 to 1997. Annual

investment growth averaged 17.9 percent during this period, exceeding the level in other years by 20.9 percentage points (figure B3.1.1). Private investment growth increased more than public investment growth. Both credit growth and capital inflows played major roles in triggering this episode. During the acceleration in investment, output growth averaged 9.2 percent, enabling Malaysia to attain upper-middle-incomecountry status in 1992.

Policy drivers. The 1988 acceleration was triggered by policy changes that reduced restrictions on capital flowing in and out of the country (so-called capital account liberalization), which translated into a sharp increase in capital inflows and improved access to domestic credit, as well as structural reforms in the Fifth Malaysia Plan. Net capital inflows increased from -2 percent of GDP (that is, a net outflow) in 1988 to 16 percent at the peak in 1993, and the financial sector undertook an expanding array of activities that increased credit flow especially through bank lending (Ghani and Suri 1999). With improved access to credit and foreign capital, exports of manufactured goods rose (Naguib and Smucker 2009). A currency devaluation and tax reform improved the business climate while public revenue shortfalls were prevented through the elimination of tax loopholes (Somogyi 1991). However, the episode was not accompanied by policy changes to control financial excesses associated with the rapid opening of the capital account, a major factor in the financial crisis of 1997.

Republic of Korea (1985-96 and 1999-2007)

Economic performance. The Republic of Korea experienced two investment accelerations since the 1980s—one in 1985-96 and the other in 1999-2007. Investment growth surged during both accelerations, reaching 9.2 percent a year (figure B3.1.1). Output growth picked up by 4 percentage points per year during the accelerations, relative to other years. While capital accumulation had played a large role in Korea's growth miracle since the 1960s, the two episodes were


FIGURE B3.1.1 Investment accelerations in the Republic of Korea and Malaysia


Malavsia

Malaysia experienced an investment acceleration from 1988 to 1997. In that episode, private investment growth increased more than public investment growth. Both credit growth and capital inflows played major roles in triggering this episode. The Republic of Korea experienced two investment accelerations-in 1985-96 and in 1999-2007. While capital accumulation played a large role in Korea's growth miracle, the two episodes were also associated with faster growth of employment and productivity.










C. Net capital inflows and public and private investment growth in Malaysia




D. Output and investment growth in the Republic of Korea

also associated with much faster growth of employment and productivity, and improvements in human capital (Rodrik 1995; Kim and Lau 1994).

Furthermore, enhanced price stability, strengthened fiscal positions, and improved current account balances accompanied both accelerations: on average across the two accelerations, inflation fell to 4.3 percent; government debt declined by 15 percentage points of GDP; the primary balance was in surplus by 2.4 percent of GDP and the current account balance was in a slight surplus of 0.9 percent of GDP. A notable 8.3

percentage point increase in annual private investment growth underpinned both acceleration episodes. Korea attained high-income-country status in 1995, fell back in 1998 because of the 1997 Asian financial crisis, and then regained high-income status in 2001.

Policy drivers. The 1985 acceleration was preceded by a comprehensive set of macroeconomic stabilization policies. First, to curb inflation that was partly driven by the government-led growth strategy in the late 1970s, fiscal policy was tightened based on a balanced budget principle. This ended the subordination of

monetary policy to government financing (Koh 2007; Cho and Kang 2013). Second, the number of price controls was reduced, and the Monopoly Regulation and Fair-Trade Act was established to ensure market competition (Nam 1988). Third, restrictions on imports were loosened which helped relieve pressure on inflation by promoting domestic competition (Dornbusch and Park 1987; Koh 2010).

Against a backdrop of broader measures to bolster macroeconomic stability, the acceleration that began in 1999 benefited from structural reforms to address financial and corporate sector problems that contributed to the 1997 crisis. These included comprehensive steps to liberalize capital markets and foreign investment (Lee 2013; Vashakmadze et al. 2023). Extensive restructuring of corporates and financial institutions also strengthened financial soundness, governance, and profitability. Notably, reforms geared toward Chaebol groups (familycontrolled large conglomerates) required their affiliated firms to exit nonviable businesses, which improved loan availability for smaller firms (Krueger and Yoo 2002). In addition, a floating exchange rate system was adopted in late 1997, and an inflation-targeting regime with enhanced central bank independence was established in 1998.

Europe and Central Asia

Poland (1992-2000 and 2003-08)

Economic performance. Poland experienced two investment accelerations, during 1992-2000 and 2003-08 (figure B3.1.2). During these accelerations there were sharp increases in both investment growth (which averaged 10.4 percent per year) and output growth (which averaged 5 percent per year). In contrast, in non -acceleration years since 1980, investment fell 3 percent per year and output declined 0.7 percent per year. Both private and public investment growth rose sharply in these episodes, with the 2003 episode driven by a more pronounced increase in public investment. The two also accompanied accelerations were by an improvement in the fiscal position and an uptick in net capital inflows. Inflation declined notably during the 1992 acceleration.

Policy drivers. The 1992 acceleration in Poland was preceded by reforms to stabilize the economy and structural policy shifts that helped transition from a

centrally planned economy toward a market-oriented one. Prior to the 1992 acceleration, the collapse of the Soviet Union caused output and investment to plummet and inflation to skyrocket in Poland. To curb inflation, a stabilization program was employed to tighten monetary policy, restrict credit flow, and enhance central bank independence. The exchange rate system transitioned from a fixed regime in 1990 to a crawling peg in 1991, and then progressively to a fully floating regime in 2000.

improved Fiscal sustainability because of comprehensive set of interventions: cuts in subsidies and spending by public enterprises; the introduction of personal, corporate, value added, and excise taxes; the implementation of a more targeted system of social transfers; and sizable debt reliefs granted by the Paris Club (Berg and Blanchard 1994; World Bank 2022c). Poland also undertook structural policy changesliberalizing international trade to become a key exporter to Western Europe, encouraging capital inflows (especially FDI), privatizing state-owned enterprises, recapitalizing the financial system, and lowering entry barriers for new firms (Georgiev, Nagy-Mohacsi, and Plekhanov 2017). Private sector development was also supported by capital market deepening, reinforced by the creation of regulatory bodies, the Stock Exchange, and an increasing role of foreign banks (de Haas and van Lelyveld 2006).


The 2003 acceleration was triggered by reforms tied to Poland's EU accession process which granted the country access to the single European market and additional EU structural funds (IMF 2003; IMF 2008; World Bank 2022b). To become an EU member, Poland maintained prudent fiscal policy and transitioned to an inflation-targeting regime in 1998. Lower corporate income taxes and research and development tax allowances were introduced to promote investment (Murgasova 2005).

Attaining full EU membership accelerated Poland's structural changes and integration with the global economy. The EU accession process led to improvements in institutional quality as Poland aligned policies and regulations to European standards, privatized the telecommunications and energy sectors, strengthened banking regulation, and improved access to public infrastructure (Bruszt and Campos 2016). Labor market policies became more flexible. Capital

inflows surged as Poland integrated further into the supply chains of Western Europe (Georgiev, Nagy-Mohacsi, and Plekhanov 2017).

Türkiye (2003-08)

Economic performance. Türkiye experienced an investment acceleration during 2003-08. Average investment growth rose to 14.3 percent per year during the acceleration, compared with 4.6 percent in other years (figure B3.1.2). Output growth reached more than 6 percent per year during this episode, up from 3.7 percent per year in other years. During this period, the primary balance improved, and inflation was brought

under control—falling from 65 percent in the six years before the acceleration to about 11 percent during the acceleration. Both private and public investment growth surged to similar degrees, while credit growth and net capital inflows more than tripled. Rapid output growth allowed Türkiye to attain upper-middle-income status in 2004.

Policy drivers. Policy reforms implemented in the early 2000s, accompanied by a benign external environment, laid the foundation for the 2003 acceleration. Prior to the acceleration, a series of macroeconomic stabilization policies were implemented in response to the 2000-01

economic crisis. Fiscal discipline was established with a primary surplus target of 6.5 percent of GNP, and the central bank became an independent institution (IMF 2007). The result was a virtuous cycle of disinflation, lower interest rates, and higher economic growth (Macovei 2009). These macroeconomic policies were complemented by structural reforms in several areas, including enterprise restructuring and privatization, improvements to the business climate, trade liberalization, labor market liberalization, and comprehensive reform of the banking sector. As a result, both access to credit and foreign direct investment inflows improved (World Bank 2008).

Latin America and the Caribbean

Uruguay (1991-98 and 2004-14)

Economic performance. Uruguay experienced two investment accelerations: 1991-98 and 2004-14. Average annual investment growth reached 10.3 percent, exceeding the level in non-acceleration years by 14.7 percentage points (figure B3.1.3). Output growth rose to 5 percent per year during the acceleration episodes (from near zero in non-acceleration years) as both employment and productivity growth surged. In both episodes, private investment grew much faster than public investment. Each acceleration was accompanied by improved macroeconomic conditions, including lower government debt, subdued inflation, larger primary surpluses, and higher credit growth compared with non-acceleration years. Uruguay attained high-income-country status in 2012.

Policy drivers. Following a period of stagnation between 1983 and 1990, policies to stabilize the economy and promote trade laid the foundation for the 1991 acceleration (Marandino and Oddone 2019). Fiscal policy measures included reducing external debt by 5 percentage points of GDP and restructuring short-term debt through the 1991 Brady Plan, as well as broader fiscal consolidation (Rial and Vicente 2003). Following high inflation in the 1980s, these fiscal adjustments fed into a price stabilization plan which also included a preannounced crawling exchange rate peg (Peluffo 2013). The country's first Central Bank Act was approved in 1995 to strengthen monetary policy and establish limits on central bank financing of the public sector. The 1991 acceleration was also

associated with further trade liberalization, marked by the signing of the Treaty of Asunción that formed the Southern Common Market.

The 2004 acceleration coincided with a series of macroeconomic and structural policy reforms. After a major banking crisis in 2002 and several external shocks between 1999 and 2001, the government adopted a range of measures to improve macroeconomic stability and debt sustainability (de la Plaza and Sirtaine 2005; Marandino and Oddone 2019). Fiscal consolidation and better debt management were combined with monetary policy measures including greater exchange rate flexibility, adoption of an inflation target, and enhanced central bank independence. Banking regulations were introduced in 2008 to mitigate risks associated with currency mismatches between banking sector assets and liabilities (Marandino and Oddone 2019).


This acceleration episode was also supported by structural reforms that improved the investment climate. These included strengthening the national investment office and improving physical infrastructure and the business environment (IMF 2008, 2010). The 2004 acceleration was accompanied by elevated agricultural commodity prices, favorable global financial conditions, and stronger regional trade linkages. Late in the 2000s investment acceleration, Uruguay regained an investment grade sovereign rating (Che 2021).

Colombia (2001-07)

Economic performance. Colombia experienced an investment acceleration between 2001 and 2007. Annual investment growth reached 12.7 percent during the acceleration, exceeding the level of non-acceleration years by 10.3 percentage points (figure B3.1.3). Output growth averaged 4.5 percent during the investment acceleration compared with 3.3 percent outside of that period. During the acceleration, private investment grew over six times faster than during non-acceleration years, at 13.8 percent, while public investment growth increased from 4.2 percent to 6.1 percent. Inflation declined to single digits in the year before the acceleration for the first time in more than two decades. The overall fiscal deficit was less than 1 percent of GDP by 2004, while the primary balance reached a surplus. Government debt fell from 48 percent of GDP at its peak in 2002 to 33 percent of GDP in 2007.

Uruguay experienced two investment accelerations: in 1991-98 and 2004-14. Private investment grew much faster than public investment during the two episodes. Both accelerations were accompanied by more favorable macroeconomic conditions, including lower government debt, subdued inflation, larger primary surpluses, and higher credit growth. Colombia experienced an investment acceleration between 2001 and 2007. During the acceleration, private investment grew more than six times faster than during non-acceleration years, while public investment growth increased from 4.2 to 6.1 percent. Both employment and TFP grew strongly.

Policy drivers. The 2001 acceleration came after a difficult decade and was preceded by a series of reforms that significantly improved macroeconomic stability. First, a floating exchange rate regime was introduced in 1999 that helped reduce the impact of shocks on international reserve buffers. Second, in 2000, inflation targeting was adopted, accompanied by several legal measures to improve central bank independence and transparency (IMF 2006a). Third, on the fiscal front, government finances were improved by the introduction of tax reforms in the early 2000s, spending

restraint, a pension reform, and a series of reforms to public spending management (Clavijo 2009; IMF 2006b). Rising oil prices increased fiscal revenues during this period. Colombia's external position was also boosted by strong export growth in industrial goods. Domestic financial markets were deepened via the privatization and liquidation of public banks and improved supervision (IMF 2005, 2006b). Significant improvements in administrative procedures also supported the business environment.

Chile (1986-93)

Economic performance. Chile experienced an investment acceleration between 1986 and 1993 which resulted in annual average investment growth of 12.3 percent—8.4 percentage points higher than in other years (figure B3.1.4). Output growth doubled during this episode, exceeding 7.6 percent per year, supported by both productivity and employment growth. Broad improvements macroeconomic in indicators accompanied this acceleration. These included the primary balance moving from deficit to surplus, a significant decline in inflation (from almost 20 percent in the first year of the acceleration to 12.7 percent in 1993), and a substantial improvement in the current account from -6 percent of GDP in 1986 to -0.25 percent of GDP at its peak in 1991. Trade openness (the sum of exports plus imports relative to GDP) increased from about 50 percent of GDP to 63 percent of GDP at its peak in 1989, and proportion of exports from sectors other than mining increased by about 5 percentage points. Chile became an upper-middleincome country in 1993.

Policy drivers. Several policy interventions preceded or coincided with the acceleration. After the 1982 debt crisis during which output contracted by 15 percent, macroeconomic stability was an essential enabler (De Gregorio 2005; Corbo, Hernández, and Parro 2005). After the debt crisis, Chile took steps to reduce government borrowing, resulting in several consecutive years of fiscal surplus. The public debt-to-GDP ratio declined to roughly 50 percent by 1993, from 120 percent in 1986. The adoption of an inflation targeting regime in 1991 also helped to bring inflation under control.

Structural reforms—including trade liberalization, pension system reform, and banking sector reforms were essential to sparking the investment acceleration (Corbo, Hernández, and Parro 2005, Gallego and Loayza 2002). The 1981 pension reform from a pay-asyou-go system toward a capitalization scheme helped deepen domestic financial markets by creating an additional source of credit for the private sector (Edwards 1998). Reforms that bolstered the ability of banks to provide credit and set up bankruptcy proceedings with well-defined property rights were critical factors in improving resource allocation (Bergoing et al. 2002).

Middle East and North Africa

Morocco (1996-2009)

Economic performance. Morocco underwent a significant economic transformation during the investment acceleration between 1996 and 2009 (figure B3.1.4). Annual investment growth rose from 2.3 percent in non-acceleration years to 7.5 percent during acceleration years, with annual output growth improving from 3.2 percent to 5 percent (despite a brief recession in 1997 during which investment growth did not contract). The period coincided with improvements in the fiscal position, external balance, and productivity growth, as well as higher credit growth. Both inflation and government debt (as a share of GDP) declined during the period.


Policy drivers. The acceleration followed and was accompanied by a range of fiscal and monetary reforms to foster macroeconomic stability (Harrigan and El-Siad 2010; IMF 2001, 2004). Fiscal revenue capacity was strengthened, including through the privatization of the telecommunications sector, tax reforms in the 1980s, and the strategic allocation of privatization revenues in 2001 (IMF 2001, 2004). During this period, improved fiscal capacity, exemplified by a large reduction in the external debt-to-reserves ratio, lessened marginal borrowing costs, allowing the government to finance much-needed social development initiatives.


Trade integration was strengthened by the Association Accord with the EU in 1996 and a free trade agreement with the United States in 2004. Morocco's trade openness surged by 31 percentage points of GDP during the acceleration. Financial reforms and price liberalization created a more conducive business and trade environment (Moreira 2019). Strategic policies supporting vital and internationally competitive sectors such as agriculture and renewable energy helped improve production (Paus 2012; Agénor and Aynaoui 2015). Other significant reforms included improvements in governance and competitiveness, measures to streamline public investment processes, and incentives to increase tourism revenues. This broad suite of growth-friendly reforms helped increase the netcapital-inflows-to-GDP ratio to 2 percent of GDP during the acceleration, from -2 percent prior to the episode (World Bank 2001; Achy 2011).

FIGURE B3.1.4 Investment accelerations in Chile and Morocco










C. Net capital inflows and public and private investment growth in Chile




D. Output and investment growth in Morocco

South Asia

India (1994-99)


Economic performance. India experienced an investment acceleration from 1994 to 1999 (figure B3.1.5). During this acceleration, driven mostly by the private sector, average annual investment growth reached 10 percent per year, about 5.9 percentage points higher than in other years. The government debt -to-GDP ratio was about 6 percentage points lower during this episode than in non-acceleration years, while the primary fiscal deficit and current account

deficit widened slightly. Net capital inflows to GDP improved slightly during the acceleration compared with those in the years before the acceleration while credit growth rose to over 7 percent compared with 4.8 percent in non-acceleration years. At the same time, TFP growth almost doubled during the acceleration, from 1.9 percent in nonacceleration years to 3.8 percent.


Policy drivers. The 1994 investment acceleration had its roots in reforms that started in 1991, addressing four major economic distortions (Ahluwalia 2002). First,

FIGURE B3.1.5 Investment accelerations in India and Uganda


India had an investment acceleration from 1994 to 1999. During this episode, driven mostly by the private sector, average annual investment growth reached 10 percent per year, while the government-debt-to-GDP ratio declined materially. Uganda's investment acceleration lasted from 1993 to 2012. The episode was accompanied by a significant reduction in inflation and an improved primary fiscal balance, as well as a notable increase in credit growth. Private investment also grew.




C. Net capital inflows and public and private investment growth in India Percent / Percent of GDP




D. Output and investment growth in Uganda

tariff and non-tariff barriers on imports were lifted, making it easier to import capital goods. Second, capital account restrictions were loosened to allow greater capital inflows. Third, state control of the banking and insurance sectors was reduced to facilitate greater competition and efficiency, leading to increased domestically supplied credit to the private sector.

Finally, most of the public sector monopolies were ended. Sectors reserved to public firms shrank from 18 important industries (including iron and steel, electricity, and telecommunications) to three (atomic energy, rail transport, and national defense-related aircraft and warships). A further reform was the transition to a market-determined exchange rate in 1993. These reforms promoted international investment and trade, and strengthened the private sector generally (Ahmad et al. 2018; Gupta et al. 2018).

Sub-Saharan Africa

Uganda (1993-2012)

Economic performance. Uganda, a low-income country, had a long period of investment acceleration between 1993 and 2012 (figure B3.1.5). Annual average investment growth, estimated at 10.9 percent

during the acceleration period, was 5 percentage points higher than during non-acceleration years. Output growth was similarly elevated during the acceleration, but to a lesser extent—averaging 7.4 percent in acceleration years, compared with 4.2 percent otherwise. The episode was accompanied by a significant drop in inflation, an improved primary balance, a sizable reduction in the debt-service-to exports ratio, and a notable increase in credit growth. Both private and public investment grew robustly during the acceleration. The proportion of the population in poverty fell from 68 percent in 1993 to 35 percent in 2013 (World Bank 2016).

Policy drivers. The 1993 acceleration was supported by a wide range of policies (World Bank 2007). Prior to the acceleration, Uganda committed to fiscal measures encompassing public enterprise and civil service reforms which helped stabilize the macroeconomy (Kuteesa et al. 2010; Mawejje and Odhiambo 2021). Public enterprise reforms, especially the privatization of key government-owned enterprises and the introduction of private sector participation in public utilities, sought to reduce the role of the government (Reinikka and Collier 2001; World Bank 2004). In addition, a comprehensive debt strategy formulated in 1991 strengthened debt management (Kitabire 2010). Monetary policy reforms focused on attaining a flexible exchange rate and price stability (Henstridge and Kasekende 2001).

A variety of structural reforms were implemented in the early 1990s to improve efficiency in the banking sector, liberalize the capital account, reduce trade barriers, and eliminate tax, legal, and other regulatory burdens on firms (Kuteesa et al. 2010; World Bank 2004). Debt relief initiatives and development assistance programs championed by the international community also played a significant role in supporting the acceleration. For example, Uganda was the first country to qualify for the Heavily Indebted Poor Countries debt relief initiative in 1998 and benefited from the Multilateral Debt Relief Initiative in 2006 (Andrews et al. 1999; Kitabire 2010). Uganda's participation in these initiatives reduced the debt-service-to-exports ratio by more than half, creating fiscal space that allowed more fiscal resources to be channeled into investment (Muwanga-Zake and Ndhaye 2001; Kitabire 2010).

Conclusion

These country studies show how initial conditions, together with comprehensive efforts to improve fiscal, monetary, and structural policies, can spark investment accelerations (tables B3.1.1, B3.1.2, and B3.1.3). The policy packages documented above allowed the 10 countries to seize favorable external conditions and turn them into accelerations. The case studies also demonstrate how such accelerations can be the source of sizable economic and development achievements.

The comprehensive policy packages overlapped considerably, even if the subsequent accelerations differed in some important dimensions (such as the split between private and public investment growth, or levels of credit growth). First, at about the start of each acceleration, improvements in the credibility and independence of monetary policy helped achieve lower and more stable inflation (for example, the Republic of Korea in 1998). Second, all accelerations were preceded by fiscal consolidation, either through stricter expenditure controls, the elimination of subsidies, tax reforms, or privatization of state-owned enterprises (for example, Colombia, India, or Uganda). Third, all accelerations were accompanied structural reforms. These encompassed trade and capital account liberalization efforts, the strengthening and deepening of financial markets and their regulation, and improvements to business climates, including policies to promote greater competition (for example, India, Poland in 1992, and Türkiye).

Investment accelerations were crucial for economic and human development. Output growth was substantially higher during these 13 accelerations than in nonacceleration years. Further, for many countries, productivity and employment growth was only positive, on average, during accelerations. Several countries either became high-income countries during the acceleration (for example, the Republic of Korea in 2001, Poland in 2009, or Uruguay in 2012), or saw sizable gains in the fight against extreme poverty (Colombia, India, Morocco, Uganda).

In some cases, the international community played a critical role in addressing long-standing debt problems, such that investment accelerations could take hold. For example, well-calibrated debt relief preceded or accompanied accelerations in Uganda and Uruguay.

ANNEX 3.1 Identification of investment accelerations

Definition. Investment accelerations are defined as episodes of rapid acceleration in investment per capita that are sustained for at least six years. Using per capita growth in investment takes into account the significance of population growth, which has averaged more than 2 percent in the typical EMDE between 1950 and 2022. Per capita growth rates also have a better link with GDP per capita growth, which is the focus of long-term growth analyses (Libman, Montecino, and Razmi 2019).

As suggested by Barro and Sala-i-Martin (1992) and Christiano and Fitzgerald (2003), economic indicators taken more than five calendar years apart are less influenced by business cycle fluctuations. According to Hausmann, Pritchett, and Rodrik (2005), output growth accelerations require heightened output growth to last at least eight years. Given the volatile nature of investment growth, the approach preferred here uses a time frame of a minimum of six years. In addition, the requirement that capital stock per capita at the end of an acceleration must exceed its pre-episode peak is added to ensure that the episodes identified are indeed accelerations and not merely periods of recoveries. The sensitivity analysis shows that shorter (or longer) periods of acceleration do not affect the main results of this chapter (see annexes 3.3 and 3.4 for details). Based on the length of six years and the sample's end year of 2022, the latest year an acceleration can start is in 2017. The distribution of episodes by country groups is shown in table A3.1.1, and the list of episodes in EMDEs detailed in table A3.1.2.

The chapter aims to identify the same type of large-scale investment acceleration with transformative development implications. To avoid pooling different types of accelerations, the same set of criteria detailed below is applied to per capita growth in investment in all economies in the sample:

• The average growth rate of investment over six years must be at least 4 percent a year.

- The average growth rate of investment over six years must be at least 2 percentage points higher than in the previous six years.
- The level of the capital stock per capita at the end of the acceleration must exceed its pre-episode peak.

The first two criteria are designed to identify rapid acceleration in investment per capita growth. The first criterion requires that growth is rapid, setting a threshold of at least 4 percent per capita growth per year. This rate corresponds to the long-run median growth rate of investment for the top onethird of countries in the sample.¹¹ The second criterion confirms that investment accelerates. It does so by requiring a minimum increase of 2 percentage points, which is the median difference in growth between two neighboring six-year periods for the top one-third of countries in the sample. Finally, the requirement that capital stock per capita at the end of an acceleration must exceed its pre-episode peak ensures that the episodes identified are indeed accelerations and not merely periods of recoveries. Three additional criteria are added to identify more reasonable episodes and starting years (see below).

Comparison with other identification approaches. The identification approach adopted here aligns with the existing studies on output and capital stock growth accelerations, but differs in two key dimensions: the duration of heightened growth required and the main criteria for identifying accelerations. First, all existing studies on accelerations typically adopt an eight-year framework without adapting to the volatile nature of investment growth (for instance, Libman, Montecino and Razmi, 2019; Manzano and Saboin 2022). Second, the values for various criteria detailed above are taken from sample statistics, while other approaches used ad-hoc values (for instance, Hausmann, Pritchett and Rodrik 2005; Jong-A-Pin and de Haan 2011). In addition, Libman, Montecino and Razmi (2019) study capital stock growth accelerations. Their approach differs slightly from the one used here in

how they identify the correct starting years (that is, using a break test to smoothed capital stock growth series) and the focus on capital stock per capita growth. The use of capital stock growth makes their set of accelerations less linked with output performance.

Additional requirements. A few additional requirements are added to avoid overidentifying investment accelerations and to identify more reasonable episodes and starting years. These requirements are specifically added to tailor the filtering approach to the volatile nature of investment growth. Firstly, to exclude episodes driven by short-term surges in investment, the approach mandates that investment growth must

be positive in at least five out of the six years of an acceleration period. Second, the investment per capita growth rate at the beginning of the six-year period should not be negative. Third, per capita investment has to accelerate and be higher in the second year of an episode than in the first year. Finally, if more than one year qualifies as the start of the investment acceleration episode, the first year that meets the criteria is identified as the start (Jong-A-Pin and De Haan 2008). The unconditional probability of experiencing an investment acceleration in a decade is calculated by dividing the number of identified investment accelerations by the total number of country-years in the sample (later converted to decades) during which an acceleration could occur.

ANNEX 3.2 Methodological annex

Data

Data for investment, GDP, capital stock, and population for the period 1950-2019 are sourced from the Penn World Table (PWT) 10.01 because this database covers many more countries than alternative databases. To update the investment data provided by PWT, investment growth data for 2020-22 is sourced from Haver Analytics, World Bank Development Indicators (WDI), and Global Economic Prospects (GEP). To compute per capita series of GDP and investment after 2019, population data are taken from the United Nations population prospects database. The final sample of economies includes 35 advanced economies and 69 EMDEs (table A3.1.1). These economies represent about 97 percent of global GDP since the mid-2000s (World Bank 2023a).

Data on the explanatory variables are taken from a variety of sources. Institutional quality is proxied by the "law and order" subcomponent of the PRS Group's International Country Risk Guide (ICRG). The undervaluation index is constructed following Rodrik (2008) using data from PWT. Global GDP growth is computed using GDP weights at average 2010-19 prices and market exchange rates. Primary balance as a share of GDP is taken from the IMF's World Economic Outlook. Inflation data are taken from Ha, Kose, and Ohnsorge (2021). Trade restrictions and inflation targeting indices are taken from the IMF structural reform database (Alesina et al. 2020) and IMF AREAER database. The capital account restrictions index is taken from (Chinn and Ito 2008). Additional covariates for the robustness checks include natural resource rent as a share of GDP from WDI; global recession years defined by Kose, Sugawara, and Terrones (2020); and global financial cycle factor, retrieved from Miranda-Agrippino and Rey (2020).

Methodology

The correlates and probability of an investment acceleration starting in a given year are estimated

using logit regressions. The following model is estimated:

 $Pr\left(Y_{i,t}=1\big|X_{i,t}\right)=\phi\left(\beta X_{i,t}\right),$

where Pr denotes the probability that a sustained investment acceleration takes place in country *i* in year t $(Y_{i,t})$, conditioned on a set of variables $(X_{i,t})$, and ϕ denotes the cumulative distribution function. Because there is some uncertainty around the precise starting date of an acceleration, the approach of Hausmann, Pritchett, and Rodrik (2005) and Libman, Montecino, and Razmi (2019) is followed: the dependent variable takes the value 1 in the year immediately before and the year immediately after the beginning of the episode, and 0 otherwise. Also, the years an episode cannot take place (that is, year two until the end of an episode, as well as the first and last five years of the sample) are excluded. Because of data limitations, the regressions cover the period 1985-2017. Furthermore, to prevent a small number of countries from having a large influence on the results, estimates are unweighted.

The analysis focuses on the effect of institutional quality (IQ) and economic policy reforms (EPR) on the likelihood that an investment acceleration occurs. In the model, the level of institutional quality, the economic policy reform indicator, and their interaction are included.

The model is:

$$Pr(Y_{i,t} = 1 | X_{i,t}) = \phi(\beta_0 + \beta_1 I Q_{i,t-1} + \beta_2 EPR_{i,t}) + \beta_3 [IQ_{i,t-1} * EPR_{i,t}] + \beta_4 CV_{i,t-1} + \mu_{i,t}),$$

where *CV* represents the control variables capturing the country's development status and domestic and external controls, such as the global GDP growth rate. Institutional quality is measured by the law and order subindex from ICRG. Economic policy reforms are calculated as the annual change in the trade restriction index and the Chin-Ito capital openness index (measured in percent), percentage points of GDP for the primary balance, or a dummy variable indicating whether a country has adopted an inflation target or tightened an inflation target since the preceding year.

Empirical results

Table A3.2.1 shows the results for the impact of institutional quality and control variables on the probability of an investment acceleration starting in the following year. Column (1) shows the main institutional quality variable, and controls for country-specific conditions that capture the development status (GDP per capita), level of capital (capital-to-output ratio), and the undervaluation index following Rodrik (2008). Columns (2) through (6) add additional control variables for global economic conditions (global GDP growth), economic stability (inflation rate), and the level of fiscal and external policies of this chapter. Based on these results and the limits that the level of fiscal and external policy place on the sample size, column (2) is the preferred baseline specification for the analysis of policy impacts on the probability of an investment acceleration.

Table A3.2.2 presents the impact of policy changes on the probability of an investment acceleration using the set of controls in column (2) of table A3.2.1. To simplify the interpretation of the results, the institutional quality variable and the policy change variables are demeaned. The results mirror those in table A3.2.1, showing that higher institutional quality, as well as the four policy changes presented in table A3.2.2, increase the likelihood of an investment acceleration. Furthermore, the impact of a policy is dependent on the level of institutional quality. For two policy changes, the interaction term between the lagged institutional quality variable and the policy change are significant. Column (5) includes all four policy reforms concurrently but does not include an interaction term with institutional quality.

ANNEX 3.3 Investment accelerations using different filtering algorithms

Table A3.3.1 displays the robustness of the identification approach when alternative parameter values of the minimum average investment growth rate and minimum length of investment acceleration are applied. Overall,

setting lower thresholds for growth rates during accelerations or using shorter acceleration durations result in a larger number of identified episodes. Despite variations in the number of episodes identified under different parameter combinations, including those based on aggregate rather than per-capita investment growth, the findings show sustained and heightened investment and output growth, which supports the use of the baseline approach.

ANNEX 3.4 Robustness exercises

The empirical results presented in annex 3.2 are robust to the use of alternative sets of episodes identified using different algorithm thresholds and duration parameters as well as controlling for additional variables. Table A3.4.1 reruns the main regression shown in table A3.2.2 using investment accelerations identified when alternative minimum duration length is required while holding the minimum required growth rate of 4 percent constant. Table A3.4.2 shows that the results are also robust to alternative minimum average investment growth thresholds. In table A3.4.3, the following additional control variables are included in the baseline regression: lagged per capita investment growth, the global recession year dummies defined in Kose, Sugawara, and Terrones (2020), the global financial cycle factor provided by Miranda-Agrippino and Rey (2020), and natural resource rents as a share of GDP (taken from the World Development Indicators). Table A3.4.4 repeats the baseline regression using investment accelerations identified using the baseline parameters applied to aggregate investment growth (that is, not in per capita terms). Across all robustness tests, the baseline results presented in table A3.2.2 do not change in a meaningful way.

FISCAL POLICY IN COMMODITY EXPORTERS An Enduring Challenge

Fiscal policy has been about 30 percent more procyclical and about 40 percent more volatile in commodityexporting emerging market and developing economies (EMDEs) than in other EMDEs. Both procyclicality and volatility of fiscal policy—which share some underlying drivers—hurt economic growth because they amplify business cycles. Structural policies, including exchange rate flexibility and the easing of restrictions on international financial transactions, can help reduce both fiscal procyclicality and fiscal volatility. By adopting average advanced-economy policies regarding exchange rate regimes, restrictions on cross-border financial flows, and the use of fiscal rules, commodity-exporting EMDEs can increase their GDP per capita growth by about 1 percentage point every four to five years through the reduction in fiscal policy volatility. Such policies should be supported by sustainable, well-designed, and stability-oriented fiscal institutions that can help build buffers during commodity price booms to prepare for any subsequent slump in prices. A strong commitment to fiscal discipline is critical for these institutions to be effective in achieving their objectives.

Introduction


FIGURE 4.1 Commodities: Price volatility and importance for exports and revenues

Commodity-exporting emerging market and developing economies (EMDEs) face significant fiscal challenges: Government debt in these countries has grown rapidly over the past decade-from about 33 percent of GDP in 2010 to about 58 percent in 2022, on average. Over the same period, their primary fiscal deficit (which does not include interest payments) averaged about three times that of commodity importers. Increased spending during the pandemic amplified the challenges confronting commodity-exporting EMDEs. The higher cost of servicing elevated debt levels, coupled with weaker growth prospects, is increasing the risk of debt distress among some of these economies (World Bank 2023). Along with the wide swings in commodity prices in recent years, these developments have brought to the fore the complex task of formulating fiscal policy in these economies (figure 4.1.A).

The main challenge faced by policy makers in commodity-exporting countries is coping with the swings in commodity prices; commodities are important sources of export and fiscal revenues for almost two-thirds of EMDEs, including threefourths of low-income countries (LICs) (figures 4.1.B and 4.1.C; World Bank 2022). Shocks to commodity prices are often large and persistent. Commodity prices have undergone frequent cycles over the past five decades, with the average cycle lasting almost six years (figure 4.1.D). Price slumps, on average, lasted somewhat longer (39 months) than booms (30 months), with prices falling and rising by 1 to 4 percent per month over the course of the average cycle, respectively (World Bank 2022).

Commodity dependence makes it harder for policy makers to formulate appropriate fiscal responses to commodity price fluctuations. The booms and busts in government revenues attributable to commodities tend to make fiscal policy both more procyclical and more volatile in commodity-exporting EMDEs, amplifying business cycles and harming growth.


Fiscal policy tends to be more procyclical—that is, expansionary in good times and contractionary in bad times—in commodityexporting EMDEs than in other EMDEs.¹ In commodity-exporting EMDEs, rising commodity prices can lead to procyclical increases in public spending and tax cuts. Conversely, declines in commodity prices can trigger procyclical tax increases and cuts in public expenditures as a result of reduced revenues from commodity production and exports. Moreover, because tax cuts and increases in public spending are generally easier to implement and more difficult to reverse, politically, than tax increases and reductions in public spending, government deficits and

(2019), as well as studies documenting evidence for select groups of commodity-exporting countries, including Bova, Medas, and Poghosyan (2016) and Céspedes and Velasco (2014).



debt positions tend to ratchet up, deteriorating from cycle to cycle. This secular deterioration, in turn, will make it more difficult to implement countercyclical fiscal policy in bad times. In sum, the procyclical tendency of fiscal policy in commodity exporters can magnify the impact of commodity price movements on economic activity, lead to inefficient stops-and-starts in government investment and in the provision of government services, and introduce a bias toward a deterioration in fiscal positions.

Fiscal policy tends to be more volatile in commodity-exporting EMDEs than in other EMDEs. Swings in commodity prices often result in highly volatile commodity-related fiscal revenues in these countries, leading to more volatile business cycles, which historically move in tandem with commodity price cycles.² Over the past three decades, output volatility in commodity-exporting EMDEs was more than double that in commodityimporting ones. Revenues derived from the commodity sector are also prone to policies associated with rent-seeking behavior. In addition, fiscal policy volatility can act as a transmission mechanism for the "resource curse"-the term coined to describe how commodity abundance, if not managed properly, can damage overall growth.³ Moreover, country-specific evidence suggests that large swings in commodity prices can be socially harmful, as shown in such indicators as poverty indices, highlighting the need for policies that mitigate the adverse effects of such price shocks (Álvarez, García-Marin, and Ilabaca 2021; Estrades and Terra 2012).

In the years ahead, the challenges associated with volatile and procyclical fiscal policies are likely to be compounded by sharp fluctuations in commodity prices as the impact of climate change on commodity markets becomes more pronounced.⁴ The continuation of procyclical and volatile fiscal policies would be detrimental to growth and impede progress in achieving climate and other broader development goals. As the experience of

recent decades shows, governments have difficulties in establishing macroeconomic policy frameworks that are effective in helping maintain steady growth in the face of commodity price swings (IMF 2015b; UNCTAD 2021; World Bank 2022).

This chapter presents a comprehensive study of the role of fiscal policy in commodity-exporting EMDEs. Specifically, it addresses the following three questions:

- How different has fiscal policy been, in terms of its cyclicality and volatility, in commodity-exporting EMDEs relative to other EMDEs?
- How have fiscal procyclicality and volatility affected economic growth in commodity-exporting EMDEs?
- Which policy interventions can help improve the quality of fiscal policy by reducing procyclicality and volatility?

Contributions to the literature. This chapter makes several contributions to the literature, including:

- Provides a thorough analysis of fiscal procyclicality and volatility. This is the first study that examines the implications of fiscal policy procyclicality and volatility together. The empirical literature treats the concepts of fiscal cyclicality and volatility as distinct. While closely following the literature in terms of the methodology for analyzing the two concepts, this chapter goes beyond the literature in examining the linkages between cyclicality and volatility. It provides fresh comprehensive evidence on fiscal procyclicality and volatility for a larger sample of commodity exporters (agricultural, metals, and energy exporters) and commodity importers than previously examined. It also documents how fiscal policy challenges have manifested themselves in different EMDE regions; previous studies have covered either a geographically limited set of countries or mainly oil exporters.
- Deepens the understanding of the implications of fiscal procyclicality and volatility for economic

growth. The chapter quantifies how procyclical fiscal policy responses have amplified business cycles in commodity-exporting EMDEs during periods of elevated commodity prices, taking a close look at the 2003-08 commodity price boom. It also quantifies the impact of higher output volatility on economic growth.

Presents a large menu of policies. The chapter presents a comprehensive analysis of policies to reduce fiscal policy procyclicality and volatility. It uses several empirical approaches to examine the roles of cyclical and structural factors in improving the design of fiscal policy. In addition, the chapter illustrates the use of sovereign wealth funds (SWFs) and fiscal rules in coping with fiscal procyclicality and volatility by examining the experiences of a set of commodity-exporting countries. Insights from these cases complement the findings of the broader quantitative analysis and help identify best practices in the implementation of these fiscal frameworks and institutions.

Main findings. This chapter offers five main findings.

Fiscal policy has tended to be both more procyclical and more volatile in EMDEs than in advanced economies, and more so in EMDE commodity exporters than commodity importers. The average correlation between the cyclical components of real GDP and real government spending-the measure of fiscal cyclicality-is 0.40 for EMDEs and near zero for advanced economies. Within EMDEs, the correlation is 0.46 for commodity exporters and 0.36 for commodity importers. Fiscal policy volatility, measured by the volatility of real government expenditure, is about 40 percent higher in EMDE commodity exporters than in other EMDEs. Moreover, among EMDEs, the larger the commodity sector, the more volatile fiscal policy has tended to be. Both fiscal procyclicality and volatility have generally trended downward in EMDEs in recent decades. However, procyclicality has fallen less among commodity-exporting EMDEs than in other EMDEs. Fiscal volatility has declined by nearly half in EMDEs over the past three decades, but it remains much higher among commodity exporters than in other EMDEs.

Fiscal procyclicality has amplified the business cycle in commodity-exporting EMDEs. Because of its procyclical nature, fiscal policy in the average EMDE commodity exporter has increased the impact of commodity price shocks on output by more than one-fifth, relative to the counterfactual in which fiscal policy does not respond to the price shock (box 4.1). In contrast, fiscal policy in advanced-economy commodity exporters has, on average, offset the output effect of a commodity price shock by reacting countercyclically. When hit by a commodity price shock of the same magnitude, the change in output in the average commodity-exporting EMDE has tended to be more than three times larger than that in its average advanced-economy counterpart, because of the opposite responses of fiscal policy in the two country groups.

Fiscal policy volatility has often amplified the business cycle and reduced growth. Fiscal policy volatility has tended to be associated with more volatile business cycles and lower economic growth. Results from a counterfactual exercise show that if the average commodity-exporting EMDE were to adopt the policies of an average advanced economy in three areas—exchange rates, capital flow restrictions, and the use of fiscal rules—it could have added about 1 percentage point in per capita growth every four to five years by reducing fiscal policy volatility.

Fiscal procyclicality and volatility are intertwined. Procyclicality and volatility have been strongly interlinked in EMDEs, especially commodity exporters, and driven by similar factors. EMDEs with more procyclical fiscal policies have tended also to display more volatile fiscal policies. Procyclical fiscal policy amplifies the business cycle, which in turn exacerbates the volatility of output. That is, given a shock to output, a procyclical fiscal response further exacerbates the business cycle. Hence, the initial shock to output has larger overall economic impacts when there also is procyclicality, thereby amplifying volatility. Structural policies can help reduce fiscal procyclicality and volatility. In particular, more stable governments, a stronger rule of law, greater capital account openness, fiscal rules to constrain government spending, and SWFs have all been associated with lower fiscal procyclicality. Fiscal rules and SWFs, essentially state-owned investment companies, have been most effective when surrounded by robust institutional frameworks. Stronger institutions and stricter constraints on fiscal policy have also been associated with less fiscal volatility. Specifically, the presence of fiscal rules, less constraints on international financial transactions, and flexible exchange rates are all associated with lower fiscal policy volatility. Medium-term expenditure frameworks can also help lower the procyclicality and volatility of fiscal policies by improving fiscal discipline.

Fiscal policy procyclicality

Conceptual definitions

Because the concept of fiscal policy cyclicality is important to guiding actual policy, it is critical to define policy cyclicality in terms of policy instruments (such as, government expenditure) rather than outcomes (such as, the fiscal balance). This chapter follows the literature and measures fiscal cyclicality as the correlation between annual percentage changes in real (primary) government expenditure and real GDP: a positive correlation indicates procyclicality.⁵ These correlations are calculated for 182 countries using annual data for 1980-2020.

Economies are placed into two groups— "commodity exporters" and "commodity importers"—by applying the classification criteria used in World Bank (2022). An economy is classified as a commodity exporter if, on average in 2017-19, either its combined exports of all

commodities accounted for 30 percent or more of its total exports or its exports of any single commodity accounted for 20 percent or more of its total exports. Economies are excluded if they reached either threshold only because of re-exports (imports that were exported without being changed). Based on these criteria, 92 economies are classified as commodity exporters of which 87 are EMDEs and five are advanced economies. Commodity importers are economies not classified as commodity exporters (table A4.3.1). The panel is unbalanced because some countries do not have data for the whole sample period.


Basic features of procyclicality


The analysis of correlations produces four stylized facts.


- In the period 1980-2020, fiscal policy in EMDEs has been procyclical while that in advanced economies has been acyclical (figure 4.2.A). The correlation between the cyclical components (derived using the Hodrick-Prescott filter) of real government expenditure and real GDP for EMDEs is 0.40, while that for advanced economies is slightly negative.
- Although fiscal policy in both commodity exporters and commodity importers has been procyclical among all EMDEs in the sample, commodity exporters are 30 percent more procyclical than commodity importers on average (figure 4.2.B). The correlation between the cyclical components of real government spending and real GDP for commodity exporters is 0.46 compared with 0.36 for commodity importers, with both coefficients as well as the difference between them being statistically significant. This procyclical behavior has been widespread across all EMDE regions (figure 4.2.C).
- The degree and nature of fiscal procyclicality have varied across country-income groups. Fiscal procyclicality in LICs and fragile and conflict-affected situations (FCSs) was higher than in lower- and upper-middle income countries, while in high-income countries fiscal policy was countercyclical (figure 4.2.D).


B. Fiscal procyclicality: EMDE


C. Fiscal procyclicality in commodity exporters, by regions




D. Fiscal procyclicality in commodity exporters, by country-income groups



Fiscal procyclicality has declined over the past four decades. To examine the evolution of fiscal procyclicality, the sample is split into two subperiods: before and after 2006. This division reflects the observed increase in the willingness and ability of countries to pursue countercyclical fiscal policies following the 2007-09 global financial crisis (Alvarez and De Gregorio 2014; Végh and Vuletin 2014). Fiscal procyclicality in commodity exporters has been falling over the past decade-and-ahalf. Nevertheless, procyclicality in commodity exporters still prevails and has fallen much less than in commodity-importing countries (which are, on average, acyclical since 2006) (figure 4.2.E). The fraction of countries running procyclical fiscal policies has declined over the past few decades. This decline was more pronounced for commodity importers (from 33 percent in the mid-1990s to 24 percent in 2021) compared with commodity exporters (from 40 percent in the mid-1990s to 36 percent in 2021) (figure 4.2.F).

Determinants of fiscal procyclicality

To assess how fiscal cyclicality has varied with macroeconomic and institutional features of countries, this section first compares fiscal cyclicality across different groups of countries. It then presents a cross-country regression analysis to disentangle the roles of key factors in driving procyclicality.

The county groupings are based on certain macroeconomic characteristics, including the degree of capital account openness, the exchange rate regime, and the level of external debt. In addition to these macroeconomic characteristics, the degree of fiscal procyclicality can also depend on political economy considerations and institutional features. The choice of these variables is guided by the literature on fiscal procyclicality.

Restrictions on international financial transactions. Countries with more restrictions on the capital account tend to have more limited access to international financial markets, which makes the cost of borrowing more expensive. This may increase the procyclicality of fiscal policy by making the government's access to funds particularly limited during recessions, forcing government expenditures to shrink, thus amplifying the economic downturn and the cycle.⁶ And the data indeed show that fiscal policy in commodityexporting countries with more capital account restrictions has tended to be more procyclical than in those with fewer restrictions (figure 4.3.A).7 On average, the correlation between cyclical components of real government spending and real GDP for countries with more capital controls is 0.51 compared with 0.33 for countries with fewer capital controls; the difference between the correlations is statistically significant.

Exchange rate regime. Flexible exchange rates are often associated with greater fiscal discipline

because of the immediacy of the repercussions of imprudent fiscal policies (Tornell and Velasco 2000). It is likely, then, that the degree of fiscal procyclicality is higher in countries with fixed exchange rate regimes. Indeed, the correlation between the cyclical components of government spending and GDP is higher (0.46) under fixed exchange rate regimes than under flexible exchange rates (0.36)—although the difference between the two is not statistically significant (figure 4.3.B).

External debt. Fiscal cyclicality is found not to have varied significantly with the level of external debt over the sample period. The correlation between cyclical components of real GDP and real government spending is essentially the same for countries with low and high external debt.⁸

Political economy factors. Extensive research has documented the role of political variables in driving fiscal procyclicality. Political pressures in good times tend to prompt policy makers to reduce primary surpluses, by reducing taxes or increasing spending. Given that more volatile primary surpluses offer more chances of fiscal appropriation, the more volatile output and therefore the tax base are, the more procyclical will fiscal policy tend to be (Talvi and Végh 2005).

The dispersion of political power—the so-called voracity effect, in which various fiscal claimants (including government ministries, provinces, and unions) attempt to appropriate resources in good times without considering the effects of their actions on other claimants—is another channel through which political economy factors can affect fiscal procyclicality (Tornell and Lane 1999). As the intensity of such fiscal competition increases in good times, the rise in government spending could be greater than the windfall gains in revenues, resulting in procyclical fiscal expansion. The more claimants there are (that is, the more dispersed the power), the higher government spending may tend to be in good times.

Quality of institutions. The quality of institutions plays an important role in the ability of countries to conduct countercyclical fiscal policy.⁹ Indeed, institutional factors, such as law and order, have been found to play a larger role than financial variables, such as financial openness and domestic credit to the private sector, in explaining differences in fiscal cyclicality between advanced and developing economies (Calderón and Schmidt-Hebbel 2008). Government stability and law and order are especially important factors in reducing fiscal procyclicality. They can help do so by shrinking government discretion and extending the horizon of policy decision-making.

To analyze the linkages between fiscal cyclicality and institutional quality, five country-specific indicators of institutional quality from the PRS Group database are used: political risk, quality of bureaucracy, control of corruption, government stability, and law and order (table A4.3.2). The association between procyclicality and the presence of fiscal rules is also examined here because these rules are a significant part of the fiscal institutions in many commodity-exporting countries (box 4.2).


The results indicate that higher political risk is associated with more procyclical fiscal policies. The correlation between the cyclical component of real GDP and real government spending in countries that rank higher on political risk is 0.49, compared with a correlation of 0.28 for countries that rank lower on political risk; the difference between the average correlations for the two country groups is statistically significant (figure 4.4.A). Part of the explanation may be that governments in countries with higher political risk may be more focused on short-term outcomes to stay in power.



FIGURE 4.4 Fiscal procyclicality, fiscal rules, and institutional factors






C. Procyclicality and corruption control




E. Procyclicality and law and order





Likewise, commodity-exporting countries with lower-quality bureaucracy have often implemented more procyclical fiscal policies than those with higher-quality bureaucracies, although the difference between the two country groups is not statistically significant (figure 4.4.B). Better bureaucracy may be expected to allow for better, rules-based, policy management and to limit unproductive discretionary spending.

Commodity exporters with better control of corruption have demonstrated lower fiscal procyclicality than those with weaker corruption control, and the difference between the procyclicality measures for the two country groups is statistically significant (figure 4.4.C). Weaker control of corruption makes it easier to capture rents. Likewise, countries with more government stability have tended to demonstrate less fiscal procyclicality than those with less government stability-although the difference in cyclicality measures is not statistically significant (figure 4.4.D). A more stable government allows for the formulation of fiscal policy with a longer horizon, weakening the incentive for procyclical policy. Better law and order has been associated with less procyclical fiscal policy (figure 4.4.E). The difference between the procyclicality measures for countries ranked lower in the law-and-order index and countries ranked higher is statistically significant.

Many commodity exporters have enacted fiscal rules, often in conjunction with stabilization funds-which essentially put aside revenue in good times that can be tapped in bad times. Fiscal rules may signal the intent of the government to dampen, if not eliminate, fiscal procyclicality as well as to safeguard long-term fiscal sustainability. Over the past four decades, the presence of fiscal rules has been associated with lower procyclicality across the full sample of countries, although results are less clear for commodity exporters (figure 4.4.F). Increased use of fiscal rules has not shielded EMDEs or commodity exporters from fiscal procyclicality, as evidenced by the continued procyclicality of fiscal policies in these countries after they adopted such rules. Nevertheless, there is evidence that some features of a second generation of fiscal rules-such as the use of

BOX 4.1 How does procyclical fiscal policy affect output growth?

Fiscal responses to commodity price shocks have differed considerably between emerging market and developing economies (EMDEs) and advanced economies. Commodity-exporting EMDEs have tended to react in a procyclical manner, increasing government expenditures when prices of exported commodities rise. Advanced-economy commodity exporters, by contrast, have tended to react countercyclically, reducing spending when prices rise. Fiscal policy procyclicality in the average EMDE commodity exporter has increased the effects of a commodity price shock on the business cycle by more than one-fifth.

Introduction

Procyclical fiscal policy amplifies the effect on output of a shock to economic activity—that is, "when it rains, it pours," using the analogy of Kaminsky, Reinhart, and Végh (2004). Such shocks could originate from various sources—from the financial sector or from supply or demand shocks associated with external or domestic developments. Kaminsky, Reinhart, and Végh (2004) focused on net capital inflows, finding that such flows were associated with an increase in government expenditure in emerging market and developing economies (EMDEs), while net capital outflows were associated with a decline in government expenditure. A variety of other drivers could lead to procyclical fiscal behavior.

This box examines how increases in commodity prices have affected the behavior of fiscal policy and, in turn, output growth. The total impact of the changes in commodity prices on output can be decomposed into two components. First, the "rains" component: in response to an increase in commodity prices, production rises in the commodity sector and other related sectors, and the associated increases in income generate further increases in private spending and output. The increases in output and spending, in turn, boost fiscal revenue, reducing the primary fiscal deficit. The second component depends on the response of fiscal policy. If the reduction in the fiscal deficit is conserved, fiscal policy will play a countercyclical role, dampening the increase in demand and activity. But if the reduction in the fiscal deficit leads the government to increase spending or lower taxes, fiscal policy will increase the effect of the shock on output. There will then be a "pours" component, with procyclical fiscal policy amplifying the business cycle.

This box addresses the following questions:

 How does fiscal policy in commodity-exporting countries react to changes in prices of commodity exports? • How does the impact of this fiscal reaction on output growth differ between commodity-exporting-EMDEs and advanced economies?

Methodology

To estimate the effect of fiscal policy on output, the analysis proceeds in four steps. First, to quantify the effects of changes in commodity prices on output, panel regressions are used to obtain the response of real GDP to changes in country-specific commodity price indexes.^a The results show that a 10 percent increase in commodity export prices increases output by 0.63-0.85 percent in EMDE commodity exporters and 0.18-0.26 percent in advanced-economy commodity exporters (table A4.1.3).^b

Second, panel regressions are used to estimate a fiscal policy reaction function (that is, the response of government spending to changes in commodity prices). Results show that EMDEs increase government spending when commodity export prices rise, indicating a procyclical fiscal policy (table A4.1.4). Specifically, a 10 percent increase in commodity export prices leads to an increase in government spending of about 0.6 percent to 0.8 percent. In contrast, advanced economies respond countercyclically: a 10 percent increase in commodity export prices leads to an increase field of the percent increase in commodity. 

commodity exporters using a panel structural vector autoregression (SVAR) model. °

Finally, the "amplification" effect (the "pours" component) of fiscal policy on output is obtained by combining the fiscal response in the second step with the fiscal multiplier obtained from the third step. The pours component represents changes in output growth that are due solely to changes in government expenditure in response to the initial shock. The "pours component" is then formally measured by:

Pours = $\Delta CEP * Fiscal reaction elasticity * fiscal$ $multiplier * <math>\frac{g}{y}$ (B4.1.1) where *CEP* is the commodity export price, *fiscal* reaction elasticity is the estimated coefficient in the fiscal regression and $\frac{g}{y}$ is the ratio of government spending to GDP (computed as the average over the sample period for each country). Intuitively, changes in commodity export price (*CEP*) trigger a fiscal reaction (elasticity), which in turn affect GDP via the fiscal multiplier. The fiscal reaction is adjusted by the size of the government to measure the final impact in percentage points of GDP.^d

c. BOX 4.1 How does procyclical fiscal policy affect output growth? (continued)

Impact of procyclical fiscal policy on output

The results indicate that, if an increase in the price of the exported commodity boosts output by 1.0 percentage point (the "rains" effect), procyclical fiscal policy in commodity-exporting EMDEs increases GDP by another 0.21 percentage point (the "pours" effect), boosting the total change in GDP to 1.21 percent (figure B4.1.A). In contrast, fiscal policy in commodityexporting advanced economies compensates for the cyclical effect by reacting in the opposite direction, reducing GDP by 0.65 percentage point. This leaves the net increase in GDP of 0.35 percentage point for advanced economies. These estimates suggest that, when faced with a commodity price shock of the same magnitude, the overall change in GDP can be more than three times bigger in EMDEs than in advanced economies solely because of the fiscal policy reaction.

The above approach is applied to the commodity price boom of 2003-08 to illustrate the role of fiscal policy. During this period, commodity export prices increased about 76 percent for the EMDEs and 66 percent for the advanced economies in the sample. The analysis estimates the direct effect of the commodity price shock on output (the "rain" component) by applying the 2003-08 cumulative price shock to the estimated parameters. The results indicate that the total effect on output to be 5.4 percent for EMDEs and 4.6 percent for advanced economies—that is, a difference of 0.8 percentage point (figure B4.1.1.B). The procyclical response of fiscal policy in EMDEs ("pours" component) in another 1.1 percentage points to growth, bringing EMDE growth to 6.5 percent over this period.

In contrast, fiscal policy in advanced economies reacted in a countercyclical fashion, subtracting about 3 percentage points from growth, bringing advancedeconomy growth to 1.6 percent. In other words, of the 4.9 percentage points difference between total EMDE and advanced-economy growth in the sample, 4.1 percentage points (or 84 percent) can be explained by the responses of fiscal policy—procyclical in EMDEs and countercyclical in advanced economies. Alternative estimates also indicate that fiscal expenditure in EMDEs reacts in a procyclical manner while that in advanced economies reacts in a countercyclical one (figure B4.1.1.C).

Conclusion

Fiscal procyclicality amplifies the effect of commodity price shocks on the business cycle in EMDEs. In the sample period examined, fiscal policy in the average EMDE commodity exporter is estimated to have increased the effect of a commodity price shock on output by more than one-fifth. The results indicate that in EMDE commodity exporters fiscal policy has tended to amplify the business cycle, whereas in advancedeconomy commodity exporters fiscal policy has tended to dampen it.

cyclically adjusted targets and well-defined escape clauses, combined with strong legal and enforcement arrangements—have been associated with reduced procyclicality (Bova, Carcenac, and Guerguil 2014). The country cases examined in box 4.2 suggest that fiscal rules or SWFs are most effective in achieving their stated objectives when they are well-designed, closely linked to broader policy objectives, and supported by strong institutions and political commitment.

Armed with the insights from the correlates of fiscal procyclicality established above, the analysis uses cross-country regressions to identify the main drivers of fiscal procyclicality in commodity exporters.¹⁰ The dependent variable here is the correlation between the annual percentage changes of real government spending and real GDP. The explanatory variables are intended to capture the four explanations for the existence of procyclical fiscal policy described in the previous section: capital account openness (measured by an index of

¹⁰ For an empirical analysis of the drivers of fiscal procyclicality in OECD countries, see Lane (2003). For an analysis of the role of financial and institutional variables, see Calderón and Schmidt-Hebbel (2008) and Calderón, Duncan, and Schmidt-Hebbel (2010). Ilzetzki (2011) provides a novel political economy explanation based on successive governments disagreeing on the desired distribution of public spending and examines different theories of procyclicality by running numerical simulations in calibrated models.

financial openness); political economy factors (measured by an index of political constraints, which reflects the extent to which policy changes are inhibited by institutional and political factors); macroeconomic stability (measured by the standard deviation of output); and institutional quality (measured by an index of control of corruption).

The coefficients of each of these four variables are statistically significant and three of the four have the expected sign (annex 4.1; table A4.1.1). More open capital accounts and better control of corruption are estimated to have helped reduce fiscal procyclicality while greater output volatility was associated with higher procyclicality. However, the coefficient of the political constraints index does not have the expected sign, suggesting either that the "voracity effect" did not hold or that the political constraints index fails to capture it. The variables are jointly significant when combined and explain about 18 percent of procyclical behavior across countries.¹¹

Cross-country regressions are also used to analyze the role of institutional variables in driving fiscal cyclicality, as highlighted by the correlations reported in the previous section. The roles of SWFs and fiscal rules are also explored. SWFs can play an important role in reducing procyclicality by promoting the accumulation of government savings during commodity price booms, to be drawn down to some extent during price slumps (Asik 2017). The results show that greater government stability, better law and order, and the presence of SWFs and fiscal rules have all tended to reduce fiscal procyclicality (table A4.1.2). Overall, the analysis therefore provides empirical evidence that better institutions are associated with lower fiscal procyclicality. These results are also corroborated by the country case studies (box 4.2) which show that SWFs and fiscal rules are

most effective in meeting their goals when supported by strong institutions.

Fiscal policy volatility

Conceptual definitions

Country-specific measures of fiscal policy volatility are constructed based on the variance of exogenous changes in fiscal policy stance. These are simply derived from fiscal policy reaction functions, following the approach in Fatás and Mihov (2013) (annex 4.2 provides details). The analysis is based on four alternative measures of fiscal policy: primary expenditures (which exclude net interest payments), revenues, government consumption, and the primary budget balance (which excludes net interest). The first three variables are expressed in real (inflation-adjusted) terms and measured as log differences. The primary budget balance is expressed as the annual change of its ratio to GDP. Annual data are used for the 1990-2021 period for 184 countries, including 148 EMDEs and 36 advanced economies. The choice of the sample period is based on data availability. Of these 184 countries, 94 are commodity exporters and the remainder as commodity importers. Among commodity exporters, only five are advanced economies. Among commodity importers, 31 are advanced economies and 59 are EMDEs.

Basic features of fiscal policy volatility

The following stylized facts emerge from a comparison of the measures of fiscal policy volatility between different country groups.

First, over the past three decades, *the volatilities of primary expenditures, government consumption, and revenues were all significantly higher in EMDEs than in advanced economies* (figure 4.5.A). The difference between the average volatility for these two groups of countries is statistically significant. Notably, the difference in the volatility of government consumption is larger than that of primary expenditures, highlighting the role of government consumption in fiscal policy volatility in EMDEs. The estimated volatility of the primary balance (as a percentage of GDP) is

¹¹ In line with Lane (2003), and to check the robustness of our results, GDP per capita, size of the public sector relative to GDP, and openness (the sum of exports and imports as a share of GDP) were added as controls, one at a time. relatively smaller and closer between the two country groups than with the other fiscal policy indicators.¹²

Second, EMDE commodity exporters exhibited more volatility in fiscal policy than commodity importers (figure 4.5.B). The difference in the average volatility for commodity exporters and commodity importers is statistically significant. Government revenues demonstrated greater volatility than the other indicators, although only by a slight margin.


Third, fiscal policy volatility declined somewhat in EMDEs over the past three decades. Volatility of government expenditure, consumption, revenue, and primary balance were all lower on average during 2007-20 than in 1980-2006 (figure 4.5.C). This reduction in fiscal policy volatility in EMDEs mirrors the increasing use of fiscal rules in these countries (Arroyo Marioli, Fatás, and Vasishtha 2023). In advanced economies, however, over the same period, revenue volatility declined while volatility of expenditures and primary balance increased (figure 4.5.D).


Fourth, government expenditures, consumption, and revenue tend to be more volatile in LICs than in other EMDEs. Over the past three decades, government expenditure, consumption and revenue were roughly twice as volatile in LICs as in other EMDEs (figure 4.5.E). The degree of fiscal volatility has also varied across emerging market regions. On average, expenditure volatility in LICs, particularly FCS economies, over the past three decades was higher than that in lower- and upper-middle income countries. Fiscal volatility was the highest among commodity exporters in Sub-Saharan Africa (SSA), the Middle East and North Africa (MNA), and East Asia and Pacific (EAP) than in other emerging market regions (figure 4.5.F).

FIGURE 4.5 Fiscal policy volatility

Over the past three decades, primary expenditure, government consumption, and revenues in EMDEs have been more volatile than those in advanced economies, on average. Within EMDEs, fiscal policy in commodity exporters has been more volatile than that in commodity importers and in LICs compared with non-LICs, on average. Fiscal policy volatility declined somewhat in EMDEs over the past three decades while the evolution of fiscal volatility in advanced economies has varied across different fiscal indicators. Expenditure volatility over the past three decades has been highest among commodity exporters in Sub-Saharan Africa, the Middle East and North Africa, and East Asia and Pacific.


A. Fiscal volatility: Advanced economies versus EMDEs






B. Fiscal volatility: EMDE commodity


C. Evolution of fiscal volatility in EMDEs




D. Evolution of fiscal volatility in advanced economies

Determinants of fiscal volatility

Cross-sectional regressions are used to investigate the role of country-specific factors-such as institutions, policy variables, the extent and nature of commodity dependence, and GDP per capitain driving fiscal policy volatility. Like the analysis of procyclicality, the exercise focuses on the spending side of the budget. While each of the four fiscal policy indicators used above contains information about fiscal policy, the variation in primary expenditures provides a more accurate perspective on the volatility of fiscal policy. Since the automatic stabilizer component of expenditures tends to be small, changes in primary expenditures tend to be driven by discretionary measures and changes in nondiscretionary spending that are unrelated to the business cycle. It is these changes in primary expenditure net of cyclical components (such as unemployment benefits) that are captured in the volatility measure used in the analysis.

The findings indicate that commodity dependence can be a source of fiscal policy volatility by itself. Being both an EMDE and a commodity exporter explains up to 22 percent of the variation in fiscal policy volatility across countries (table A4.2.1).¹³ That commodity exporters exhibit higher fiscal policy volatility even after their EMDE status is taken into account suggests that reliance on commodities in itself contributes to fiscal policy volatility.

EMDEs and commodity exporters are heterogenous groups of countries that display substantial variation in their level of development as well as degree of commodity dependence. To account for these differences across countries, two additional variables are introduced into the analysis. First, GDP per capita is included to represent the level of development in each country. Second, a variable measuring resource rents—specifically, income from natural resources as a percentage of GDP—is introduced to capture the degree of commodity dependence. Resource rents are highly correlated with resource revenues as a share of GDP (Arroyo Marioli, Fatás, and Vasishtha 2023).

The results indicate that the lower GDP per capita in EMDEs does not by itself explain the differences in fiscal policy volatility across countries because the presence of larger commodity sectors contributes to greater volatility in fiscal policy. Overall, these findings suggest that both the level of development and the degree of commodity dependence contribute to explaining fiscal volatility.

Energy exporters display higher fiscal policy volatility than exporters of metals and agricultural commodities. Controlling for resource rents, however, the results indicate that commodity dependence is a more important determinant of fiscal volatility than the type of commodity exported (table A4.2.2).

A stable institutional environment and the use of sound fiscal rules can reduce fiscal policy volatility. The role of institutional factors in driving fiscal policy volatility is analyzed by including two additional variables often used in the literature: political constraints and control of corruption. These two variables are found to be significant and together help explain up to 40 percent of crosscountry variation in fiscal policy volatility. Policy frameworks can also play an important role in driving fiscal policy volatility. The roles of three specific policy variables are examined: the capital account openness, exchange rate regime (floating versus fixed), and the presence of fiscal rules.

The presence of a more open capital account, more flexible exchange rates, and fiscal rules are all associated with lower fiscal policy volatility. Taken together, these explanatory variables can explain up to 71 percent of the cross-country variation in fiscal policy volatility. The estimates suggest that moving from a fixed exchange rate regime to a flexible one can lower expenditure volatility by 3 percentage points (table A4.2.1). Although a flexible exchange rate regime is not feasible or appropriate for all EMDEs, countries with those regimes may have more room for the exchange



rate adjustment needed to counteract the destabilizing effects of commodity prices on output. A more flexible exchange rate regime, in principle, facilitates a smoother cyclical adjustment to a terms-of-trade shock. For example, during the 2014-16 fall in commodity prices (mainly crude oil and natural gas), commodityexporting countries such as Chile and Peru (two countries with flexible exchange rate regimes) were able to increase spending through countercyclical fiscal policy as they were equipped with sufficient fiscal space and the necessary medium-term fiscal frameworks to safeguard fiscal sustainability (Al-Sadiq, Bejar, and Otker 2021).¹⁴ In contrast, countries with pegged regimes experienced a larger deterioration in their fiscal balance, on average, relative to those with flexible exchange rate regimes. Pegged exchange rates remain the dominant exchange rate regime among EMDEs (figure 4.6.A). While greater exchange rate flexibility can help build resilience to commodity price shocks, its macroeconomic implications need to be taken into account, particularly in cases where prices of a few key exports are globally determined, and exchange rate fluctuations may have adverse impacts on the balance sheets of public and private institutions.

The results also suggest that if the average degree of capital account openness in EMDEs were to be same as in the average advanced economy, expenditure volatility in EMDEs would be reduced by 1.7 percentage points. In principle, economies with greater access to international capital markets should be better able to smooth the impact of commodity price fluctuations on output volatility, although markets may respond in a procyclical manner for some countries (with capital flows increasing during commodity price booms and declining during slumps) (IMF 2012a). Capital account openness in commodity exporters has increased over the past few decades, but it remains lower than in commodity importers (figure 4.6.B). Measures to increase capital

account openness always have to be considered with caution, in combination with consideration of the prudential and other measures that may be needed to avoid instability in the domestic financial system.

In addition, establishing a fiscal rule can reduce expenditure volatility in EMDEs by 0.7 percentage point (from 10.8 to 10.1 percent). The significance of these three variables—that is exchange rate regime, capital account openness, and fiscal rules—in driving fiscal policy volatility remains even after accounting for the level of development and the extent of commodity dependence. Although the presence of an SWF is also associated with lower fiscal volatility, the result is not statistically significant.¹⁵

Implications of fiscal policy volatility for growth


Fiscal policy volatility reduces output growth by exacerbating macroeconomic volatility. Expenditure volatility is found to have significantly hurt






D. Correlation between fiscal volatility

per capita output growth (annex 4.2 and table A4.2.3), which supports earlier research showing a negative association between macroeconomic

volatility and economic growth (Kose, Prasad, and Terrones 2005; Ramey and Ramey 1995). The estimated impact of fiscal volatility on per capita growth is in line with other recent estimates (for example, Fatás and Mihov 2013).


FIGURE 4.8 Fiscal volatility, growth, and fiscal frameworks

Applying the above estimates in a counterfactual scenario, if the average commodity-exporting EMDE were to adopt the policies of an average advanced economy in three areas—capital account openness, exchange rate flexibility, and use of fiscal rules—fiscal volatility would be reduced by roughly 3.1 percentage points—from 12.3 percent to 9.2 percent. That would result in an increase in the average per capita GDP growth rate for commodity-exporting EMDEs from about 1.4 to 1.7 percent per year. In other words, by adopting these policies the average commodity-exporting EMDE could have added about 1 percentage point in per capita growth every four to five years (figure 4.8.A). Over the 30-year sample period of the analysis, an overall 7.6 percentage points would have been added to average growth in GDP per capita in EMDEs.

Links between procyclicality and volatility

Fiscal procyclicality and volatility are intimately related concepts and often driven by similar factors, as highlighted by the preceding analysis. Intuitively, a more procyclical fiscal policy would be expected to result in a more volatile fiscal policy to the extent that it amplifies the business cycle, thus exacerbating the effect of the initial source of volatility.¹⁶ The measures of volatility and procyclicality are positively correlated, a finding in line with some previous studies (figure 4.7.A; IMF 2004). However, when EMDEs and advanced economies are considered separately, the correlation is significant only for EMDEs. The correlation is significant for both commodity exporters and commodity importers. This suggests that fiscal procyclicality is associated with more fiscal policy volatility only in EMDEs (which also tend to be procyclical). In advanced economies, because fiscal policy is countercyclical or acyclical on average, the volatility of fiscal policy is likely from other factors. The correlation between fiscal procyclicality and volatility has declined for advanced economies from the 1980-2006 period

to the post-2007 period, while it has remained unchanged for EMDEs and commodity exporters (figure 4.7.B). High- and upper-middle-income countries present the highest correlation among country-income groups (figure 4.7.C). Finally, the Europe and Central Asia (ECA) and Middle East and North Africa (MNA) regions show higher correlation than other EMDE regions (figure 4.7.D).

Fiscal institutions and frameworks

The results of the empirical analysis highlight the role of political pressures in driving fiscal policy procyclicality and volatility in commodityexporting EMDEs. This section discusses how well-designed and credible institutional mechanisms—fiscal rules, sovereign wealth funds, and medium-term expenditure frameworks—can help foster fiscal discipline and counteract tendencies toward procyclicality. It also highlights the role of strong governance more generally in facilitating countercyclical fiscal policies in these economies.

Fiscal rules

Fiscal rules can help reduce the volatility of fiscal policy and deliver better fiscal outcomes. Fiscal rules leave less space for discretionary spending, which tends to be procyclical and to exacerbate the business cycle (thereby adding more fiscal volatility). Fiscal rules can also provide a strong signal of prudence in fiscal policy (Debrun and Kumar 2008). Well-designed fiscal rules have been found to help lower fiscal deficits and reduce both fiscal procyclicality and volatility.¹⁷


Until the early 1990s only a handful of EMDEs had fiscal rules and virtually no LICs did. Since then, a growing number of EMDEs have adopted

A. EMDE annual per capita growth


B. Fiscal rules and SWFs

such rules—including commodity exporters, such as Chile and Indonesia (Davoodi et al. 2022; box 4.2). By the end of 2020, 43 of 96 commodityexporting EMDEs had at least one fiscal rule in place (figure 4.8.B). The adoption of fiscal rules has been most prevalent in energy and agricultural

exporters followed by metal exporters (figure 4.8.C). The use of fiscal rules has been associated with more fiscal discipline.¹⁸ However, only well-designed fiscal rules promote more fiscal discipline (Caselli and Reynaud 2020). Additionally, although while fiscal rules are associated with improved fiscal policy management, their success crucially depends on effective institutions and governance underpinned by the rule of law and strong accountability mechanisms (Ardanaz, Cavallo, and Izquierdo 2023; Bergman and Hutchison 2015).

The adoption of fiscal rules is associated with less procyclicality in fiscal policy. At the same time, fiscal rules can act as a constraint on the ability of incumbent politicians to generate political business cycles using fiscal and monetary expansions. Fiscal frameworks that do not have formal rules but focus on transparent and credible strategies backed by proper fiscal institutions could also provide a viable approach to support fiscal discipline (World Bank 2023b).

Sovereign wealth funds

Over the past few decades, the number of SWFs established has increased rapidly, particularly by commodity-exporting countries. Many commodity exporters have established SWFs as a stabilization fund to channel windfall gains during commodity price booms to accumulate as savings that can be withdrawn during commodity price slumps to limit the impact on fiscal balances. Among the major emerging market regions, the MNA region ranks the highest in terms of total assets under management of SWFs—more than twice that in advanced-economy commodity exporters (figure 4.8.D).

In practice, the effectiveness of such stabilization funds in moderating fluctuations in government spending, and hence output, has varied across countries (Gill et al. 2014). Although poor fiscal governance has hampered the successful implementation of sovereign stabilization funds in many EMDEs, the overall experience has been positive for smoothing the path of government spending (Sugawara 2014). There is evidence that SWFs can be effective in reducing fiscal procyclicality in some countries (Coutinho et al. 2022). In oilexporting countries, stabilization funds have been associated with reduced macroeconomic variability and lower inflation (Shabsigh and Ilahi 2007).

An appropriate institutional framework and strong long-term political commitment, including transparent governance of the stabilization fund and prudent constraints on the discretion of fund managers, are critical for the effectiveness of these funds (Asik 2017; Bagattini 2011; Ossowski et al. 2008). Strong institutions help to shield these funds from political influences (Koh 2017; Mohaddes and Raissi 2017). In this context, sovereign wealth and stabilization funds work well to reduce government expenditure volatility in countries where fiscal rules are implemented (Sugawara 2014), but their effectiveness is hampered where there are inadequate controls and integration with the budget is limited (Le Borgne and Medas 2007). More broadly, cross-country evidence shows a strong causal link running from better institutions to less procyclical or more countercyclical fiscal policy in EMDEs (Frankel, Végh, and Vuletin 2013). These results are also corroborated by the country case studies presented in box 4.2, which suggest that the efficacy of SWFs is positively correlated with the presence of strong institutions.

Medium-term expenditure frameworks

Medium-term expenditure frameworks (MTEFs) are intended to establish or enhance credibility in the budgetary process and to set out spending plans consistent with prevailing economic conditions and medium-term policy objectives (Raudla, Douglas, and MacCarthaigh 2022). Such frameworks can enhance clarity on the purposes of expenditures and help ensure a transparent budgetary process, where government agencies allocate public resources based on strategic priorities. MTEFs foster greater fiscal transparency and accountability by providing a

clear basis for monitoring government performance against approved plans, making it easier to hold governments accountable for their fiscal policies.

The number of countries with MTEFs has increased notably over the past three decades. Initially adopted by a few advanced economies in the early 1980s to address public overspending, MTEFs became widely accepted as integral components of fiscal governance throughout the 1990s and 2000s. Among EMDEs, MTEFs were introduced to strengthen public finance management and to realign expenditures consistent with long-term development needs (World Bank 1998). The adoption of MTEFs accelerated in the aftermath of financial crises, with the objective of reconciling short-term pressures with longer-term priorities (Raudla, Douglas, and MacCarthaigh 2022).¹⁹

Evidence suggests that credible MTEFs can significantly improve fiscal discipline (Vlaicu et al. 2014; World Bank 2013). Robust implementation of these frameworks is closely related to linkages with broader economic and social policy objectives, to the reliability of the relevant data, and to the forecasting capability of the authorities (Allen et al. 2017). The success of these frameworks crucially depends on strong government ownership and support (Schiavo-Campo 2009). For example, South Africa, a commodity exporter, introduced an MTEF when government debt was high, the central government was underspending, and provincial governments were overspending. With widespread support at the top levels of government, the underspending and overspending were both reduced following the introduction of the MTEF (World Bank 2013).

MTEFs need clearly defined legal frameworks and strong supporting institutions to be effective. They can also complement other fiscal frameworks to achieve desired fiscal policy objectives. For example, combined with fiscal rules, MTEFs can improve fiscal balances and the quality of budget forecasts. More advanced MTEFs can also be associated with lower spending volatility and higher spending efficiency. Nevertheless, MTEFs may fail to meet their objectives where institutions are weak and where key government functions are hindered by capacity constraints in critical technical and administrative areas. For instance, the improvements in fiscal discipline following the adoption of MTEFs tend to be transient in nature, especially in the case of frameworks lacking comprehensive metrics for monitoring and evaluating fiscal performance. In addition, lack of fiscal transparency can impair budget credibility and increase uncertainty about fiscal policy and outturns in EMDEs.²⁰

Institutional quality and governance

Resource abundance can be advantageous to a country if the government has a sound long-term plan for extracting the resources and a robust mechanism for using resource revenues to meet economic and social needs to achieve sustained economic growth. However, resource wealth can undermine institutions and longer-term growth by promoting rent-seeking, corruption, and the squandering of resources through unproductive spending, poor-quality investment, and the depletion of government savings. For mineral rich countries, there is also evidence that mineral wealth can provoke or fuel internal conflicts (Collier and Hoeffler 2004). In general, resourcerich countries with stronger economic and political institutions tend to have better macroeconomic and growth outcomes (Arezki and Bruckner 2010; Arezki, Hamilton, and Kazimov 2011; van der Ploeg 2011).

Higher quality political institutions help limit procyclicality of fiscal expenditures (Ossowski et al. 2008; Sugawara 2014). The observed decline in fiscal procyclicality in EMDEs over the past decade and a half has been mainly attributed to the improved quality of institutions, as measured by indicators on law and order, bureaucracy

quality, and corruption (Frankel, Végh, and Vuletin 2013). In LICs, the quality of budget institutions—measured through the quality of the various stages on the budget process and the number of checks and balances in place—tends to be positively associated with the ability of these countries to conduct countercyclical policies (Dabla-Norris et al. 2010).

The case studies of Norway, Chile, and Botswana show that the quality of their institutions—which is higher than that of their peers—helped limit the negative impact of commodity price volatility (box 4.2; Bova, Medas, and Poghosyan 2016). These country cases also demonstrate that fiscal rules or SWFs work best when they are well-designed, closely linked to broader policy objectives, and supported by strong institutions and political commitment. In the absence of strong institutions and political commitment, fiscal rules and SWFs tend not to be followed closely, which reduces their effectiveness.

Conclusions

Many EMDEs are commodity-dependent—in terms of fiscal and export revenues as well as economic activity. The challenges posed by this commodity dependence have again been apparent in recent years because of gyrations in commodity prices, resulting partly from geopolitical tensions. These challenges are likely to be exacerbated in coming years as commodity prices become more volatile during the transition from fossil fuels to more climate-friendly sources of energy. If not adequately managed, the response of fiscal policy to this increased commodity price volatility is likely to impede growth.

This chapter has focused on two features of fiscal policy in commodity-exporting EMDEs, procyclicality and volatility. Fiscal policy tends to be both more procyclical and more volatile in EMDEs than in advanced economies, and more so in commodity exporters than in commodity importers. Fiscal procyclicality and volatility amplify the effect of commodity price shocks on the business cycle in EMDEs, with detrimental effects on economic growth.

The chapter offers insights for policy makers in commodity-exporting EMDEs about the appropriate design of fiscal policies and institutional frameworks. Both institutional and policy factors play important roles in explaining the cross-country variation in fiscal policy volatility. Greater government stability, a stronger rule of law, easier access to international financial markets, greater exchange rate flexibility, and the presence of fiscal rules and SWFs have all been associated with lower fiscal policy volatility and procyclicality.

The broader macroeconomic effects of commodity price fluctuations also depend on the policy mix, particularly the interaction of fiscal policy with the monetary and exchange rate policies (IMF 2012b; World Bank 2022). Additionally, the role that commodity revenues play in the budgets of commodity-exporting EMDEs and their impact on fiscal policy volatility suggests potential benefits from diversification of their economies, away from production of commodities.²¹

Commodity price movements often induce more procyclical and volatile fiscal policy, which leads to boom-bust cycles and hinders growth in commodity-exporting emerging market and developing economies (EMDEs). In recent decades, many commodity exporters have adopted fiscal rules and established sovereign wealth funds (SWFs) to partly address these challenges. The adoption of these institutional arrangements, as well as their effectiveness in reducing fiscal procyclicality and fiscal volatility, has not been uniform across countries. Overall, fiscal rules and SWFs are found to have been most effective in addressing procyclicality and volatility when well-designed and supported by strong institutions. Chile and Norway, in particular, have managed their commodity exposure relatively successfully owing to their rigorous fiscal frameworks and strong institutions, offering lessons for other resource-dependent countries.

Introduction

Commodity dependence presents substantial challenges for many emerging market and developing economies (EMDEs). Commodity price volatility generally results in unpredictable swings in commodity-related export and fiscal revenues, particularly in countries where commodities account for a large share of fiscal revenue, which leads to volatile and procyclical public expenditure-that is, expenditure that reinforces rather than moderates a business cycle. To manage the impact of commodity price volatility on fiscal policy, commodity-exporting countries have adopted a variety of policy frameworks, such as fiscal rules and sovereign wealth funds (SWFs). Over the past two decades, several countries have also set up publicly funded independent fiscal institutions, such as "fiscal councils," to monitor fiscal policy. The independent fiscal monitoring institutions are supposed to act as watchdogs by highlighting fiscal risks. However, these policy frameworks and institutions are far from homogenous and often take different forms in different countries.

This box assesses the effectiveness of fiscal rules and SWFs in managing commodity price shocks in selected commodity-exporting countries. It addresses the following questions:

- How do fiscal rules and SWFs differ among commodity-exporting countries?
- How have fiscal rules and SWFs helped in reducing fiscal procyclicality and volatility?

Sovereign wealth funds and fiscal rules

Sovereign wealth funds

SWFs are special purpose investment funds or arrangements that are owned by the government and


are designed to expand national wealth and stabilize business cycles. SWFs hold, manage, or administer assets to achieve financial objectives and employ a set of investment strategies. The objectives of SWFs depend on country-specific circumstances, which may evolve over time. SWFs include:^a

- *Stabilization funds.* These funds are established to insulate the economy from commodity price volatility—for example, the Economic and Social Stabilization Fund in Chile. Revenue flows into the funds when government receipts are above a benchmark and money can be withdrawn from the fund when government revenue is below the benchmark level.
- Savings funds. The primary objective of a savings fund is to build wealth for future generations and ensure intergenerational equity in countries that rely on nonrenewable natural resources, such as oil. Examples include the Petroleum Fund in Timor-Leste and the Pula Fund in Botswana. These funds are characterized by fixed inflows of government revenue and discretionary outflows—reflecting a higher tolerance for short-term volatility and a focus on longer-term returns. Savings funds are established when a government can put aside funds for the future and be reasonably confident that the assets in the fund will not need to be liquidated in the short- and medium-run (Al-Hassan et al. 2018).
- *Financing funds.* A financing fund combines the characteristics of a stabilization fund and a savings fund, such as the SWF of Norway. It is fully integrated into the government budget process.

Typically, inflows to the fund come from the resource revenues of the government and the returns on the fund's investments. The outflows are transfers to cover any nonresource budget deficit. As a result, the fund receives positive net transfers if, and only if, the government runs a budget surplus when resource revenues are included. This is not necessarily the case for stabilization and savings funds (for example, that of New Zealand) because these funds are not linked to government budget deficits or surpluses (Al-Hassan et al. 2018). A key feature of the financing fund model is the fiscal policy guideline (or rule) which specifies the desired trajectory of the nonresource budget deficit that is to be financed by transfers from the fund.

Fiscal rules

Since the 1990s, rules-based fiscal frameworks have become increasingly prevalent across the world. Although fiscal rules were designed to be rigid to constrain government actions and promote compliance, these rules have been evolving, especially in response to economic crises (Budina et al. 2013). There are four main types of fiscal rules, based on the budgetary aggregate they aim to constrain (Davoodi et al. 2022):

- *Budget balance rules.* The objective of a budget balance rule is to constrain the size of the deficit and thereby control the evolution of the debt ratio (for example, Indonesia, Mexico, and Nigeria). Because such rules do not set numerical limits on budgetary aggregates, they are typically considered procedural rather than numerical fiscal rules. If followed properly, they can help prevent debt sustainability issues. However, in some cases, budget balance rules can also induce procyclicality by forcing expenditures to follow revenues, which are usually procyclical.
- Revenue rules. These rules set ceilings and floors on revenues and are aimed at boosting revenue collection and/or preventing an excessive tax burden. Most of these rules are not linked directly to the control of public debt because they do not constrain spending. Furthermore, setting ceilings/ floors on revenues can be challenging because

revenues often have a large cyclical component fluctuating in line with the business cycle. Revenue rules alone could result in procyclical fiscal policy because floors generally do not account for automatic stabilizers (such as unemployment benefits) in a downturn and ceilings don't account for them in an upturn. Revenue rules can, however, directly target the size of the government.

- Expenditure rules. Expenditure rules set limits on total, primary, or current government expenditures to limit the procyclicality of fiscal policy (for example, Botswana, Chad, and Ecuador). Such limits are typically set either in absolute terms, or growth rates, and occasionally, as a percentage of GDP. The time horizon often ranges between three and five years. Expenditure rules can constrain spending during booms, when windfall revenue receipts are temporarily high and deficit limits are easy to comply with. Such rules, however, are not directly linked to the objective of debt sustainability because they do not constrain the revenue side. Moreover, expenditure rules do not allow much scope for discretionary fiscal stimulus during bad economic times.
- Debt rules. These rules focus on long-term sustainability by setting an explicit anchor or ceiling for public debt (often as a percentage of GDP). A debt rule is relatively easy to communicate and, by definition, most effectively ensures convergence to a debt target. However, debt rules do not provide clear short-term guidance for policy makers because it takes time for budgetary measures to affect debt levels.^b Moreover, fiscal policy may become procyclical if the economy is hit by shocks and the debt target, defined as a percentage of GDP, is binding. Conversely, when debt is well below its ceiling, such a rule does not provide binding guidance (Budina et al. 2013).

As of 2021, budget balance and debt rules were the most prevalent type of rules in commodity-exporting countries. Budget balance rules accounted for about 41

percent of fiscal rules followed by debt rules which were about 33 percent of total fiscal rules (figure B4.2.1.A). Expenditure rules (15 percent) and revenue rules (11 percent) accounted for the rest.

Country case studies

This box analyzes the use of SWFs and fiscal rules in seven diverse commodity-exporting countries: Argentina, Australia, Botswana, Chile, Indonesia, Norway, and Timor-Leste. The analysis aims to include a diverse set of commodity exporters both in terms of the types of commodity exports (agriculture, energy, and minerals) as well as the concentration of commodity exports (that is, single-commodity exporters as well as countries with a more diverse export portfolio). To draw useful insights for resource-rich countries considering adopting fiscal rules and SWFs to mitigate fiscal procyclicality and volatility, the box analyzes countries with well-functioning fiscal rules and SWFs, countries with mixed experiences, and countries without fiscal rules and SWFs. Finally, the sample includes both advanced economies and EMDEs in different geographical regions.

Australia, Chile, and Norway


These countries have designed their SWFs to help manage the fiscal effects of fluctuations in commodity export prices and revenues. Australia and Norway have designed their funds for long-term purposes, while Chile has designed its fund for short-term purposes. These countries have also established fiscal rules and a strong institutional framework that allows them to reduce or avoid fiscal procyclicality (Arezki et al. 2012; Bauer 2014; Frankel 2011). The combination of good institutions, SWFs, and fiscal rules has enabled these countries to manage their commodity-based revenues and create sustainable frameworks. Australia combines well-developed fiscal frameworks with broad principles (for example, on debt sustainability) with more flexible numerical rules or guidelines. Chile and Norway also rely on more flexible guidelines and rules supported by strong institutions and transparency on fiscal plans, and are often regarded as countries with the most successful fiscal frameworks and institutions to manage natural resource wealth (Lam et al. 2023).

Australia. Australia's commodity exports comprise iron ore, coal, gold, liquified natural gas, and animal meat.

The country's fiscal framework is based on the Charter of Budget Honesty Act 1998 (Commonwealth of Australia 2014), which provides for "constrained discretion," that advocates a principles-based approach rather than a numerically oriented, rules-based approach. It adds transparency and discipline to the budget formation and execution process (Bhattacharyya and Williamson 2011; Chohan 2017). The Charter defines the principles of sound fiscal management as several components, including comprising an expectation that fiscal policy contributes to adequate national saving and to moderating cyclical fluctuations in economic activity, as appropriate (Chohan 2017). The country's SWF, the Future Fund, was established in 2006 and accumulates revenue from budget surpluses for long-term purposes, such as pensions (figure B4.2.1.B).^c The minister of finance may make certain discretionary transfers from time to time.

Norway. Commodity exports of Norway are concentrated in crude oil and petroleum gas. The country has a SWF comprising two separate investment funds.

- The Government Pension Fund-Global (GPFG), formerly the Petroleum Fund, was established in 1990 to collect revenue from oil-related income sources to support government saving and to promote an intergenerational transfer of resources (Velculescu 2008). In this way, the government's revenue from petroleum production does not enter the government budget directly. Norway's GFPG is the largest natural-resource-based SWF in the world with its latest annual holdings at more than US\$1.2 trillion, equivalent to 256 percent of GDP at the end of 2022 (figure B4.2.1.C).
- The Government Pension Fund Norway (GPFN) saves surpluses of the national insurance scheme and held assets of US\$32.7 billion, or 6 percent of 2022 GDP (Lam et al. 2023).

Political will to turn nonrenewable resources into wealth for future generations paved the road for Norway's fund. The GPFG is fully integrated with the

state budget and builds on existing institutions to strengthen the budget process. It finances the non-oil budget without constraints from any inflow or outflow rules between the fund and the budget. Norway has consistently sustained budget surpluses over the past two decades (except for 2020), with net inflows to the GPFG accumulating over time. The central government in Norway has the so-called "bird-in-hand rule" or "spending rule" (established in 2001), which stipulates that the non-oil structural deficit, and thus withdrawals from the fund over time, should correspond to the estimated annual real return of the fund, which has been 3 percent since 2017.

Norway's spending rule implies that the non-oil budget, and hence the economy, are isolated from both the large variations in oil revenues that result from oil price fluctuations as well as the volatility in the value of the fund due to variations in stock prices. This, in turn, helps to dampen the cyclical swings in the economy. The linking of the structural, and not the actual, nonoil fiscal deficit to the expected real return on the assets of the wealth fund allows automatic stabilizers to work. Norway (unlike its Nordic peers) does not have a publicly funded independent body to monitor fiscal or other economic policy. Instead, it established a Model and Method Commission in 2011, which advises the Ministry of Finance.

Chile. Chile is the world's biggest copper exporter—the metal accounts for about half of the country's total exports. Chile's fiscal policy management has been anchored on the successful implementation of SWFs, fiscal rules, and the recent creation of a fiscal council. Chile's SWFs comprise two types of funds.

The Economic and Social Stabilization Fund (ESSF) was established with the Fiscal Responsibility Law of 2006. The ESSF has been designed for short-term purposes, with the main objective of stabilizing fiscal spending and insulating the budget from economic downturns and volatile copper prices, thus reducing the need to issue debt. Provisions for contributions to and withdrawal from the ESSF are well established in the law and closely tied to the fiscal rules. The ESSF has followed its mandate successfully and helped Chile finance countercyclical fiscal policy when needed. During the pandemic, the government utilized the stabilization fund to provide fiscal support.

• The Pension Reserve Fund (PRF) aims to accumulate resources on a longer-term horizon. The PRF was created to support the state guarantee of pension and disability benefits. The funds' governance and assets management strategy match international best practices (Lam et al. 2023).

Chile's fiscal rule, in place since 2001, limits the growth of budgeted central government spending to an estimate of structural revenue growth. The rule's operation is supported by two expert panels that estimate long-term copper prices and the output gap. According to the rule, the authorities can run a deficit larger than the target if: (1) in a recession, output falls short of its long-run trend, or (2) the price of copper is below its mediumterm (10-year) equilibrium (Frankel 2011). The ESSF is closely linked to the structural budget balance rule and has followed international best practices to have a flexible inflow and outflow mechanism, a feature similar to the arrangement in Norway (Lam et al. 2023). In addition to the fiscal rule, in January 2018 Chile created the Autonomous Fiscal Council to replace the Advisory Fiscal Council established in 2013. The new fiscal council also continues to have legal independence, its own resources, and has a broader mandate.

The presence of credible fiscal rules; the strong governance structures that provide the space for their implementation; and the recent creation of competent, independent, and adequately resourced fiscal councils have enabled Chile to develop some of the best fiscal management institutions among commodity-exporting EMDEs (IADB 2008). For example, in the aftermath of the 2009 global recession, Chile was able to conduct a countercyclical fiscal policy and maintain a low risk of debt distress. Government expenditures grew from about 23 percent of GDP in 2012-14 to about 25 percent of GDP in 2015-17 (figure B4.2.2.A). This helped mitigate output volatility, with GDP growth declining by 2 percentage points between 2012-14 and 2015-17, compared with an average decline of 2.6 percent among other metal exporters (Richaud et al. 2019). Chile's fiscal sustainability was maintained on account of its fiscal rule, which allowed the country to save a substantial proportion of commodity revenues into its SWF during the commodity supercycle (World

Indonesia's use of fiscal rules has enabled it to follow a prudent fiscal balance path despite increases in its export prices. Argentina's fiscal balance has been deteriorating since the mid-2000s despite generally increasing export prices. Australia, Chile, and Norway have followed prudent fiscal paths, with a relatively low correlation between government spending and commodity export prices. Establishing sovereign wealth funds and fiscal rules supported by strong institutional frameworks have allowed these countries to reduce or avoid fiscal procyclicality.

Bank 2017). Part of these savings were drawn down to boost the economy in the wake of the global financial crisis. More recently, the SWF was crucial in financing a big fiscal stimulus package during the COVID-19 pandemic.

Botswana and Timor-Leste

Botswana. Diamond mining is the dominant economic sector in Botswana. The government established a sovereign wealth fund-the Pula Fund-in 1994 to serve both as a savings fund and as a short-term stabilization fund. The main objective of the fund is to put aside part of the income from diamond exports to benefit future generations. Another objective is to provide a stabilization mechanism for the government budget and foreign reserves during an economic downturn or slump in mineral prices. For example, the Pula Fund helped stabilize revenue and output during the 2007-09 global financial crisis. During 2008-10, the fiscal deficit in Botswana averaged about 9.4 percent of GDP, as mining revenues declined, and expenditures surged because of an increase in infrastructure spending to offset the adverse effects of the global economic

downturn and to boost long-term productivity (figure B4.2.2.B). The government financed this deficit by drawing upon savings from the Pula Fund and issuing new debt (World Bank 2016).

To prevent excessive spending and bolster fiscal sustainability, the government has established a set of fiscal rules, which have been mostly set in terms of nonbinding political commitments. Botswana has four main rules, which target public spending, the fiscal balance, and debt:

 An indicative expenditure rule, the Sustainable Budgeting Index (SBI) was established in 1994 to ensure that mineral revenue is directed toward investments and savings, rather than consumption (Apeti, Basdevant, and Salins 2023; Kojo 2010). The SBI computes the ratio of recurrent spending (excluding development spending) over nondiamond revenue, with the objective of keeping the ratio below 1. Adhering to this rule sets aside diamond revenue to finance the accumulation of financial assets and development spending.

- There is an indicative target on the composition of spending, which specifies that development spending should be at least 30 percent of total spending.
- An indicative target of a nonnegative fiscal balance was established in 2003.
- Foreign and domestic debt are each prohibited from exceeding 20 percent of GDP.

Surplus fiscal savings are deposited into the Pula Fund, which invests in long-term instruments overseas, and dividends from these investments are paid to the Treasury.

However, Botswana's fiscal framework has limitations. The sustainable budgeting principle does not directly incorporate a sustainability concept, and the Pula Fund has been reducing its overall size with withdrawals that are far larger than its inflow (Basdevant 2008; Jefferis 2016). The Pula Fund is not governed by clearly defined withdrawal or deposit rules, with deposits determined by the size of the budget surplus and withdrawals determined by the size of deficits (Markowitz 2020). On balance, however, Botswana has run a fairly prudent fiscal policy, avoiding many pitfalls experienced by other commodity-dependent countries. The strength and stability of Botswana's institutions have been key in achieving this success (Kojo 2010; Richaud et al. 2019).

Timor-Leste. Offshore oil and gas reserves are the main sources of Timor-Leste's resource revenues. The Petroleum Fund (PF) was established in 2005 to collect oil revenues and is managed by the central bank. The PF primarily invests in offshore assets, such as U.S. Treasury bonds. The PF's only expenditures are transfers to the budget, payment of operational management fees, and refunds of overpaid taxes. The government has adopted two fiscal rules to guide the use of oil revenue although these rules are not binding.

• The Estimated Sustainable Income (ESI), established in 2005, is a mechanism for integrating the Petroleum Fund and the budget. The ESI is calculated as 3 percent of total wealth plus the present value of projected future oil receipts. That combined amount is what the government is authorized to spend each year. The value of future oil receipts is determined using the U.S. Energy Information Administration's forecasts for West Texas Intermediate crude oil. Transfers exceeding the ESI are allowed only if the government provides a justification that is approved by Parliament. The requirement is designed to constrain the government's ability to spend government resources without considering longterm fiscal sustainability (Apeti, Basdevant, and Salins 2023).

• The second rule is a political commitment to maintain a ceiling on the cost of external debt at 3 percent per year. It requires the government to benchmark the costs of external borrowing against the average rate of investment returns of the PF.

Channeling all oil revenues into the PF and requiring that the ESI rule is consistent with the sustainable use of funds should, in principle, mitigate the impact of oil price cycles on fiscal expenditure. However, the escape clauses have hindered the effectiveness of Timor-Leste's fiscal frameworks. Until 2008, government spending of oil revenue was conservative and transfers to the budget to finance the non-oil budget deficit were lower than the ESI. As a result, the net assets of the Petroleum Fund grew rapidly from US\$371 million in 2005 to US\$4.2 billion in 2008, the equivalent of 647 percent of non-oil GDP.

However, beginning in 2009, the country started to withdraw funds from the PF in excess of the ESI to finance large infrastructure projects (IMF 2012b). This led to a significant slowdown in accumulation of assets, but the PF still reached a level of about US\$19 billion in 2020. Since the global financial crisis, expenditures have followed oil prices closely (figure B4.2.2.C). Additionally, systematic excess withdrawals have been authorized in recent years, even prior to the pandemic. Given the low expected remaining lifetime of the country's oil fields, the PF is at serious risk of being depleted within the next decade (World Bank 2021).

In sum, escape clauses and weak institutions have diminished the effectiveness of fiscal rules in both Botswana and Timor-Leste, even when the rules were well-designed for long-run sustainability.

Argentina and Indonesia

Indonesia. The main commodity exports of Indonesia are crude oil, gas, coal, palm oil, and rubber. Indonesia established a fiscal rule in 2003, which stipulates a fiscal deficit ceiling of 3 percent of GDP and a debt ceiling of 60 percent of GDP. At that time, the government's deficit was 1.7 percent of GDP, debt was at 57 percent of GDP, and the economy was well on its path to recovery after the Asian financial crisis. The aim of the fiscal rule was to solidify these gains and to promote future fiscal discipline by enacting these fiscal responsibility criteria into law (Blöndal, Hawkesworth, and Choi 2009). The rules have been respected and only temporarily lifted during the pandemic within legally pre-established norms.

Although Indonesia's fiscal rule has provided a solid nominal anchor and has safeguarded debt sustainability, fiscal spending has not been disconnected from the commodity price cycle (figure B4.2.3.A; Ismal 2011). For example, over 1993-2008, fiscal policy in Indonesia was not countercyclical (IMF 2009). The factors underlying limited fiscal responses to output fluctuations originated from structural weaknesses in public finance management and a lack of budget flexibility. This weakness included a high dependence on revenue from natural resources, narrow and volatile tax bases, low discretionary spending, and problems with budget execution.

Additionally, like many EMDEs, Indonesia relies on external financing which tends to be procyclical. Liquidity constraints, particularly during downturns, weaken the government's ability to run an expansionary fiscal policy to offset the effects of an economic slowdown. For example, during the 2007-09 global financial crisis, Indonesia's external borrowing spreads increased sharply, by nearly 1,200 basis points, much higher than its regional peers—Malaysia, the Philippines, and Thailand (IMF 2009). Another factor contributing to fiscal procyclicality is the high subsidy component of the budget, particularly energy subsidies, which leaves little room to respond to the economic cycle. However, the subsidies bill has been declining since 2015 owing to a series of reforms.

Argentina. The country's commodity export basket is based on agricultural goods. Unlike the other countries

analyzed here, Argentina has neither a sovereign wealth fund nor a set of fiscal rules. Fiscal policy in Argentina has been highly procyclical, with expenditures growing closely in line with commodity export prices during the commodity price cycle of the 2000s (Kaminsky 2010; Tenreyro 2012). The lack of strong institutions and fiscal rules contributed to a deterioration in fiscal outcomes once the commodity price boom ended (figure B4.2.3.B). As a result, the country has faced persistent fiscal challenges in the past decade (IMF 2020).

Conclusions

This box analyzes the experiences of selected commodity-exporting countries, all but one of which adopted fiscal rules and SWFs, in managing commodity price shocks. Insights from these case studies lead to the following conclusions.

First, *SWFs and fiscal rules differ among countries in objectives and design.* SWFs can have a long-term purpose (such as the accumulation of pension funds) or a short-term one (such as dampening the impact of temporary economic shocks). Some rules are designed to make an SWF sustainable, others to make them accessible when needed (Bauer 2014; Richaud et al. 2019). This aspect plays an important role in procyclicality because the criteria governing accessibility will determine the extent to which a government can access funds (and spend them). The sustainability conditions might also impose a limit on the amount that can be used even in times of need.

Second, when supported by well-designed fiscal rules and institutions, SWFs can help reduce procyclicality. International experience suggests that a strong political commitment to fiscal discipline, as well as strong institutions of good governance, are needed for SWFs to work well. Countries with good corruption control and law and order have been able to construct effective SWFs that reduce procyclicality by serving as a buffer against revenue volatility or as a source of financing during downturns (figures B4.2.3.C). In the cases of Norway (oil) and Chile (copper), commodity revenues are channeled directly into the SWFs, severing links from resource revenue to government spending. These funds are then available for specific purposes under certain conditions, avoiding or limiting fiscal

procyclicality. In other cases, despite the presence of welldesigned rules, the existence of escape clauses and weak institutions can render SWFs less useful (Perry 2007). These observations are in line with the findings of the analysis in this chapter, which shows that weak institutions limit the ability of governments to follow countercyclical fiscal policy despite having fiscal tools at their disposal.

Finally, commodity-exporters without SWFs or robust fiscal rules are more prone not only to procyclical fiscal behavior but

ANNEX 4.1 Determinants of fiscal procyclicality

Cross-country regressions for commodity exporters are used to identify the main drivers of fiscal procyclicality. The dependent variable is the correlation between the cyclical components of real government spending and real GDP. The explanatory variables capture each of the four explanations for the existence of procyclical fiscal policy: the financial openness index; the political constraints index; the standard deviation of GDP; and control of corruption. Each of these four variables is significant and three of the four coefficients have the expected sign (table A4.1.1). More financial openness and better control of corruption reduce procyclicality while greater output volatility increases procyclicality. However, the effect of the political constraints index is counterintuitive, suggesting that either the "voracity effect" does not hold or that the political constraint index is not an appropriate proxy for the detrimental effects of more fiscal claimants on available resources. When all these variables are included together, they are jointly significant.

Robustness checks. In line with Lane (2003), GDP per capita, size of the public sector relative to GDP, and openness (sum of exports and imports as a percentage of GDP) are used as controls in the regression one at a time. GDP per *also to debt sustainability issues.* In both Indonesia and Argentina, the two countries without an SWF in the sample, fiscal policies have been procyclical.^d While Indonesia has benefited from a set of rules aimed at debt sustainability, the absence of rules in Argentina has allowed more discretionary spending policies that have contributed to successive crises.

capita is significant at the 5 percent level but the two other control variables are not significant. In all three cases, the *F*-test for the joint significance of the four relevant explanatory variables is significantly different from zero at least at the 10 percent level.

The cross-country regressions are also used to analyze the role of institutional variables in driving fiscal procyclicality, as highlighted by the correlations reported in figure 4.4. The role of sovereign wealth funds (SWFs) and fiscal rules is also explored. To capture SWFs, a dummy variable is included that takes the value of 1 if a country has a SWF, and 0 otherwise. SWFs can play an important role in reducing procyclicality because these funds are designed to save during commodity price booms and dis-save during price slumps (Asik 2017). Results show that higher government stability, better law and order, and the presence of SWFs and fiscal rules all tend to reduce fiscal procyclicality (table A4.1.2). Overall, the analysis provides evidence that better institutions are associated with lower fiscal procyclicality.

Although fiscal rules may reduce procyclicality, the existence of fiscal procyclicality may prompt policy makers to adopt fiscal rules. To account for this potential endogeneity, instrumental variable estimation (two-stage least squares) is used with bureaucracy quality (from the PRS database) as an instrument.

ANNEX 4.2 Linkages between fiscal policy volatility and economic growth

Estimating fiscal policy volatility

The framework used to estimate fiscal policy volatility is based on the approach in Fatás and Mihov (2013), which involves estimating a fiscal policy reaction function of the following form:

Fiscal Policy_t = $\alpha + \beta$ Economic Activity_t + γ Controls_t + ϵ_t (4.2.1)

where "*Fiscal Policy*" is a variable that captures the stance of fiscal policy. Four alternative measures of fiscal policy are used: primary expenditures, revenues, primary budget balance, and government consumption. Primary expenditures, revenues, and government consumption are all expressed in real terms and measured as log differences. The primary budget balance is expressed as the annual change of its ratio to GDP. "*Economic Activity*" denotes the cyclical stance of the economy and is represented by annual GDP growth. The alternatives—the output gap and the unemployment rate—are more difficult to construct or measure accurately for diverse economies.²² β summarizes the cyclical behavior of fiscal policy and indicates whether fiscal policy is countercyclical or procyclical. It is composed of both automatic stabilizers and the discretionary response of governments to economic fluctuations.²³ The residual, ϵ , captures changes in fiscal policy that are unrelated to the business cycle or any of the control variables. These decisions can be the result of political decisions (such as changes in tax rates or spending associated with the political cycle) or errors in policy (such as mismeasurement of the output gap). The uncertainty associated with the residual can be seen as generating excessive volatility in GDP and, possibly, reduced longterm growth. Following Fatás and Mihov (2013), the volatility of fiscal policy is measured as the standard deviation of the residual in the fiscal policy reaction function (σ_{i}^{ϵ}) .

Implications of fiscal policy volatility for growth

The impact of fiscal policy volatility on per capita GDP growth is analyzed by estimating variants of a standard growth regression (Barro 1991). The benchmark specification is given by:

²³ The specification has potential endogeneity issues since fiscal policy could affect economic activity contemporaneously. While the literature has acknowledged these issues, it has made use of OLS in many instances because of the lack of an obvious instrument (for example, Aghion, Hemous and Kharroubi 2014; Alesina, Campante and Tabellini 2008; and Lane 2003). Studies that have explored a set of instruments to test the robustness of the results presented in these earlier papers find similar results (for example, Fatás and Mihov 2013). Given this, and for the sake of simplicity, the analysis in this chapter makes use of OLS.

$$\Delta y_i = \alpha' + \rho' \log(\sigma_i^{\varepsilon}) + \gamma' Z_i + u_i \qquad (4.2.2)$$

where $\overline{\Delta y_i}$ is the average per capita GDP growth for country i; σ_i^{ε} is the measure of fiscal policy volatility—the key regressor; Z_i is a vector of variables that have been found to have significant explanatory power for the cross-country variation in growth. Fiscal policy volatility is measured using primary expenditures. Equation (4.2.2) is estimated using both OLS as well as instrumental variables to address endogeneity concerns. Instruments used are political constraints and control of corruption from the PRS Group database, *International Country Risk Guide*. The controls included in the regression are taken from the specification of Fatás and Mihov (2013), which are based on the growth regressions of Sala-i-Martin, Doppelhofer and Miller (2004).²⁴ The controls included are government size, initial GDP per capita, capital account openness, and the price of investment.

²⁴ For robustness, different specifications were estimated with a variety of controls, including the existence of a sovereign wealth fund. The results are not significant. Note that this variable is already included as an instrument for fiscal policy volatility.

Latin America and the Caribbean: Argentina, Belize, Bolivia, Brazil, Chile, Colombia, Costa Rica, the Dominican Republic, Ecuador, El Salvador, Guatemala, Honduras, Jamaica, Mexico, Nicaragua, Panama, Paraguay, Peru, and Uruguay.

Middle East and North Africa: Bahrain, the Arab Republic of Egypt, the Islamic Republic of Iran, Jordan, Morocco, Oman, Qatar, Saudi Arabia, Tunisia, the United Arab Emirates, and West Bank and Gaza.

South Asia: India, Maldives, Pakistan, and Sri Lanka.

Sub-Saharan Africa: Angola, Botswana, Ghana, Kenya, Lesotho, Mozambique, Namibia, Nigeria, Rwanda, the Seychelles, South Africa, Uganda, and Zambia.

Data and Forecast Conventions

The macroeconomic forecasts presented in this report are prepared by staff of the Prospects Group of the Equitable Growth, Finance and Institutions Vice-Presidency, in coordination with staff from the Macroeconomics, Trade, and Investment Global Practice and from regional and country offices, and with input from regional Chief Economist offices. They are the result of an iterative process that incorporates data, macroeconometric models, and judgment.

Data. Data used to prepare country forecasts come from a variety of sources. National Income Accounts (NIA), Balance of Payments (BOP), and fiscal data are from Haver Analytics; the World Development Indicators by the World Bank; the World Economic Outlook, Balance of Payments Statistics, and International Financial Statistics by the International Monetary Fund. Population data and forecasts are from the United Nations World Population Prospects. Country- and lendinggroup classifications are from the World Bank. The Prospects Group's internal databases include high-frequency indicators such as industrial production, consumer price indexes, emerging markets bond index (EMBI), exchange rates, exports, imports, policy rates, and stock market indexes, based on data from Bloomberg, Haver Analytics, IMF Balance of Payments Statistics, IMF International Financial Statistics, and J.P. Morgan.

Aggregations. Aggregate growth for the world and all subgroups of countries (such as regions and income groups) is calculated using GDP weights at average 2010-19 prices and market exchange rates of country-specific growth rates. Income groups are defined as in the World Bank's classification of country groups.

Forecast process. The process starts with initial assumptions about advanced-economy growth and commodity price forecasts. These are used as conditioning assumptions for the first set of growth forecasts for EMDEs, which are produced using macroeconometric models, accounting frameworks to ensure national account identities and global consistency, estimates of spillovers from major economies, and high-frequency indicators. These forecasts are then evaluated to ensure consistency of treatment across similar EMDEs. This is followed by extensive discussions with World Bank country teams, who conduct continuous macroeconomic monitoring and dialogue with country authorities and finalize growth forecasts for EMDEs. The Prospects Group prepares advanced-economy and commodity price forecasts. Throughout the forecasting process, staff use macroeconometric models that allow the combination of judgement and consistency with modelbased insights.

In support of this commitment, we leverage electronic publishing options and print-on-demand technology, which is located in regional hubs worldwide. Together, these initiatives enable print runs to be lowered and shipping distances decreased, resulting in reduced paper consumption, chemical use, greenhouse gas emissions, and waste.

We follow the recommended standards for paper use set by the Green Press Initiative. The majority of our books are printed on Forest Stewardship Council (FSC)-certified paper, with nearly all containing 50-100 percent recycled content. The recycled fiber in our book paper is either unbleached or bleached using totally chlorine-free (TCF), processed chlorine-free (PCF), or enhanced elemental chlorine-free (EECF) processes.

 ${old J}$ lobal growth is expected to slow further this year, reflecting the lagged and ongoing effects of tight monetary policy to rein in inflation, restrictive credit conditions, and anemic global trade and investment. Downside risks include an escalation of the recent conflict in the Middle East, financial stress, persistent inflation, weaker-than-expected activity in China, trade fragmentation, and climate-related disasters. Against this backdrop, policy makers face enormous challenges. In emerging market and developing economies (EMDEs), commodity exporters face the enduring challenges posed by fiscal policy procyclicality and volatility, which highlight the need for robust fiscal frameworks. Across EMDEs, previous episodes of investment growth acceleration underscore the critical importance of macroeconomic and structural policies and an enabling institutional environment in bolstering investment and long-term growth. At the global level, cooperation needs to be strengthened to provide debt relief, facilitate trade integration, tackle climate change, and alleviate food insecurity.

Global Economic Prospects is a World Bank Group Flagship Report that examines global economic developments and prospects, with a special focus on emerging market and developing economies, on a semiannual basis (in January and June). Each edition includes analytical pieces on topical policy challenges faced by these economies.
